Dear Mr. Mikulka,

Reference is made to the letter of Ms. Patricia O'Brien, Under-Secretary-General for Legal Affairs, dated 10 December 2008, inviting the Secretariat of the Convention on Biological Diversity (CBD) to provide information on the implementation of the outcomes of the United Nations Informal Consultative Process on Oceans and the Law of the Sea ("the Consultative Process"), to the Secretary-General's report on oceans and the law of the sea, for the consideration of the United Nations General Assembly at its sixty-fourth session.

The Secretariat of the CBD has been represented at the 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup> and 8<sup>th</sup> meetings of the Consultative Process. The main contribution made by the Secretariat to the Consultative Process has been to promote harmonization and collaboration between the CBD process on marine and coastal biodiversity and the relevant UNGA-mandated processes, including through provision of updates on CBD decisions and implementation works, as well as scientific and technical information on issues such as the ecosystem approach, biodiversity in marine waters both within and beyond national jurisdiction, and marine genetic resources.

Details of the CBD decisions and major works relevant to the implementation of the outcomes of the Consultative Process are described in the attached table.
