Workshop to discuss implementation of paragraphs 80 and 83 to 87 of resolution 61/105 and paragraphs 117 and 119 to 127 of resolution 64/72 on sustainable fisheries, addressing the impacts of bottom fishing on vulnerable marine ecosystems and the long-term sustainability of deep sea fish stocks

Organization of work

15-16 September 2011

1. Pursuant to paragraph 128 of resolution 64/72, the General Assembly requested the Secretary-General to convene, within existing resources, within the time made available for the informal consultations on the sustainable fisheries resolution and without prejudice to future arrangements, a two-day workshop in 2011 in order to discuss implementation of paragraphs 80 and 83 to 87 of resolution 61/105 and paragraphs 117 and 119 to 127 of resolution 64/72. The General Assembly also requested the Secretary-General to invite States, the Food and Agriculture Organization of the United Nations (FAO) and other relevant specialized agencies, funds and programmes, subregional and regional fisheries management organizations and arrangements (RFMO/As), other fisheries bodies, other relevant intergovernmental bodies, and relevant non-governmental organizations and stakeholders, in accordance with United Nations practice, to attend the Workshop.

2. The Workshop will be held at United Nations Headquarters in New York on 15 and 16 September 2011, during the first round of informal consultations on the draft resolution on sustainable fisheries. It is proposed that the Workshop will comprise a series of segments involving panel presentations and a general discussion among participants. Individual presentations will be limited to 10 minutes to allow sufficient time for general discussion.

3. The Workshop will commence with scientific presentations on the impacts of bottom fisheries on vulnerable marine ecosystems and the long-term sustainability of deep sea fish stocks. Additional segments will be held on the actions taken by States and RFMO/As to implement relevant paragraphs of resolutions 61/105 and 64/72 addressing the impacts of bottom fisheries on vulnerable marine ecosystems and the long-term sustainability of deep sea fish stocks. A separate presentation will be made on the FAO Programme for Deep-sea High Seas Fisheries, including implementation of the International Guidelines for the Management of Deep-sea Fisheries on the High Seas.

4. The Workshop will be led by a moderator appointed by the informal consultations who will begin the Workshop with a description of the provisional Organization of work and the panellists for each segment. The moderator will also prepare a written summary based on the discussions and a summary segment at the end of the Workshop. Pursuant to paragraph 129 of General Assembly resolution 64/72, the discussions during the Workshop will be taken into account by the General Assembly in its further review of the actions taken by States and RFMO/As in response to paragraphs 80 and 83 to 87 of resolution 61/105 and paragraphs 117 and 119 to 127 of resolution 64/72.

(a) Conducting assessments called for in paragraph 83(a) of resolution 61/105 and ensuring vessels do not engage in bottom fishing until assessments have been carried out;

(b) Identifying vulnerable marine ecosystems and adopting conservation and management measures to prevent significant adverse impacts or closing areas to bottom fishing until conservation and management measures have been established, as called for in paragraph 83(c) of resolution 61/105 and paragraph 119(b) of resolution 64/72;

(c) Establishing and implementing protocols for encounters with vulnerable marine ecosystems, as called for in paragraph 83(d) of resolution 61/105 and paragraph 119(c) of resolution 64/72; and

(d) Adopting conservation and management measures to ensure the longterm sustainability of deep sea fish stocks and non-target species and the rebuilding of depleted stocks, and ensuring conservation and management measures are established consistent with the precautionary approach, as called for in paragraph 119(d) of resolution 64/72.
