LETTER DATED 12 AUGUST 1997 FROM THE CHAIRMAN OF THE SECURITY  
COUNCIL COMMITTEE ESTABLISHED BY RESOLUTION 661 (1990)  
CONCERNING THE SITUATION BETWEEN IRAQ AND KUWAIT ADDRESSED  
TO THE PRESIDENT OF THE SECURITY COUNCIL

Report of the Committee established by resolution 661 (1990) concerning the situation between Iraq and Kuwait pursuant to paragraph 6, subparagraph (f), of the guidelines to facilitate full international implementation of paragraphs 24, 25 and 27 of Security Council resolution 687 (1991)

1. The present report is submitted by the Security Council Committee established by resolution 661 (1990) concerning the situation between Iraq and Kuwait, in accordance with paragraph 6, subparagraph (f), of the guidelines to facilitate full international implementation of paragraphs 24, 25 and 27 of Security Council resolution 687 (1991) of 3 April 1991 approved by the Security Council in its resolution 700 (1991) of 17 June 1991 (S/22660, annex).

2. Under paragraph 6, subparagraph (f), of the guidelines, the Committee is required to report at 90-day intervals to the Security Council on the implementation of the arms and related sanctions against Iraq contained in the relevant resolutions of the Council. The present report is the twenty-fifth report submitted under the above-mentioned guidelines. The preceding reports were submitted on 13 September (S/23036) and 10 December 1991 (S/23279), 12 March (S/23708), 11 June (S/24083), 8 September (S/24545) and 4 December 1992 (S/24912), 19 March (S/25442), 7 June (S/25930), 7 September (S/26430) and 14 December 1993 (S/26874), 4 March (S/1994/274), 6 June (S/1994/695), 2 September (S/1994/1027) and 29 November 1994 (S/1994/1367), 1 March (S/1995/169), 30 May (S/1995/442), 25 August (S/1995/744) and 27 November 1995 (S/1995/992), 21 February (S/1996/127), 20 May (S/1996/361), 20 August (S/1996/676) and 18 November 1996 (S/1996/950) and 14 February (S/1997/141) and 16 May 1997 (S/1997/374).

3. By paragraph 12 of the guidelines, all States are requested to report to the Committee any information that may have come to their attention relating to possible violations of the arms and related sanctions against Iraq committed by other States or foreign nationals. During the period under review, no information as requested has been brought to the attention of the Committee.

4. In accordance with paragraphs 13 and 15 of the guidelines, all States and international organizations are required to consult the Committee on the question of whether certain items fall within the provisions of paragraph 24 of resolution 687 (1991), as well as in cases relating to dual-use or multiple-use items, that is, items meant for civilian use but with potential for diversion or conversion to military use. During the period covered by the report, no States or international organizations have consulted the Committee on these questions.

5. By paragraph 14 of the guidelines, international organizations are requested to take all appropriate steps to assist in ensuring full compliance with the arms and related sanctions against Iraq, including providing to the Committee any relevant information that may come to their attention. During the period under review, no information as requested by paragraph 14 of the guidelines has been received by the Committee.

6. The Committee will continue its efforts to fulfil the mandate entrusted to it. Since the last report of the Secretary-General, dated 4 December 1991 (S/22884/Add.2), no further communications have been received from Member States pursuant to paragraph 4 of Security Council resolution 700 (1991).
