On 9 December, a treaty ceremony will be organized in the event that States, responding to the call for universal participation, are in a position to deposit their instruments of ratification or accession to the United Nations Convention on the Law of the Sea and to the Agreement relating to the Implementation of Part XI of the Convention.

Similarly, it will also be possible for States that may wish to avail themselves of the occasion to deposit their charts showing the outer limits of the territorial sea, the exclusive economic zone, the continental shelf, and/or lists of geographical coordinates of points specifying the respective geodetic datum.
