PRELIMINARY TIMETABLE AND IMPLEMENTATION PLAN FOR THE SECOND CYCLE OF THE REGULAR PROCESS FOR GLOBAL REPORTING AND ASSESSMENT OF THE STATE OF THE MARINE ENVIRONMENT, INCLUDING SOCIOECONOMIC ASPECTS

After consultation with the secretariat for the Regular Process for Global Reporting and Assessment of the State of the Marine Environment, including Socioeconomic Aspects (the "Regular Process"), and further discussion within the Group of Experts of the Regular Process, the Group of Experts proposed the following draft timetable and implementation plan for the second cycle of the Regular Process for submission to the Ad Hoc Working Group of the Whole for its approval at its tenth meeting held in New York from 28 February to 1 March 2018. The Ad Hoc Working Group of the Whole considered and took note of the preliminary timetable and implementation plan.

In addition to the face-to-face meetings of the Group of Experts listed in this timetable, there will be regular meetings by teleconference (approximately once a month). These will be used, *inter alia*, to review progress in implementing this implementation plan.

The programme of work for the period 2017–2020 for the second cycle of the Regular Process, endorsed by the General Assembly, foresees that key activities will be identified so as to support and interact with ongoing ocean-related intergovernmental processes, as appropriate. Outputs will be specifically tailored to the requests and needs of the processes. There is no provision in this implementation programme for such activities. The Group of Experts is ready and willing to undertake such activities – possibly in the form of providing briefings on issues covered by the First Global Integrated Marine Assessment (World Ocean Assessment I) and the work in producing the second world ocean assessment – but needs to point out that such activities will almost certainly need to be undertaken by teleconference and video links, in the absence of resources to cover travel costs.
