# Need for Better Ocean Management Key Focus of World Oceans Day, 8 June

The United Nations will officially observe World Oceans Day for the first time on 8 June, with the theme “**Our Oceans, Our Responsibility**”. To commemorate the observance, the Empire State Building will be lit in an ocean of blue.

While World Oceans Day has been celebrated by many countries since the Earth Summit in Rio de Janeiro in 1992, the United Nations General Assembly decided last year to make the day an officially recognized UN observance. The official designation of World Oceans Day by the United Nations is an opportunity to raise global awareness of the current challenges faced by the international community in connection with the oceans.

The oceans cover about two-thirds of the surface of the Earth and affect all. They generate most of the oxygen we breathe, absorb carbon dioxide emissions, provide food and nutrients, regulate climate, and are important economically for countries that rely on tourism, fishing and other marine resources for income. Unfortunately the vitality of the world’s oceans is under threat due to human activity and climate change.

United Nations **Secretary-General Ban Ki-moon**, in a message for World Oceans Day, said “human activities are taking a terrible toll on the world’s oceans and seas. Vulnerable marine ecosystems, such as corals and important fisheries, are being damaged by over-exploitation, illegal, unreported and unregulated fishing, destructive fishing practices, invasive alien species and marine pollution, especially from land-based sources.”

Mr. Ban also said that increased sea temperatures, sea-level rise and ocean acidification caused by climate change pose a further threat to marine life, coastal and island communities and national economies.

“The theme of World Oceans Day,” he added, “emphasizes our individual and collective duty to protect the marine environment and carefully manage its resources.”

The discussion will be moderated by Professor David Freestone, Lobingier Visiting Professor of Comparative Law and Jurisprudence, George Washington University Law School, and Visiting Professor, United Nations University.

This film screening on ocean acidification will be followed by a question-and-answer session. The screening is sponsored by the Division for Ocean Affairs and the Law of the Sea, Office of Legal Affairs, and the United Nations Staff Recreation Council Film Society.

### **Other Observances**

The Food and Agriculture Organization of the United Nations will be launching the International Guidelines for the Management of Deep-sea Fisheries in the High Seas in three languages, for use by States and regional fisheries management organizations.

Other specialized agencies, organizations, bodies, programmes and funds of the United Nations system will be holding various events and activities to raise awareness of oceans issues on World Oceans Day.
