DESCRIPTION OF REQUIREMENTS

The United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic (MINUSCA) hereby solicits Expression of Interest (EOI) from qualified companies and /or individuals for Commercial Sales of 24 TPT vehicles including one PALLET LOADING SYSTEM MODULE, RENAULT, M-11T, MEDIUM, CARGO CRANE PK6500) in Bangui, Central African Republic.

1) Registering as a Vendor with the United Nations
