The United Nations Truce Supervision Organization in Israel (UNTSO) is looking for qualified suppliers for the Provision of Catering Services.

For this purpose, UNTSO will undertake a competitive bidding exercise shortly. Accordingly, UNTSO would issue a Request For Proposal (RFP) to those companies who would express their interest and provide initial relevant information as to their ability to fulfill UNTSO's requirements. Please note that this is not an invitation for submission of a price proposal.

This request for EOI does not constitute a solicitation. UNTSO reserves the right in selecting the companies to participate in the bidding. Responding to this EOI does not guarantee that such company will be invited to tender. The UNTSO Procurement Section reserves the right to change or cancel this EOI notice at any time.

In order to qualify for the contract award, the prospective supplier must be registered with the United Nations Global Marketplace. The specific instruction and additional information on registration is indicated below.

### SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

The Contractor shall provide all personnel necessary to perform full food service operations required for the daily preparation and serving of food for up to 150 (one hundred fifty) UN personnel employed at the Government House (Jerusalem, Israel) and a small number of authorized visitors, or an average of 20 persons partaking of the food services; self-service and take out snack-bar type food services on working days during working hours for the benefit of the staff (Monday – Friday; 7:00am – 156:00 hrs); full dining food services with waiters for official functions (approximately twice per month for lunch or dinner) serving, on occasion, senior UN officials and/or members of the diplomatic community; Small day-time and evening functions with drinks, food (approximately twice per month); Large venue food catering usually held outdoors, (approximately three to four times per year).

1.2 In consideration of these requirements, UNTSO shall provide the necessary kitchen related equipment, including but not limited to the physical space necessary to facilitate any catering services, including:

- a. fixtures and fittings, which shall refer to lights, ventilation systems, sink units, work areas and storage cupboards;
- b. infrastructure, which refers to water supply, sewage systems, gas lines, electrical supply, electricity outlets and telecommunications facility;
- c. serving areas, dry and cool storage areas, kitchen areas with all the necessary facilities required for the preparation and cooking of food;
- d. maintenance of all fixtures and fittings used by the Contractor.

### 1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace ([www.ungm.org](http://www.ungm.org)) with the UN Secretariat in order to be eligible to participate in any solicitation. #### **Prerequisites for Eligibility**

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
  - I. the Compendium of United Nations Security Council Sanctions Lists (<https://www.un.org/sc/suborg/en/sanctions/un-sc-consolidated-list>), or
  - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary or affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, are not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15).
- F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.
