L'Office des Nations Unies à Genève (ONUG) souhaite recevoir des expressions d'intérêt pour un appel d'offres qu'il a l'intention de lancer pour les prestations de démantèlement, d'évacuation et de manutention de matériaux divers et d'installations du Palais des Nations à Genève.

Le descriptif des prestations à fournir se présentera principalement comme suit:

- Tous types de tuyauteries nues et isolées ainsi que les supports et colliers ;
- Des réseaux de gaines de ventilation et climatisation, nus ou isolés ainsi que les supports ;
- Des moteurs, pompes, circulateurs, servomoteurs ;
- Des monoblocs de ventilation et climatisation ainsi que leurs supports et fixations ;
- Des chaudières, citernes ;
- La manutention et l'introduction de divers équipements et matériels de tous poids et de tous volumes.

Les degrés de difficulté seront définis selon les critères suivants :

1) Travaux en accès facile

Tous travaux à réaliser dans un espace de travail libre, à une hauteur d'intervention de moins de deux mètres cinquante (2,50 mètres) avec échelle ou petit échafaudage, ne nécessitant pas l'utilisation de protections spécifiques ni d'outillage spécifique (appareils de levage, camion nacelle etc.).

2) Travaux en accès moyennement facile

Tous travaux à réaliser dans un espace de travail encombré, à une hauteur d'intervention de deux mètres cinquante (2,50 mètres) ou plus, nécessitant l'installation d'un échafaudage avec pose de protections

mécaniques ou contre la poussière ou les salissures et nécessitant l'utilisation de matériel spécifique. Travaux pouvant nécessiter l'installation d'un ventilateur d'extraction de fumées.

3) Travaux en accès difficile

Tous travaux en accès moyennement facile pour lesquels il sera nécessaire d'utiliser en plus les moyens de protection et de sécurité tels que cordages, harnais etc. Seront aussi considérés comme travaux en accès difficile tous les travaux à réaliser dans des courettes verticales, en façades de bâtiments pour lesquels les services d'un camion nacelle seront obligatoires. Travaux pouvant nécessiter l'installation d'un ventilateur d'extraction de fumées.

L'ensemble des travaux devra être réalisé suivant les normes et règles du pays hôte et du canton de Genève applicables.

SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

L'adjudicataire du présent marché devra fournir les prestations demandées pour la durée d'un contrat de cinq (5) ans, précisément pour une période initiale de trois (3) ans avec la possibilité de deux périodes supplémentaires et consécutives d'une année chacune (3+1+1).

Les expressions d'intérêt doivent impérativement être reçues avant 18h, heure de Genève, le 28 août 2018. Toutes les réponses seront traitées de manière strictement confidentielle.

Veuillez noter que cette demande d'expression d'intérêt (REOI) ne constitue pas une sollicitation. L'ONUG se réserve le droit de modifier ou d'annuler l'appel d'offres à tout moment. Seuls les fournisseurs considérés comme qualifiés par l'ONUG pour fournir les prestations de service requis seront invités à participer.

1) Registering as a Vendor with the United Nations

Prerequisites for Eligibility

In order to be eligible for UN registration, you must declare that:

 - II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organisation (including the World Bank);
- C. Your company (as well as any parent, subsidiary or affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
