The United Nations Interim Force in Lebanon (UNIFIL) has a mandate to support the implementation of the Security Council Resolution 1701. As part of the Mission's support programme, UNIFIL requires the following goods and/or services:

1. Supply of various steel products including Aluzinc trapezoidal sheets, industrial steel angles, bars, channels, tubes, sheets, and reinforcing / deformed steel bars. Deliveries shall be made on "as and when required basis" to UNIFIL HQ in Naqoura, Southern Lebanon, within 25 calendar days after receipt of Purchase Order.
2. In this respect UNIFIL seeks the services of qualified ISO 9001:2000 certified Manufacturer(s) Supplier(s), capable of undertaking such project and having the technical, financial and organizational capability.
3. The Long Term Agreement is intended for a duration of one year, with the option for a one year extension, and prices shall be fixed for the first year period and may be reviewed for the second year period.

The United Nations wishes to identify companies that have the capacity to provide such goods and/or services to UNIFIL with projected troop strength of approximately 15,000.

Expressions of interest shall include: (a) Company Profile; (b) List of previously completed and current contracts including volume and value of each contract; and (c) Company's latest Financial Statement and a Certified Audit thereof.

Interested companies shall submit such Expression of Interest and supporting documentations by hand or courier service to reach the above-mentioned address not later than close of business 10 Nov.
