The United Nations Interim Force in Lebanon (UNIFIL) has a mandate to support the implementation of the Security Council Resolution 1701. As part of the Mission's support programme, UNIFIL requires the following goods and/or services:

Electrical lights of various wattage and fixtures such as fluorescent tubes, ballasts, low energy lamps, high pressure sodium lamps, incandescent lamps, halogen lamps, transformers, floodlights, emergency lights, etc.

The United Nations wishes to identify companies that have the capacity to provide such goods and/or services to UNIFIL with projected troop strength of approximately 15,000.

Expressions of interest shall include: (a) Company Profile; (b) List of previously completed and current contracts including volume and value of each contract; and (c) Company's latest Financial Statement and a Certified Audit thereof.

- D. You currently do not employ, or anticipate employing, any person(s) who is or was recently employed by the UN (in accordance with ST/SGB/2006/15, post-employment restrictions (www.un.org/depts/ptd/pdf/conduct_english.pdf)).
- E. Your subsidiaries, agents, intermediaries and principals agree to cooperate with the United Nations Office of Internal Oversight Service during any investigative processes undertaken by them, either before during or after execution of a contract, including providing all required documents, company records, access to employees, officers and staff, as well as financial information.
