**Charles Okwalinga** was born and raised in rural Uganda and completed formal education to university degree. The epic of growing up in rural Eastern Uganda was the then vibrant cotton production and the role of cooperatives under which the sector was established.

Charles migrated and settled in UK, raising a family, as well as running a small family business that exemplified community engagement. This took a devotion of 15 years of working life in running the business in Hospitality, Catering and Food industry in African food. In this pursuit Charles was involved in various training in business development and was engaged in supporting ethnic communities in business development support.

Charles later undertook and completed comprehensive and practical training on *LEADING*CHANGE a taylored course for senior corporate executive officers delivered by Common

Purpose London, dealing with leading change, governance and organisational management, in

particular unique instruments of governance and management mixes balancing between capital

and social investment and outcomes.

Charles was inspired to return to Uganda to explore how he can support in governance, management, and transitional changes that would lead to better institutional organisation, governance and management, in particular I rural, community and small business set ups. Charles set up Teso Professionals Enterprise Development Organisation (Teso PEDO) Ltd, a social enterprise to this regard, working in the Teso region of Eastern Uganda with farmers, rural and peri urban communities to support in furthering professional development, enterprise development organisational development as well as benchmarks in line with Social Development Gals SDGs.

Working with farmer groups coincides with the national and international effort to establish and set up cooperatives that enhance the realisation of production units that we believe would be key to increase production productivity and enterprise aspects on community development that would ensure sustainable and impact development, enabling us to achieve the SDGs Uganda economy and community wellbeing was crucially hinged on existence and performance of cooperatives post-independence, and these collapsed, save a few remnant societies and Unions. The cooperatives then were set up and run by central government, and upon collapse the methodology is no longer applicable. The resurgence of cooperatives and as observed internationally, is therefore with bottom up approaches, the community coming together and guided t formation and the working of cooperatives

Charles and Teso PEDO now devote to registering farmers to groups that are subsequently set up and establish as cooperatives initially in Eastern Uganda but will expand to the rest of the

country. The cooperatives are set up by local area or by product or a combination. We aim to have set up 3,000 cooperatives in the region each holding on average 100 farmers.
