

Programme budget for the biennium 2002-2003

Implementation of projects financed from the Development Account

Sixth report of the Advisory Committee on Administrative and Budgetary Questions

- 1. The Advisory Committee on Administrative and Budgetary Questions has considered the report of the Secretary-General on the implementation of projects financed from the Development Account (A/57/360). During its consideration of the report, the Advisory Committee met with representatives of the Secretary-General, who provided additional information.
- 2. The report of the Secretary-General is submitted in accordance with General Assembly resolution 56/237, by which the Assembly decided to continue to keep the implementation of the Development Account under review and requested the Secretary-General to submit a report on the subject to the Assembly at its fifty-seventh session.
- 3. The Advisory Committee welcomes the streamlining of the presentation for the Development Account. The Committee recalls that, in its first report on the proposed programme budget for 2002-2003, it referred to the modalities for financing of the account and requested the Secretary-General to provide a thematic impact analysis of the projects and to expand the relevant tables to include the date of commencement, projected date of completion and the implementing agency for the project (see A/56/7, paras. XIII.1-XIII.5). The Committee notes that information regarding progress on all projects under tranches one and two, including an evaluation of their impact, as well as information on the commencement dates, implementing agencies and anticipated dates of completion, is now posted on the United Nations Development Account web site (www.un.org/esa/devaccount). Information provided to the Committee in this regard is contained in annexes I and II to the present report.
- 4. Paragraph 2 of the Secretary-General's report (A/57/360) indicates that, to date, 43 projects have been approved for implementation by the General Assembly at a total cost of \$39.2 million. Moreover, as indicated in paragraph 2 and tables I, II

and III of the report, 7 projects were financed under the first tranche of 1998-1999, of which 69.9 per cent of planned expenditures had been made as of 30 June 2002; 16 projects were financed under the second tranche of 2000-2001, of which 55.9 per cent of planned expenditures had been made as of the same date; and 20 projects are being financed under the third tranche for 2002-2003, of which 4.9 per cent of planned expenditures had been made as of 30 June 2002. The Committee notes that, as of 30 June 2002, an amount of \$17 million has been spent of the \$39.2 million approved.

- 5. The Committee notes the information in section III of the report of the Secretary-General on issues regarding the delivery of projects and in tables I, II and III, which contain data in terms of expenditure as of 30 June 2002. The problems encountered in launching, programming, formulating, identifying completion dates and reporting are summarized in paragraphs 14 to 21. As indicated in paragraph 14, the start-up of the first two tranches of the Development Account was slow in view of the need to establish procedures and protocols for its operations. A majority of the projects, therefore, only became operational in 2000. In addition, as indicated in paragraphs 18 and 19, none of the projects had been completed by the end of 2001 and their completion dates are now foreseen as much as one or two years later than originally indicated, complicating, for the time being, the issue of proper assessment of impact and accomplishments. The Committee trusts, however, that, in future, it should be easier to submit clearer statements with regard to meeting the objectives in General Assembly resolutions 53/220 A and B.
- 6. The Committee notes the improvements made in connection with the management of the account, reported in paragraphs 7 to 10 of the report, such as those related to the support of the integrated monitoring of the Development Account projects. Paragraph 10 indicates that the Executive Committee for Economic and Social Affairs increasingly serves as collective manager of the Account. The Committee cautions that the Under-Secretary-General for Economic and Social Affairs is ultimately accountable for the management of the Development Account and that the role of the Executive Committee should therefore be to provide overall guidelines.
- 7. The Advisory Committee recommends that the General Assembly take note of the report of the Secretary-General (A/57/360). The Committee is of the opinion, however, that the report in connection with the Development Account should be submitted in the context of the presentation of the proposed programme budget.
