## Statements, Languages and Remote Simultaneous Interpretations

Speakers are encouraged to deliver speeches at a moderate pace to enable the interpreters to provide an accurate and complete rendition of their statements. When statements are delivered at a fast pace, the quality of the interpretation may suffer. It is suggested not to exceed the speed of about 100 to 120 words per minute (as a guide for statements delivered in English) in order to ensure that the statement is delivered at a normal pace.

Simultaneous interpretation of the virtual proceedings is provided by the United Nations for the purpose of facilitating communication in the six official languages. In cases of interruption, partial or complete loss of audio, interpretation will be turned off and will resume when conditions allow. Only the speech or intervention in the original language is authentic. In case of any inconsistency between the interpretation and the speech or intervention in the original language, the latter shall prevail. In cases of poor connection, below-standard sound quality, and when no written statement is provided, interpretation will not be possible.

Due to the limitation of the virtual platforms, speakers would only be able to deliver their statements and/or made an intervention in one of the official languages of the UN. Speakers may deliver their statements through an intermediary (their own interpreter) or through consecutive interpretation by their interpreter within the same time limit provided for each speaker.

In order to facilitate the provision of interpretation, speakers are invited to provide statements electronically well in advance to facilitate interpretation and mitigate possible connectivity problems associated with the virtual setting, such as interruptions, bad sound quality, loss of sound. Please submit

your statement as soon as possible but no later than three hours in advance of delivery to <u>estatements@un.org</u>. Speakers are required to send the statements in both <u>PDF and word documents</u>. It will be kept confidential and checked against delivery to allow for last-minute changes in the text by the speakers.

#### Virtual Platforms

The virtual platforms that will be used for the thirteenth session of the COSP is **Zoom Webinar** with simultaneous interpretation.

Speakers will be provided a link to login to Zoom and those requiring remote simultaneous interpretation to one of the UN official languages can listen via Zoom using the interpretation function available at the bottom of the screen.



For a more desirable user experience, it is recommended that Google Chrome is used for both platforms.

The Conference will be recorded and streaming live in UN WebTV (<u>http://webtv.un.org/</u>) in all six United Nations' official languages as well as with International Sign interpretation and closed captioning.


#### User Guide on Zoom Webinar

#### Joining the meeting

When you are invited to a Zoom Webinar, you will receive an email with instructions. For security and confidentiality reasons, please keep do not share this email.

1. If you have not used Zoom before, you may be prompted to install the app (<u>https://zoom.us/download</u>) or join the Zoom on your web browser. It is recommended that you install the app for a better user experience.

- It is important that you include your full name in the <u>first name field</u> and (delegation/organization name) in the <u>last name field</u> in order for the meeting host to grant entry access. [For example, Amb. Katalin Bogyay (Hungary) or Frances West (Frances West Co)].
- 3. Ensure that your camera and microphone are <u>turned off</u> until you are called to speak. You'll see when your microphone is muted. Please keep your camera <u>turned on</u> at all times.



4. Click Join Event.

Turn on your microphone. Please keep camera turned on at all times and especially one minute before your speaking time.


If you need to share a content, such as Microsoft PowerPoint presentation, under **Share Content** and select **Share Application**.


#### **Interventions**
