High-Level Panel on the Priority Theme of the 56th Session of CSocD Mon 29 Jan. 3pm – 6pm

- The panel on the priority theme will engage in a substantive dialogue, focused on the following:
 - (1) Policy actions and recommendations on ways to effectively address the root causes of poverty within countries
 - (2) Knowledge sharing, experiences and innovative strategies that have proven to be effective at eradicating poverty in all its forms at the national, regional and international levels
 - (3) Issues related to poverty eradication, including inequality, resource mobilization, the use of disaggregated data and effective and accountable public institutions
 - (4) Emerging issues likely to affect the eradication of poverty and accelerating sustainable, inclusive and equitable economic growth and sustainable development.
