Background and Objective

 The 72nd session of the General Assembly proclaimed the "Third United Nations Decade for the Eradication of Poverty (2018–2027)" (A/RES/72/233).

- The objective of the Third Decade is to maintain the momentum generated by the implementation of the Second United Nations Decade for the Eradication of Poverty (2008-2017) towards poverty eradication.
- The Assembly also requested the SG to submit to its 73rd session a report that details the response of the UN system to the theme of the Third Decade - "Accelerating global actions for a world without poverty"

Background and Objective, con'td

The SG was requested to :

i)

submit an inter-agency, system-wide plan of action for poverty eradication to coordinate the efforts of the United Nations system,

 ii) provide recommendations concerning how to make the 3rd Decade effective, in support of the internationally agreed development goals related to poverty reduction, including the SDGs, utilizing, as appropriate, existing expertise and poverty-related follow-up mechanisms and processes.

Thematic Areas

- 1. Productive employment and decent work in the context of a changing labour market
- 2. The future of food and sustainable agriculture
- 3. Human capability development: addressing the non-income forms of poverty
- 4. Social protection
- 5. Reducing inequalities
- 6. Addressing climate change and intensification of natural hazards
- 7. Fighting poverty in fragile and humanitarian contexts
- 8. Strengthen capacity in countries for implementing the 2030 Agenda
- Advocacy and awareness-raising of the joint implementation of the Third United Nations Decade for the Eradication of Poverty
