- (1) Sharing knowledge and experiences on how countries can design and implement fiscal policies that help reduce inequality and poverty simultaneously.
- (2) Lessons learned when governments pursue counter-cyclical fiscal policy in an attempt to address both inequality and poverty.
- (3) Labour market policy, including wage and minimum wage policies, in addressing inequality and challenges to social inclusion.
- (4) Innovative approaches and effective strategies to build nationally appropriate social protection systems including floors
