Bios of the speakers



H.E. Ms. Alya Ahmed Saif Al-Thani is the Permanent Representative of the State of Qatar to the United Nations and Chair of Commission for Social Development. Prior her appointment as Permanent Representative to the United Nations in New York in 2013, Ms. Al-Thani was her country's Permanent Representative to the United Nations in Geneva, beginning December 2011. From August 2011 to October 2011, she served as Ambassador to the Cabinet of the Ministry of Foreign Affairs. She was Deputy Permanent Representative at Qatar's Permanent Mission to the United Nations in

New York from May 2010 to July 2011, having previously been Minister Plenipotentiary from June 2009 to April 2010 and Counsellor from April 2007 to May 2009. From September 2006 to March 2007, Ms. Al-Thani was the Director of the Division of the Rights of the Child in the General Secretariat of Qatar's Supreme Council for Family Affairs, having served as Acting Director between June 2004 and August 2006. From October 2003 to May 2004, she was a Senior Specialist in the General Secretariat of the Supreme Council's Department of International Relations. Born in Doha in 1974, Ms. Al-Thani holds a Master of Arts in international studies and diplomacy from the University of London's School of Oriental and African Studies, and a Bachelor of Science in economics from Qatar University.



H. E. Ms. Lachezara Stoeva was elected the seventy-eight President of the Economic and Social Council on 25 July 2022. Ambassador Lachezara Stoeva is currently the Ambassador and Permanent Representative of Bulgaria to the United Nations in New York. She assumed her duties as Permanent Representative of Bulgaria to the United Nations on 16 February 2021. Before her appointment, Ms. Stoeva headed the Department of Economic, Financial and Administrative Affairs of the United Nations, in Bulgaria's Ministry of

Foreign Affairs. She served as Deputy Permanent Representative to the United Nations from 2016 to 2019, prior to which she was Acting Deputy Permanent Representative and Counsellor, responsible for issues including international security and disarmament. Prior to her posting in New York, Ms. Stoeva headed the Foreign Ministry's Department of Arms Control and Non-Proliferation from 2013 to 2014, and the Department of International Development Cooperation from 2012 until 2013. She first joined the Ministry in 2002 and has worked extensively on international security issues with an emphasis on arms control, non-proliferation and United Nations issues. Ms. Stoeva holds master's degrees in European politics and government from the London School of Economics and in political science from Sofia University "St. Kliment Ohridski".



Mr. Li Junhua is Under-Secretary-General for Economic and Social Affairs. Mr. Li brings to the position perspectives and visions on fostering multilateral economic and social cooperation, with a commitment to engage with all parties to further implement the 2030 Agenda including dedication to serve member states. He has contributed to numerous meetings of the Economic and Social Commission for Asia and the Pacific (ESCAP), the United Nations General Assembly and Security Council, as well as other multilateral meetings including the G20, Asia-Pacific Economic Cooperation

Her knowledge of the United Nations system, policies and procedures, has been particularly useful to NGOs that participate in deliberations in intergovernmental meetings. She was a key participant in the establishment of the Stakeholder Group on Ageing in 2013, as part of the Major Groups and Other Stakeholders involved, as civil society participants, in sustainable development issues and was actively engaged in the United Nations intergovernmental negotiations leading up to the adoption of the 2030 Agenda for Sustainable Development, ensuring inclusion of the concerns of older persons. She is the UN Focal Point in New York for the Stakeholder Group on Ageing. Keynote speaker



Ms. Manuela Tomei has been Director of the Conditions of Work and Equality Department, International Labour Organization (ILO) since 2013. She has held various posts at ILO Headquarters in Geneva and its Regional Office in Peru. She was lead coordinator of the preparatory work that culminated in the adoption of the last two ILO Conventions, namely, C.190 on violence and harassment in the world of work in 2019, and C.189 on decent work for domestic workers in 2011. Together with UN Women and OECD, the ILO established and launched at the UN General Assembly in

September 2017 the Equal Pay International Coalition (EPIC) to contribute to the realization of SDG 8.5, in which Ms. Tomei played a key role. She led the work that resulted in the adoption by the 2021 International Labour Conference of the Resolution on inequalities and the world of work. She has written and provided policy advice on a range of subjects, including gender, poverty and work, informal and non-standard forms of employment, wages and the gender pay gap.

Minister Rafael Eugenio Rodríguez Pellecer raduated as a lawyer and notary public from Rafael Landívar University in Guatemala City and has a master's degree in Governance and Public Administration from the Universidad Complutense in Madrid, Spain. Mr. Rodríguez was the Director of the National Office for Civil Service (ONSEC in Spanish). He has experience as a technical advisor to various Guatemalan Congressional Committees and with that experience, was also a legal advisor in the USAID/Checchi Security and Justice Program. In addition, Mr.

Rodríguez taught in the Public Administration master's degree program of the National Institute of Public Affairs (INAP in Spanish) and was a consultant in a project which led to reforms in the Civil Service and changes in the regulations for public management services. Mr. Rodríguez was named Minister of Labor and Social Welfare in July 2020 and has been in charge of the Ministry since then. His responsibilities include the Employment Department which manages the Seasonal Labor Program.



Mr. Dirk Andreas Zetzsche is Professor of Financial Law at the University of Luxembourg. Prof. Zetzsche holds the ADA Chair in Financial Law (inclusive finance) since March 2016 and leads the Faculty of Law, Economics and Finance's House of Sustainable Governance & Markets. His research focuses on inclusive and sustainable finance as well as financial and corporate law, in particular on payment and banking systems, collective investment

schemes, institutional investments and FinTech/RegTech/CorpTech. Prof. Zetzsche is consistently listed for the last three years on SSRN (http://ssrn.com/author=357808) in the Top 10 law authors globally, measured by downloads in the last 12 months. He is the author of more than 350 publications, including some globally leading articles and treatises on sustainable finance law and regulation, collective investment schemes, FinTech/RegTech, corporate governance as well as cross-border financial services. Prof. Zetzsche has held presentations and lectures at leading universities around the world, for instance (in alphabetical order) Cambridge University, Columbia University, Harvard University, LSE, National University of Singapore, Oxford University, University of Chicago, University College London, University of Hong Kong, University of Paris I / Sorbonne, University of Zürich, UNSW Sydney, Yale University. He regularly cooperates with international development organizations and NGOs, including ADA, the Alliance for Financial Inclusion, the Asian DevelopmentBank, the European Investment Bank, the Islamic Development Bank, the German GIZ, the Toronto Centre, the Worldbank, the United Nations, and the CarnegieEstablishment on International Peace, among others.

Cooperation (APEC), Asia–Europe Meeting (ASEM), BRICS etc. As Under-Secretary-General for Economic and Social Affairs, Mr. Li guides UN Secretariat support for the follow-up processes of the 2030 Agenda for Sustainable Development, including the High-level Political Forum on Sustainable Development. He also oversees the substantive services to many intergovernmental processes, including the annual meetings of the Second and Third Committees of the General Assembly, the meetings of the Economic and Social Council, including its Development Cooperation Forum, and the work of the subsidiary bodies of ECOSOC. In addition to intergovernmental processes, Mr. Li oversees DESA's policy analysis and capacity development work. He also serves as the Convenor of the Executive Committee on Economic and Social Affairs, and advises the United Nations Secretary-General on all

development-related issues, including climate change, internet governance, and financing for development.
