Every time an elder dies, a library is burnt': Amazon COVID-19 toll grows

COVID-19 kills the elderly, those with underlying health conditions, the poor and vulnerable. It is now doing so in the Brazilian Amazon where the virus killed nine Munduruku indigenous elders in just a few days. Forest people elders are typically leaders and keepers of culture, so their loss is especially destabilizing. Officially, 218 indigenous people had died of COVID-19 and 2,642 were infected as of 7 June. But experts say that the numbers are at least three times higher, with poor government recordkeeping and Amazon community remoteness resulting in a severe undercount.

Overlap of fire, COVID-19 peaks: A ‘catastrophe’ for Brazil’s Amazon

Researchers have detected the “first major fire of 2020” in the Brazilian Amazon three months ahead of the fire season, in Mato Grosso. While other scientists warn that there could be a “catastrophe” in the region if the peak of fires and COVID-19 overlap.

Another report, led by scientists at Brazil’s National Institute of Space Research (INPE), indicates that the continued rise in cases of COVID-19 combined with the approach of fire season in the Amazon could overwhelm the Amazon region’s clinics due to the increase in respiratory diseases as a result of the fires.

Em uma semana, casos de Covid-19 triplicam entre indígenas na região do Xingu, no Pará

Os casos de Covid-19 triplicaram em uma semana entre indígenas na região do Xingu, no Pará. Nesta quinta (11), já são 80 infectados e um óbito, de acordo com o Distrito Sanitário Especial Indígena (Dsei) de Altamira, sudoeste do estado. Entre os casos confirmados, 16 estão recuperados após isolamento domiciliar.

Agentes de saúde levaram Covid-19 a povos isolados, dizem indígenas; governo nega

Indígenas que vivem no Vale do Javari, no extremo oeste do Amazonas – região com maior número de grupos isolados e de recente contato do mundo – afirmam que foram contaminados por Covid-19 por agentes de saúde do governo. Ao menos 20 indígenas da região já contraíram a doença, segundo o governo do estado. O Ministério da Saúde nega que agentes do governo tenham levado a doença, e afirma que "a região tem como característica a passagem de comerciantes e pescadores". Após as denúncias dos indígenas, porém, o Ministério Público Federal (MPF) fez recomendações ao governo, solicitando a compra urgente de insumos para tratamento da Covid-19, além da instalação de locais adequados de quarentena para profissionais de saúde e indígenas contaminados ou com sintomas do vírus.

A rise in illegal deforestation heightens the risk of fires in the Brazilian rainforest even more destructive than those that drew global outrage last year. Since coming to office, President Jair Bolsonaro of Brazil has enabled increased razing of the Amazon rainforest.

Now, the coronavirus has accelerated that destruction.

Illegal loggers, miners and land grabbers have cleared vast areas of the Amazon with impunity in recent months as law enforcement efforts were hobbled by the pandemic.

Indígenas que vivem na região com o maior número de grupos isolados e de recente contato do mundo, o Vale do Javari, no Amazonas, fizeram um pedido de socorro às autoridades neste domingo (7), depois que foram confirmados pelo menos quatro casos entre profissionais de saúde e sete entre indígenas. Os números do governo federal conflitam com os da prefeitura de Atalaia do Norte (AM), que já fala em 12 casos confirmados entre indígenas na sua jurisdição.

Para ambos boletines, la información deriva de los 34 Distritos Sanitários Especiais Indígenas (DSEI), validados por el Departamento de Atenção à Saúde Indígena (DASI).

El Boletín del reporta 2608 casos de indígenas contagiados en áreas rurales y 89 fallecidos.

Los DSEI más afectados son Alto Rio Solimoes, Guamá-Tocantins, Maranhão.

Casos reportados por la APIB

Diante da subnotificação dos casos indígenas pelos dados oficiais (veja abaixo) a Apib vem realizando um levantamento independente dos casos. Os números são superiores aos notificados pela Sesai, que tem contabilizado somente casos em terras indígenas homologadas. A compilação de dados da Apib tem sido feita pelo [Comitê Nacional de Vida e Memória Indígena](#) e pelas Organizações indígenas de base da APIB. Outras frentes de enfrentamento à Covid-19 organizadas no Brasil também têm colaborado com a iniciativa. Diferentes fontes de dados têm sido utilizadas nesse esforço, além da própria Sesai, o comitê tem analisado dados das Secretarias Municipais e Estaduais de Saúde e do Ministério Público Federal.
