Input from the UNCCD

Land is fundamental for the development and wellbeing of indigenous peoples. The United Nations Convention to Combat Desertification (UNCCD) is the sole legally binding international agreement linking environment and development to sustainable land management. The Convention addresses specifically the arid, semi-arid and dry sub-humid areas, known as the drylands, where some of the most vulnerable ecosystems and peoples can be found

Decision 5/COP14 adopted in New Delhi on the participation and involvement of civil society organizations in meetings and processes of the UNCCD requests the secretariat to continue working with key stakeholders, including youth, faith-based organizations, local governments, farmers, pastoralists, women’s organizations, indigenous peoples and local communities. In this regard, during the course of 2021, the secretariat is supporting the participation of indigenous peoples in the meetings of the governing bodies of the

Conventions (15th session of the Conference of the Parties -COP15) and its subsidiary bodies (19th session of the Committee for the Review of the Implementation of the Convention – CRIC19).

Civil society organizations representing indigenous peoples are being engaged in the work of the convention. In this regard, CENESTA a non-governmental organization from Iran is representing both indigenous peoples and Asian organizations within the UNCCD CSO panel and ensuring that the body is taking into consideration the points of view of IPOs. The panel meets once a month and has included the engagement of IPOs as one of the priorities for the current biennium.

Furthermore, decision 20/COP.14 on the policy-oriented recommendations resulting from the cooperation with other intergovernmental scientific panels and bodies encourages stakeholder participation, involving land managers, including indigenous peoples and local communities, as well as experts and other knowledge holders, in policy for, planning for and implementation of land degradation neutrality.

In the framework of addressing the important aspect of access and protection of the land, the Parties to the Convention, adopted decision 26/COP14 on land tenure. In addition to highlighting the relevance of the Voluntary Guidelines on the Responsible Governance of Tenure of Land, Fisheries and Forests in the Context of National Food Security (VGGT), endorsed by the United Nations Committee on World Food Security, to the implementation of the Convention, the decision encourages Parties to recognize legitimate tenure rights, including customary rights, consistent with the national legal framework. The decision also requests Parties to provide effective, timely and affordable access to justice and transparent dispute resolution mechanisms and to recognize and promote fair and inclusive community-based conflict resolution mechanisms.

The secretariat, together with the Food and Agriculture Organization and other partners is working to prepare a technical guide that could assist the Parties to the convention to integrate the VGGT into the implementation of the UNCCD and the achievement of the Land Degradation Neutrality.

Last but not least, the recently finalized Gender Action Plan of the Convention also contents a strong component in the protection and development of indigenous peoples, particularly in the areas of enhancing women's access to improved knowledge and technologies that relate to effective UNCCD implementation and in the way we could strengthen women's land rights and access to natural resources.

Building on outcomes of the ministerial interactive dialogue organized at COP14 on a values-based approach to land stewardship, the secretariat will pay special attention to the role of indigenous communities. Guardians of our global land resources, protecting 80% biodiversity on Earth, if we are to stand a chance of arresting the degradation of our natural world, the implementation of the Convention can help the global community recognize, promote and harness indigenous communities' invaluable knowledge and intuitive connection with nature.

As requested in the Outcome Document of the World Conference on Indigenous Peoples (A/RES/69/2), a system-wide action plan (SWAP) to ensure a coherent approach to achieving the ends of the UN Declaration on the Rights of Indigenous Peoples was adopted in November 2015 and launched by the Secretary-General at the UN Permanent Forum in May 2016.

In August 2020, the United Nations Executive Committee agreed on the need for accelerated and collective action to strengthen the implementation of UN System Wide Action Plan (SWAP) on indigenous peoples. In November 2020, the United Nations Chief Executives Board for Coordination issued a Call to Action: Building an Inclusive, Sustainable and Resilient Future with Indigenous Peoples, to ensure collaborative and coherent UN system action to support the rights and well-being of indigenous peoples with focus on furthering the implementation of the SWAP.

The Permanent Forum will follow up on progress made in the implementation of the system-wide action plan during its 2021 session. For ease of reference, the questions have been framed under the six key elements of the SWAP-Indigenous Peoples as follows:

1. Raising awareness of the UN Declaration

Input from the UNCCD

In the framework of the implementation of decision 26/COP14 on Land Tenure, the secretariat together with the Food and Agriculture Organization has been working on the development of a technical guide that will assist countries in integrating the VGGT into the UNCCD and Land Degradation Neutrality implementation.

As of today, 5 consultations have been organized to identify challenges, benefits and barriers that should be addressed in the preparation of such a technical guide. Representatives from IPOs have been present at the consultations, ensuring that articles 26 and 27 of the UNDRIP are taking into consideration when addressing land tenure.

The final document will be ready for presentation at COP15 (last quarter of 2021) for the consideration of the Parties.

Furthermore, the secretariat is preparing a strategy on how to promote awareness-raising on

responsible land governance for combating desertification/land degradation and drought among all stakeholders, particularly among vulnerable populations, including indigenous peoples and local communities (mandated by the same decision) Collaboration has been sought with the International Land Coalition and Land Portal

2. Supporting the implementation of the UN Declaration, particularly at the country level

The role of the new Resident Coordinators and UN Country Team framework is an integral component of the UN's commitment to support the rights of those at risk of being left behind, including indigenous peoples.

The Chief Executives Board committed to redouble efforts to help Resident Coordinators and UNCTs ensure more systematic participation of indigenous peoples in United Nations country processes.

Please provide information on actions taken or planned by your agency/ fund/ programme/ entity on the following:

- i. Any activities or support provided to indigenous peoples both during the COVID-19 pandemic and after, to ensure their inclusion in addressing the impacts of the pandemic, as well as in building back better.

The secretariat has been working on the aspects related to the Role of land in COVID-19 response and has issued a report promoting a new social contract for nature that meets our planet's current challenges. The report entitled ["Supporting the Global Response to the COVID-19 Pandemic: Land-based Solutions for Healthy People and a Healthy Planet"](#)

During 2020 we have organized several campaigns supporting young people that are working on the area of desertification, land degradation and drought. The campaign [#UNCCDLandHeroes](#) was launched during the year and the [winners](#) were announced at June 17, Desertification and Drought Day. During the rest of the year the secretariat

organized 6 webinars with the winners addressing relevant issues for the youth (education, employment, entrepreneurship, science, food security and art)

3. Supporting indigenous peoples' rights in the implementation and review of the 2030 Agenda for Sustainable Development

- i. Has your agency/organization taken any measures to incorporate indigenous issues into policy and programming to implement the 2030 Agenda in line with the UN Declaration on the Rights of Indigenous Peoples?

The UNCCD 2018-2030 Strategic Framework is the most comprehensive global commitment to achieve Land Degradation Neutrality (LDN) in order to restore the productivity of vast expanses of degraded land, improve the livelihoods of more than 1.3 billion people, and reduce the impacts of drought on vulnerable populations to build

A future that avoids, minimizes, and reverses desertification/land degradation and mitigates the effects of drought in affected areas at all levels to achieve a land degradation-neutral world consistent with the 2030 Agenda for Sustainable Development. The document identifies strategic objectives and requires Parties to report periodically on its implementation. Strategic objective 2 focusses on the improvement of the living conditions of populations affected by desertification, land degradation and drought. Among these aspects, the Parties identified the following expected impacts

1. Food security and adequate access to water for people in affected areas is improved
2. The livelihoods of people in affected areas are improved and diversified.
Expected impact
3. Local people, especially women and youth, are empowered and participate in decision-making processes in combating DLDD

4. Migration forced by desertification and land degradation is substantially reduced

Decision 26/COP14 on Land Tenure requests the secretariat, in consultation with the Bureau of the Committee for the Review of the Implementation of the Convention, to explore options for the integration of existing globally agreed Sustainable Development Goal indicators relevant to land governance into the UNCCD reporting process, with a view to avoiding duplication of reporting efforts and ensuring the widest reach among different national contexts.

In the next weeks the secretariat will finalize a report that will be looking particularly at the indicators 1.4.2 and 5.a.1 and 5.a.2. We hope to provide more information during the next reporting cycle.

Observers are invited to attend the sessions of the Conference of the Parties to the UNCCD and its subsidiary bodies (CRIC and Committee of Science and Technology). As of today, more than 600 civil society organizations are accredited as observer to the convention (full list available [here](#)). Several among them are IPOs. The secretariat always ensures that within the available resources there are organizations that receive financial support. The UNCCD CSO panel decides against 5 criteria (gender and geographical balance, turnover, expertise, and membership to a network) the organizations that will receive the financial support to attend those sessions.

In addition to the mandated official sessions, the secretariat also supports the participation of CSOs in relevant meetings of the [Science-Policy Interface](#) as well as the

[Intergovernmental Working Group on Drought](#) CSO representatives attending those meetings need to consult with the CSO panel and bring all the necessary elements to the discussion.
