As announced in the previous report (2021) and as part of the efforts to contribute to the International Decade of Indigenous Languages (2022-2032), ITU and UNESCO organised activities during the WSIS Forum 2022, to support indigenous languages and peoples as follows:

A- WSIS&SDG TalkX to celebrate International Mother Languages Day on 21 February 2022

On the occasion of international Mother language Day, ITU organized a WSIS&SDG TalkX, in collaboration with ITU, UNESCO and other Stakeholders, to discuss the potential role of technology in advancing multilingual education and support the development of quality learning for all. During the WSIS&SDG TalkX, High-Level panellists shared their countries best practices to ensure multilingualism, such as the creation of an Institute and a museum to preserve languages in Bangladesh or the decision to use Artificial Intelligence to tackle obstacles for digital inclusion and empowerment in India. B- ICTs for Indigenous Languages Hackathon in 2022

The WSIS Forum 2022 co-organized an online hackathon, in collaboration with ITU, UNESCO, Nokia and the Internet Society, under the theme of ICTs for Indigenous Languages.

The hackathon generated a lot of excitement worldwide, by gathering more than 690 participants from 67 Countries who ideated in teams of 2 to 5 members, ICT solutions addressing 3 challenges faces by Indigenous peoples, which are knowledge, empowerment and preservation. 3 winners, one for each challenge area were awarded a 1000 \$ cash prize, alongside a 6 month mentoring programme with Nokia, during a High-Level Dialogue organized as part of the WSIS Forum 2022 Final Week. The World Summit on the Information Society (WSIS) Forum co-organised annually by ITU, UNESCO, UNCTAD, and UNDP, in collaboration with more than 30 UN agencies provides a multistakeholder platform for information exchange, knowledge creation, and sharing of best practices on information and communication technologies (ICTs) and fostering partnerships.

Through the WSIS Forum activities, we promote the participation of indigenous peoples in the international decades declared by the General Assembly and other relevant international decades and processes.

B. System-Wide Action Plan to achieve the ends of the UN Declaration on the Rights of Indigenous Peoples

Background

As per the Outcome Document of the World Conference on Indigenous Peoples (A/RES/69/2), a system-wide action plan to ensure a coherent approach to achieving the ends of the UN Declaration on the Rights of Indigenous Peoples was adopted in November 2015 and launched by the Secretary-General at the UN Permanent Forum in May 2016.

In August 2020, the United Nations Executive Committee agreed on the need for accelerated and collective action to strengthen the implementation of the SWAP on indigenous peoples. In November 2020, the United Nations Chief Executives Board for Coordination issued a <u>Call to Action: Building an Inclusive, Sustainable and Resilient Future with Indigenous Peoples</u>. Its goal is to ensure collaborative and coherent UN system action to support the rights and

well-being of indigenous peoples with a focus on furthering the implementation of the SWAP².

C. 2030 Agenda for Sustainable Development

i. <u>ITU's work for Indigenous Peoples</u> focuses not only on empowering Indigenous peoples, cultures and communities by enhancing digital literacy, but also on supporting these communities to learn how to develop and maintain digital environments that respond to the needs and embrace the diversity of Indigenous peoples' aspirations.

To support the achievement of this goal, ITU works through a capacity building programme created by the ITU Development Sector (ITU-D) tailored for Indigenous peoples. This programme aims to strengthen the capacity of Indigenous communities from the Americas region with digital literacy skills and knowledge applicable for their communities' needs and requirements. The ITU-D blended training program, developed in follow up to the last World Telecommunication Development Conference (WTDC-17), is also in line with ITU Resolution 46 that calls for leveraging indigenous communities' knowledge of Information and Communication Technologies (ICTs).

The ITU-D capacity building programme for Indigenous People is also organized in close collaboration with Indigenous Organizations, experts in Indigenous issues, and Communities' representatives. The ITU has made available two certified training programmes:

1- Capacity building programme to develop indigenous technicians knowledgeable on how to design, develop and maintain telecommunications and ICT networks. It also promotes entrepreneurship by the participants helping to ensure the sustainability of the networks in these communities. The training encompasses five (5) independent modules and a training camp.

Unit 1: Development of web pages with content of interest to indigenous communities

Unit 2: Emergency information systems

Unit 3: Web tools for network development

Unit 4: Development of an indigenous radio network

Unit 5: Use of digital content on the indigenous radio network.

Each of the modules and the curriculum structure were designed based on ITU previous training experiences on developing technical capacities of Indigenous People in their own villages. For those who successfully completed the whole program (5 modules), the training invites the successful Indigenous participants to also take part in a face-to-face training camp, which aims to be a space that facilitates the mutual exchange of challenges and knowledge and overall generates a network of indigenous technical promoters in the Americas region.

More information about the 1st training programme:

In collaboration with the Fund for the Development of the Indigenous Peoples of Latin America and the Caribbean (FILAC) the ITU-D delivered in 2022 two editions of the training programme on Innovative communication tools to strengthen the capacities of indigenous communities with a focus on how to develop, manage, and operate a network.

These tutor-led online trainings that were held through the ITU Academy from 16 May 31 July and from 25 July to 9 October 2022, received 200 inscriptions from Indigenous Peoples (45% women) from 16 countries (Argentina, Bolivia, Brazil, Chile, Colombia, Costa Rica, Cuba, Ecuador, Guatemala, Honduras, Mexico, Nicaragua, Panama, Paraguay, Peru and Venezuela). The use of digital content in the indigenous radio network, is enabling participants to follow either a part of the training in the topic of their interest or to complete the whole programme, which was the case for 68 of Indigenous participants.

2- Technical Promoters in telecommunication and broadcasting in Indigenous Communities. training programme (not finished yet), but the work so far includes:

A blended training programme (online through ITU Academy and face-to-face) that aims at developing Technical Promoters in telecommunication and broadcasting in Indigenous Communities

The 2022 edition (held throughout the year in 4 sessions), will be finalised with a face-to-face, hands-on campus, that is currently ongoing - <u>held from 7 to 18 November in Fusagasugá</u>, Colombia.

This training is developing professionals in the ICT field, and therefore the trainees must fulfil all the phases of the training. Therefore we work with professionals on indigenous issues and telecommunication topics. So far, 40 Indigenous have fully validated the knowledge of the 4 training modules and are eligible for the campus.

Considering the complexity of this training (a good percentage cannot arrive at the campus phase), and from previous experience, we can hope that all 40 Indigenous will also pass the hands-on campus activities.

The number might look small, but we should consider the impact that each of the technical graduated indigenous can do at the community level, which is considerable because they will not only replicate the knowledge at the community level but will also ensure the safecommunity's *ICT-related* sustainability the *Indigenous* services. Both training courses detailed in points 1 and 2 above, are delivered through the ITU Academy. ITU Academy provides high-quality training to anyone, from government policymakers and regulators to operational and technical staff, students, entrepreneurs as well as any citizens interested in developing skills and abilities in the field of ICT and digital development.

ITU-D also made available a User Guide for our ITU Academy platform – tailored for Indigenous Peoples in the Spanish language to attract more Indigenous peoples that will benefit from these courses and facilitate their understanding of how to access and make use of the training content from this platform. The guide offers a step-by-step explanation for every procedure in the platform to facilitate, incentivize and leverage the Indigenous People learning process.
