Summary

The thirty-third session of the Commission on Population and Development was held at United Nations Headquarters from 27 to 30 March 2000. Its central theme was population, gender and development.

The documents before the Commission included a report on world population monitoring, focusing on the theme of the session. The report included a historical review of population and gender issues in the global agenda, and also provided information on selected aspects of population, gender and development, covering topics such as family formation, health and mortality (including human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/AIDS)), ageing, internal migration and international migration. Other reports covered the inter-sessional meeting of the Bureau of the Commission; the monitoring of population programmes; flows of financial resources for assisting in the implementation of the Programme of Action of the International Conference on Population and Development; the special session of the General Assembly for the review and appraisal of the implementation of the Programme of Action; and the programme of work of the Population Division of the United Nations Secretariat in the field of population. The Commission also considered and took note of the draft medium-term plan of the Population Division for the period 2002-2005.

The Commission considered follow-up actions to the recommendations of the International Conference on Population and Development (agenda item 3) and adopted a resolution concerning a gender perspective in the research and analyses conducted by the Population Division. Concerning the work of the Commission during the next quinquennium (agenda item 5), the Commission reaffirmed that population, environment and development would be the special theme for 2001, and decided that future special themes would be reproductive rights and reproductive health in 2002, and population, education and development in 2003.

The Commission approved the provisional agenda for its thirty-fourth session and recommended to the Economic and Social Council the adoption of a draft decision in which the Council would approve the provisional agenda.

B. Matters brought to the attention of the Council

2. The following resolution and decisions adopted by the Commission are brought to the attention of the Council:

**Resolution 2000/1
Population, gender and development***

The Commission on Population and Development,

Reaffirming the commitment of Member States to the implementation of the Programme of Action of the International Conference on Population and Development,¹

Recalling the recommendations of the Programme of Action and reaffirming the key actions for the further implementation of the Programme of Action relating to gender equality, equity and the empowerment of women,

Recalling also that the theme for the thirty-third session of the Commission on Population and Development was population, gender and development,

Noting the fundamental importance of gender dimensions for all aspects of demographic change and development of a society,

Noting also the significance of policies and programmes affecting gender relations,

Recognizing the need to eliminate all discrimination and abuse against women and children, including sexual abuse, exploitation, trafficking and violence, and exposure, especially of young women, to high risks of human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/AIDS) infection,

1. *Requests* the Population Division of the United Nations Secretariat to continue to incorporate gender perspectives in all its research on population policies, levels and trends, including, *inter alia*, the analysis of demographic, social and economic data disaggregated by age and sex, so that Governments may benefit by achieving a better understanding of the relationships between population, gender and development in the global context and through intercountry comparisons;

2. *Also requests* the Population Division, in conducting these analyses, to pay particular attention to the gender dynamics and demographic implications of the human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/AIDS) pandemic, infant, child and maternal mortality, and ageing of populations, and to improving the statistical description and analysis of the phenomena of all forms of discrimination and abuse against women and children, including sexual abuse, exploitation, trafficking and violence, as well as to the gender dimensions of migration.

Decision 2000/1 Special themes for the Commission on Population and Development in the years 2001-2003*

The Commission on Population and Development:

(a) Reaffirms Commission on Population and Development decision 1999/1² in which the Commission decided that “Population, environment and development” should be the special theme for the Commission at its thirty-fourth session in 2001;

(b) Decides that the special theme for the Commission at its thirty-fifth session in 2002 shall be “Reproductive rights and reproductive health, with special reference to human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/AIDS)”;

(c) Also decides that the special theme for the Commission at its thirty-sixth session in 2003 shall be “Population, education and development”;

(d) Requests the Population Division of the United Nations Secretariat to give due attention to the impact of human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/AIDS) in the preparation of reports for the forthcoming theme sessions of the Commission on Population and Development for the years 2001-2003.

Chapter II

Follow-up actions to the recommendations of the International Conference on Population and Development

3. The Commission on Population and Development held a general discussion on item 3 of its agenda, entitled "Follow-up actions to the recommendations of the International Conference on Population and Development: (a) special theme: population, gender and development; (b) special session of the General Assembly for the review and appraisal of the implementation of the Programme of Action of the International Conference on Population and Development", at its 1st and 2nd meetings, on 27 March 2000. Under agenda item 3, the Commission had before it the following documents:

(a) Report of the Secretary-General on the special session of the General Assembly for the review and appraisal of the implementation of the Programme of Action of the International Conference on Population and Development (E/CN.9/2000/2);

(b) Concise report of the Secretary-General on world population monitoring, 2000: population, gender and development (E/CN.9/2000/3);

(c) Report of the Secretary-General on the monitoring of population programmes: population, gender and development (E/CN.9/2000/4);

(d) Report of the Secretary-General on the flow of financial resources for assisting in the implementation of the Programme of Action of the International Conference on Population and Development (E/CN.9/2000/5 and Corr.1).

4. At the 1st meeting, on 27 March, the Director of the Population Division of the Department of Economic and Social Affairs of the United Nations Secretariat made an introductory statement.

5. At the same meeting, statements were made by the Assistant Director and Chief of the Demographic Analysis Branch of the Population Division, who introduced the concise report of the Secretary-General on world population monitoring, 2000: population, gender and development (E/CN.9/2000/3); the manager of the Gender Theme Group of the United Nations Population Fund, who introduced the report of the Secretary-General on the monitoring of population programmes: population, gender and development (E/CN.9/2000/4); and the Director of the Technical and Policy Division of the United Nations Population Fund, who introduced the reports of the Secretary-General on the flow of financial resources for assisting in the implementation of the Programme of Action of the International Conference on Population and Development (E/CN.9/2000/5 and Corr.1) and on the special session of the General Assembly for the review and appraisal of the implementation of the Programme of Action of the International Conference on Population and Development (E/CN.9/2000/2).

6. Also at the 1st meeting, statements were made by the representatives of Japan, China and the United States of America and the observer for Portugal (on behalf of the States Members of the United Nations that are members of the European Union, Bulgaria, the Czech Republic, Estonia, Hungary, Latvia, Lithuania, Romania, Slovakia, Slovenia, Cyprus and Turkey).

7. At the 2nd meeting, on 27 March, statements were made by the representatives of the Russian Federation, Jamaica, Nigeria, Algeria, South Africa, Canada, Belarus, Italy, Belgium, the Islamic Republic of Iran and Sweden.

8. At the same meeting, statements were made by the representatives of the Food and Agriculture Organization of the United Nations, the United Nations Educational, Scientific and Cultural Organization and the World Health Organization.

Action taken by the Commission

Population, gender and development

9. At the 7th meeting, on 30 March, the Vice-Chairman of the Commission, Antonio Golini (Italy), introduced a draft resolution entitled "Population, gender and development" (E/CN.9/2000/L.4), which was submitted on the basis of informal consultations.

10. The observer for Portugal made a statement on behalf of the States Members of the United Nations that are members of the European Union.

11. At the same meeting, the Commission adopted draft resolution E/CN.9/2000/L.4 (see chap. I, sect. B, resolution 2000/1).

Documents considered by the Commission under agenda item 3

12. At its 7th meeting, on the proposal of the Chairman, the Commission took note of the documentation submitted under agenda item 3 (see chap. I, sect. B, decision 2000/2).

Chapter III

National experience in population matters: population, gender and development

13. The Commission on Population and Development considered item 4 of its agenda, entitled "General debate on national experience in population matters: population, gender and development", at its 3rd to 5th meetings, on 28 and 29 March 2000.

14. At the 3rd meeting, on 28 March, statements were made by the representatives of Croatia, India, Bangladesh, Pakistan, China, the Russian Federation, the Republic of Korea, Sweden, Panama, Brazil, Uganda, Canada and the Netherlands.

15. At the same meeting, the observer for the International Organization for Migration made a statement.

16. Also at the 3rd meeting, the representative of the International Labour Organization made a statement.

17. At the 4th meeting, on 28 March, statements were made by the representatives of Algeria, El Salvador, South Africa, Ukraine, Turkey, Malaysia and Thailand and the observers for Burkina Faso and the Holy See.

18. At the 5th meeting, on 29 March, statements were made by the representatives of the Philippines, Haiti, Malawi and Mexico and the observers for Lesotho, Tunisia, the Dominican Republic, Austria and Norway.

Chapter IV

Work of the Commission on Population and Development in the next quinquennium

19. The Commission on Population and Development held a general discussion on item 5 of its agenda, entitled “Work of the Commission on Population and Development in the next quinquennium”, at its 5th meeting, on 29 March 2000.
20. At the same meeting, the Director of the Population Division made an introductory statement.
21. Also at the 5th meeting, the representative of the United States of America made a statement.

Action taken by the Commission

Special themes for the Commission on Population and Development in the years 2000-2004

22. At the 7th meeting, on 30 March, the Vice-Chairman of the Commission, Antonio Golini (Italy), introduced a draft decision entitled “Special themes for the Commission on Population and Development in the years 2001-2003” (E/CN.9/2000/L.5), which was submitted on the basis of informal consultations.
23. Statements were made by the representative of Uganda and the observer for Portugal (on behalf of the States Members of the United Nations that are members of the European Union).
24. At the same meeting, the Commission adopted draft decision E/CN.9/2000/L.5 (see chap. I, sect. B, decision 2000/1).
25. After the adoption of the draft decision, the Vice-Chairman made the following statement reflecting the understanding reached during the informal consultations:
 - (a) With regard to the special theme for the thirty-fifth session of the Commission in 2002, “Reproductive rights and reproductive health, with special references to human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/AIDS)”, it had been agreed that the report on World Population Monitoring should also give special attention to adolescents, sexually transmitted diseases (STDs) and family planning;
 - (b) It had been agreed that preparation of the next quinquennial review and appraisal of the progress made in achieving the goals and objectives of the Programme of Action of the International Conference on Population and Development, such a review and appraisal having been called for by the General Assembly in its resolution 49/128, should be discussed under agenda item 5 at the thirty-fourth session of the Commission;
 - (c) With regard to an international event on population and development to be held in 2004, delegations had concluded that it was too early to consider it at this time; and some delegations felt that a final decision could be made at the thirty-fifth session of the Commission. However, there was not yet an agreement in terms of the outcome of such an event. Individual Governments would need to consider the key actions to be adopted at other quinquennial reviews; and Governments would need time to reflect on all the quinquennial reviews so as to allow them to give any such event in 2004 a sense of purpose and clarity.

Chapter V

Programme implementation and future programme of work of the Secretariat in the field of population

26. The Commission on Population and Development held a general discussion on item 6 of its agenda, entitled "Programme implementation and future programme of work of the Secretariat in the field of population" at its 6th meeting, on 29 March 2000. It had before it the following documents:

(a) Report of the Secretary-General on programme implementation and progress of work in the field of population in 1999: Population Division, Department of Economic and Social Affairs (E/CN.9/2000/6);

(b) Note by the Secretariat on the draft medium-term plan of the United Nations Population Division for the period 2002-2005 (E/CN.9/2000/CRP.2).

27. At the same meeting, the Director of the Population Division made an introductory statement.

28. Also at the 6th meeting, statements were made by the representatives of the United States of America, the Russian Federation, Bangladesh and the Islamic Republic of Iran and the observers for Portugal (on behalf of the States Members of the United Nations that are members of the European Union, Bulgaria, the Czech Republic, Estonia, Hungary, Latvia, Lithuania, Malta, Poland, Romania, Slovakia, Slovenia, Cyprus and Turkey), Poland and Norway.

29. At the same meeting, statements were made by the representatives of the Economic Commission for Africa, the Economic Commission for Latin America and the Caribbean and the Economic and Social Commission for Asia and the Pacific. The representative of the Regional Commissions New York Office read out statements on behalf of the Economic Commission for Europe and the Economic and Social Commission for Western Asia.

30. Also at the 6th meeting, statements were made by the Directors of the Division for the Advancement of Women, the Division for Social Policy and Development, the Division for Sustainable Development and the United Nations Statistics Division of the Department of Economic and Social Affairs of the United Nations Secretariat.

31. At its 7th meeting, on 30 March, following a statement by the observer for Poland, the Commission strongly recommended the continuation of the global Population Information Network (POPIN) and urgently requested that all efforts be made by the Population Division and the United Nations Population Fund to find and secure stable funding for the activities of that valuable network.

Action taken by the Commission

Documentation considered by the Commission under agenda item 6

32. At its 7th meeting, on the proposal of the Chairman, the Commission took note of the documentation submitted under agenda item 6 (see chap. I, sect. B, decision 2000/2).

Chapter VI

Provisional agenda for the thirty-fourth session of the Commission

33. At its 7th meeting, on 30 March 2000, the Commission approved the draft provisional agenda for its thirty-fourth session contained in document E/CN.9/2000/L.2 (see chap. I, sect. A).

Chapter VII

Adoption of the report of the Commission on its thirty-third session

34. At the 7th meeting, on 30 March 2000, the Vice-Chairman-cum-Rapporteur introduced the draft report of the Commission on its thirty-third session (E/CN.9/2000/L.3).

35. At the same meeting, the Commission adopted the draft report and authorized the Rapporteur to finalize it in consultation with the Bureau by incorporating therein the proceedings of its final meeting.

Chapter VIII

Organization of the session

A. Opening and duration of the session

36. The Commission on Population and Development held its thirty-third session at United Nations Headquarters from 27 to 30 March 2000. The Commission held 7 meetings (1st to 7th).

37. The session was opened by the Chairman of the thirty-second session, Robert Cliquet (Belgium).

38. Opening statements were made by the Under-Secretary-General for Economic and Social Affairs of the United Nations Secretariat, the Executive Director of the United Nations Population Fund and the Director of the Population Division of the Department of Economic and Social Affairs of the United Nations Secretariat.

B. Attendance

39. The session was attended by 41 States members of the Commission. Observers for other States Members of the United Nations and for 2 non-member States also attended. Representatives of the specialized agencies, intergovernmental organizations and non-governmental organizations also attended. A list of participants is given in annex I to the present report.
