I. Introduction

The Secretary-General has the honour to submit to the General Assembly and to the Security Council the curricula vitae of the candidates nominated by the national groups for the election to fill a causal vacancy in the International Court of Justice caused by the resignation of Judge Mohammed Bedjaoui (Algeria). The names of the candidates have been circulated in document A/56/373-S/2001/882. The composition of the Court and the voting procedures to be followed in the General Assembly and in the Security Council are contained in a memorandum by the Secretary-General issued as document A/56/372-S/2001/881.
