Section 8

Legal affairs

(Programme 5 of the medium-term plan for the period 2002-2005)

Overview

- 8.1 The Office of Legal Affairs is responsible for the implementation of the work programme under this section. The programme is guided by the General Assembly and its subsidiary organs, namely the International Law Commission and the United Nations Commission on International Trade Law (UNCITRAL). Guidance is also given by the Meeting of States Parties to the United Nations Convention on the Law of the Sea.
- 8.2 The activities for which the Office of Legal Affairs is responsible fall within the framework of programme 5, Legal affairs, of the medium-term plan for the period 2002-2005 (A/55/6/Rev.1).
- 8.3 According to the medium-term plan, the general objective of programme 5 is to promote a better understanding of and respect for the principles and norms of international law by Member States in order to support the accomplishment of the objectives of the United Nations. To fulfil this objective, the Office of Legal Affairs provides a unified central legal service for the Secretariat and the principal and other organs of the United Nations; contributes to the progressive development and codification of international public and trade law; promotes the strengthening and development, as well as the effective implementation of the international legal order for the seas and oceans; registers and publishes treaties; and performs the depositary functions of the Secretary-General.
- 8.4 The budget proposal reflects a comprehensive internal review of all subprogrammes. The conclusion is that they should continue as foreseen in the medium-term plan. This conclusion is based on guidance received from the General Assembly, as well as on feedback from other entities with which the Office of Legal Affairs interacts. A significant feature in the budget proposal is the provision of a non-recurrent amount of \$701,600 to be distributed among the subprogrammes for the enhanced use of information technology. In the present environment, in which information technology is becoming increasingly integrated in the working methods of the Office of Legal Affairs, both as a matter of efficiency and as a means of handling and disseminating information, it has been determined that it is of critical importance to introduce information technology to manage the flow of information within the Office. In particular, there is a need to computerize the legal archive. In this connection, increased resources for all units of the Office will be used for purposes of analysis, development, and implementation of this project (\$561,600). An additional amount of \$140,000 would provide for the necessary equipment.
- 8.5 With respect to subprogramme 1, there is an increase in the provision for travel. This is based on the experience of the last several years, in which constant unforeseen travel had to be undertaken in order to deal with matters arising from resolutions of the Security Council relating to the maintenance of peace and security, as well as to the negotiation of international legal instruments with Member States and to ensuring respect for privileges and immunities. A General Service post is redeployed from the Treaty Section to support this subprogramme.
- 8.6 As regards subprogramme 2, the General Legal Division will aim to meet the continually growing demand throughout the Organization for legal advice, services and support with basically the same resources available for the biennium 2000-2001. A General Service post is redeployed from the Treaty Section to support this subprogramme.

- 8.7 With respect to subprogramme 3, the Codification Division will continue to act as secretariat for the Preparatory Commission for the International Criminal Court, pursuant to General Assembly resolution 53/105 of 8 December 1998, in addition to its other activities. The continuation of resources to expedite the preparation and publication of supplements to the *Repertory of Practice of United Nations Organs* has been included.
- 8.8 As regards subprogramme 4, there is a reclassification of one P-3 post to the P-4 level and an increase in the provision for consultants, travel and data processing. This is based on the anticipated receipt by the Commission on the Limits of the Continental Shelf of submissions from coastal States, the expanded agenda of the Meeting of States Parties to the United Nations Convention on the Law of the Sea and the servicing and follow-up requirements of the newly established consultative process on oceans and the law of the sea.
- 8.9 With respect to subprogramme 5, there is an increase in staff resources (1 new P-4 post) and travel funds. This is based on a request by the General Assembly to the Secretary-General that he ensure and enhance the effective implementation of the UNCITRAL programme (resolution 54/103); on the growing number of requests by Member States for legislative assistance and for training and briefings relating to texts prepared by UNCITRAL; and on the increased need for substantive coordination of activities of various intergovernmental and non-governmental agencies which, inside and outside the United Nations, are preparing legal texts governing international commerce. The success of UNCITRAL depends on its ability to meet the increasing demand in these two areas of its mandate.
- 8.10 With regard to subprogramme 6, the efforts to address the backlog in the Treaty Section are now bearing fruit. Resource requirements have thus decreased as a result of the substantial clearing of the backlog. The continuous upgrading of the working methods have also resulted in decreasing staff costs. Three General Service posts will be redeployed to other units within the Office of Legal Affairs (see paras. 8.5, 8.6 and 8.11). An increase in the provision for consultants would enable the Treaty Section to engage the expertise needed for converting the United Nations Treaty Collection onto the database which will serve as the platform for the Internet.
- 8.11 With respect to the secretariat of the United Nations Administrative Tribunal, one General Service post will be redeployed from the Treaty Section, in order to secure for it competent and continuous services.
- 8.12 As noted above, under subprogramme 3, sustained efforts will be made during the biennium to expedite, pursuant to General Assembly resolutions 52/162 of 15 December 1997, 53/106 of 8 December 1998, 54/106 of 9 December 1999, and 55/156 of 12 December 2000, the preparation and publication of supplements to the *Repertory of Practice of United Nations Organs*. The analytical summary of the practice of the principal organs pertaining to the 111 Articles of the Charter of the United Nations is the responsibility of several departments and offices in the Secretariat. The progress in this endeavour has been set out in reports of the Secretary-General, the most recent contained in document A/55/340. The publication of the supplement volumes, therefore, calls for and depends on timely completion of the respective tasks by all concerned. The Office of Legal Affairs itself prepares studies on some 25 Articles of the Charter. The preparation of the studies is distributed according to competence among the various units. The Office is charged with the task of reviewing for publication the draft studies prepared by other author departments and offices. The Office also chairs the Inter-departmental Committee on Charter Repertory to coordinate the Repertory-related tasks.
- 8.13 The overall level of resources for the Office of Legal Affairs for the biennium 2002–2003 amounts to \$33,894,900 before recosting, reflecting a growth of \$14,300 compared with the revised appropriation for the biennium 2000–2001. The overall level of resources, as indicated in table 8.2

below, reflects, inter alia, the establishment of one new Professional post at the P-4 level and the reclassification of one P-3 post to the P-4 level. It also includes growth related to the enhanced use of information technology in the Office of Legal Affairs, partially offset by reductions for external printing of the *Treaty Series*.

- 8.14 The estimated extrabudgetary resources, amounting to \$5,792,300, will be utilized for activities related to, inter alia, support to United Nations organizations, support to peacekeeping operations, symposia on international trade law, participation of least developed and developing countries in the work of the Preparatory Committee on the Establishment of an International Criminal Court and assistance in the teaching, study, dissemination and wider appreciation of international law.
- 8.15 The estimated percentage distribution of the resources of the programme in the biennium 2002–2003 is as shown in table 8.1.

A. Policy-making organs

1. International Law Commission

Resource requirements (before recosting): \$1,888,000

- 8.17 The International Law Commission was established by the General Assembly in its resolution 174 (II) of 21 November 1947. The Commission has as its objective the promotion of the progressive development of international law and its codification. It consists of 34 members who are persons of recognized competence in international law. Unless otherwise decided by the General Assembly, the Commission meets annually for one 12-week session in Geneva and reports to the Assembly, which provides guidance to the Commission on its programme of work. The Codification Division of the Office of Legal Affairs provides substantive servicing for the Commission.

- 8.18 The amount of \$1,888,000 covers non-post expenditure related to non-staff compensation, the travel of representatives, travel of staff, and contractual services. A decrease in non-post expenditure is attributed to changes in the length and nature of the Commission's sessions, as reflected in the report of the International Law Commission (A/55/10) which, in the initial part of the next quinquennium, will result in the holding of split sessions over a 10-week period, as opposed to its current 12-week sessions.

2. United Nations Commission on International Trade Law

Resource requirements (before recosting): \$300,500

- 8.19 UNCITRAL consists of 36 Member States and is charged by the General Assembly (resolution 2205 (XXI)) with the development of the progressive unification and harmonization of international trade law, which corresponds to subprogramme 5. The Commission carries out its tasks with the assistance of the International Trade Law Branch as its secretariat in one annual meeting of up to six weeks' duration, but usually lasting three or four weeks, and in working group meetings on specialized topics of up to a total of 12 weeks' duration per year.

8.20 The amount of \$300,500 would provide for the travel of representatives, travel of staff, and contractual services. An increase in resources is required for the production of the *Yearbook of the United Nations Commission on International Trade Law*.

3. United Nations Administrative Tribunal (including its secretariat)

Resource requirements (before recosting): \$1,402,600

- 8.21 The United Nations Administrative Tribunal is the independent organ competent to hear and pass judgement upon applications alleging non-observance of contracts of employment of staff members of the United Nations Secretariat or of their terms of appointment, as well as applications alleging non-observance of the regulations and rules of the United Nations Joint Staff Pension Fund, arising out of decisions taken by the Fund. The Tribunal was established by the General Assembly in its resolution 351 A (IV) of 24 November 1949. It is composed of seven members, no two of whom may be nationals of the same State, who are appointed by the Assembly initially for three years and may be reappointed. The competence of the Tribunal extends to the secretariats of the associated programmes that are financed from voluntary contributions, such as UNDP, UNICEF, UNFPA, UNHCR and UNRWA. Under article 13 of the statute, the competence of the Tribunal has also been extended to IMO, ICAO and to the staff of the Registry of the International Court of Justice.
- 8.22 The secretariat provides substantive, technical and administrative servicing of the sessions of the Tribunal, including legal research and analysis of precedents; preparation of draft summaries of facts and contentions of parties for judgements to be rendered by the Tribunal; analysis and research of documentation relevant to cases on appeal to the Tribunal; consultations with administrations of subsidiary organs of the United Nations, the secretariat of the Pension Fund, the administrations of the specialized agencies subject to the jurisdiction of the Tribunal (ICAO and IMO) and the Registry of the International Court of Justice; and conducting the external relations of the Tribunal, including its relations with the secretariat of ILO. During the biennium, the secretariat will also publish the recurrent publication *Judgements of the Administrative Tribunal*, volumes XVI and XVII, in English and French.

Subprogramme 1**Overall direction, management and coordination of legal advice and services provided to the United Nations as a whole**

Resource requirements (before recosting): \$3,518,200

- 8.24 The Office of the Legal Counsel is responsible for the implementation of the subprogramme and for the overall direction, supervision and management of all legal activities under this section. There are no significant changes to the nature of the work that is to be carried out under this subprogramme during the biennium 2002-2003, except for the overall supervision of the information management project. This project is aimed at managing the office's workflow and information requirements, provide an operational data retrieval system and establish a system for organizing and making available legal materials and information concerning international law in a manner that is useful to Member States, the legal community and the general public, as appropriate.

External factors

- 8.25 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that:
- (a) Principal and subsidiary organs, including the Secretariat, will seek legal advice on rules of procedure, adoption and implementation of resolutions and decisions for the conduct of their work;
 - (b) The principal and subsidiary organs and Secretariat units will seek to obtain legal advice concerning the legal regime of the Organization necessary to implement mandated programmes and activities.

Outputs

- 8.26 During the biennium 2002-2003, the following outputs will be delivered:
- (a) Servicing of intergovernmental/expert bodies
 - (i) General Assembly: provision of advice to the General Assembly, Main Committees Credentials Committee, and conferences on the Charter of the United Nations, resolutions, rules of procedure, status of members and observers, credentials and representation;
 - (ii) Committee on Relations with the Host Country: provision of substantive and secretariat services to the Committee and its working groups, including preparation of notes and statements for the Chairman, assistance to the bureau, analysis of legal issues and preparation of reports and documentation;
 - (iii) Economic and Social Council: provision of substantive and procedural advice to the Economic and Social Council, including functional and regional commissions, on the Charter of the United Nations, resolutions, rules of procedure, elections and consultative status of non-governmental organizations;
 - (iv) Security Council: provision of oral and written advice to the Security Council and its subsidiary organs on the interpretation and implementation of resolutions, provisional rules of procedure and statutes of ad hoc criminal tribunals;
 - (b) Other substantive activities. Promotion of legal instruments
 - (i) Formulation of statements of public international law and analysis of specific legal issues in response to enquiries from intergovernmental and regional organizations, international and academic institutions and the public;

- (ii) Negotiation of international agreements, constitutive instruments and others required for the conduct of mandates carried out by the United Nations and its subsidiary organs, including UNDP, UNICEF, UNFPA and UNOPS, and with Governments and intergovernmental organizations;
 - (iii) Promotion of and ensuring respect for Articles 104 and 105 of the Charter, the Convention on the Privileges and Immunities of the United Nations, the headquarters agreements with the United States of America and other host Governments;
 - (iv) Establishment of the necessary legal instruments, legal regimes and mandates for all peacekeeping operations and other missions, including status of forces agreements, status of mission agreements, agreements with contributing States and cooperation agreements with regional organizations;
 - (v) Provision of advice to operationally responsible Secretariat units, offices established away from Headquarters, peacekeeping and other missions and expert groups mandated to investigate matters related to international peace and security;
 - (vi) Implementation of specific tasks and preparation of reports or analyses of a legal nature requested by the Security Council or its subsidiary organs in the field of international peace and security; maintenance of liaison with the International Court of Justice and discharging the responsibilities of the Secretary-General under the Statute of the Court, including the preparation of legal statements and the transmission of notices relating to legal proceedings;
 - (vii) Settlement of disputes of a public international law character involving the Organization, including representation of the Secretary-General at judicial proceedings, including those of the International Court of Justice;
- (c) International cooperation, coordination and liaison
- (i) Representation of the Secretary-General and the Legal Counsel at meetings and conferences convened by the United Nations or sponsored by Governments, intergovernmental organizations and other international institutions;
 - (ii) Provision of advice on questions relating to interpretation and application of the Charter, legal agreements, United Nations resolutions and general questions of public international law to ensure uniform consistent practice of the law;
 - (iii) Provision of advice on legal questions concerning privileges and immunities and the status of the Organization, including UNDP, UNICEF, UNFPA and UNOPS, in territories of Member States and the relationship with States and intergovernmental organizations;
 - (iv) Coordination of interdepartmental activities, liaison with United Nations organs dealing with legal matters, offices established away from Headquarters, legal advisers or liaison officers assigned to field missions or other Secretariat units;
 - (v) Cooperation with and coordination of institutional arrangements for the specialized and related agencies and with other international and national organizations dealing with matters of common concern; representation at and convening of meetings with legal liaison officers and legal advisers of the United Nations system;
- (d) Technical cooperation
- (i) Advisory Services: assistance to States, including through the Trust Fund to Assist States in the Settlement of Disputes through the International Court of Justice, in

settling their legal disputes through the International Court of Justice, including application of the Statute, and reporting to the Secretary-General and the General Assembly;

- (ii) Training courses, seminars and workshops: presentation of papers and participation in meetings and conferences sponsored by United Nations organs, Governments, professional societies or international organizations on legal issues relating to the functions of the United Nations; provision of legal expertise and resource persons to training courses sponsored by Governments or international institutions for diplomats on subjects falling within the competence of the Office of the Legal Counsel.

- 8.27 The amount of \$3,518,200 provides for 15 posts, including the redeployment of one General Service (Other level) post from the Treaty Section to support the legal archive, and various non-post items. The increase for non-post items is primarily for the Office of the Legal Counsel's portion of the requirements for the development of information technology.

Subprogramme 2

General legal services provided to United Nations organs and programmes

Resource requirements (before recosting): \$4,612,000

- 8.28 The subprogramme will be implemented by the General Legal Division, which will continue to meet the demand from throughout the Organization for legal advice, services and support for the Organization's operations and activities. The Division also provides legal advice to UNDP, UNFPA, UNICEF and UNOPS. No significant changes to the nature of the Division's work are anticipated.

Objective: To protect the legal interests of the Organization. This would include assisting the Organization (Headquarters, regional commissions, other United Nations offices away from Headquarters and peacekeeping and other missions) and other United Nations funds and programmes and other entities in the day-to-day administration of their mandates and programmes, through the provision of legal services.

External factors

- 8.29 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that United Nations units will provide timely information, seek to obtain and be guided by legal advice concerning the legal rights and obligations of the Organization in respect of the day-to-day administration of their mandates and programmes.

Outputs

- 8.30 During the biennium 2002-2003, the following outputs will be delivered:

- (a) Substantive activities
- (i) Provision of advice on commercial aspects of peacekeeping and other missions, including:
 - a. Contracts and substantial procurement for logistical support;
 - b. Insurance;
 - c. Demining and similar operations;
 - d. Disposition of assets;
 - e. Air and sea charter arrangements;
 - (ii) Provision of advice on claims arising out of peacekeeping and other missions, including:
 - a. Assistance in resolving contractual and real property disputes;
 - b. Claims for property damage, personal injury and death;
 - (iii) Provision of advice and assistance on arbitration or litigation arising out of peacekeeping and other missions, including representation of the Organization before arbitral, judicial and other quasi-judicial and administrative bodies;
 - (iv) Provision of advice on the legislative aspects of peacekeeping and other missions, such as regulations and rules and the Field Administration Handbook governing staff serving in such missions;

- (b) International cooperation and inter-agency coordination and liaison
 - (i) Provision of advice on institutional and operational arrangements for peacekeeping and other missions and for development assistance, including formation and interpretation of agreements with Governments and international organizations concerning such arrangements;
 - (ii) Provision of advice on commercial aspects of development assistance, including:
 - a. Goods and services;
 - b. Establishment of field offices;
 - c. Management of loans by Governments and regional, international or other financial institutions;
 - (iii) Provision of advice on management of development and technical assistance, including:
 - a. Personnel and financial arrangements;

It will also continue to coordinate the preparation and publication of volumes of supplements to the *Repertory of Practice of United Nations Organs*.

Subprogramme 4 Law of the sea and ocean affairs

Resource requirements (before recosting): \$5,808,800

- 8.36 The subprogramme will be implemented by the Division for Ocean Affairs and the Law of the Sea. During the biennium 2002-2003 increased activities in terms of assistance requested by coastal States are expected with respect to the anticipated receipt by the Commission on the Limits of the Continental Shelf of submissions from coastal States. Furthermore the Division will be responding to requirements for additional servicing and follow-up of the newly established consultative process on oceans and the law of the sea, and with respect to the expanded agenda of the Meeting of States Parties to the United Nations Convention on the Law of the Sea.

- 8.39 An amount of \$5,808,800 provides for 27 existing posts, and various non-post items. The resource growth, including reclassification of one post from P-3 to P-4, is owing to increased activity. - 8.40 The subprogramme is implemented by the International Trade Law Branch, which acts as the secretariat of UNCITRAL. For the biennium 2002-2003, the activities of the Branch are expected to expand in the light of the growing number of requests from Member States for legislative assistance and for training and briefings relating to texts prepared by the Commission. The Branch will also respond to the increased demand for substantive coordination of activities of various intergovernmental and non-governmental agencies which are preparing legal texts governing international commerce.

Subprogramme 6

Custody, registration and publication of treaties

Resource requirements (before recosting): \$7,049,100

- 8.44 The subprogramme is implemented by the Treaty Section. Although the backlog of the Treaty Section has been reduced dramatically, there is still some delay in the translation process. Total elimination of the backlog is now expected in 2002. However, with the elimination of the printing backlog in 2001, the Treaty Series will be entirely produced in 2002 in the desktop publishing format, using the enhanced capabilities of the new database. The continuous upgrading of the working methods has resulted in decreasing staff costs, with the redeployment of three General Service (Other level) posts to other Divisions.

 - (b) Member States request legal and technical advice before (i) concluding treaties, in particular with reference to final clauses of treaties, which include provisions of entry into force; and (ii) before submitting treaties for registration to avoid delays and potential problems in their implementation.

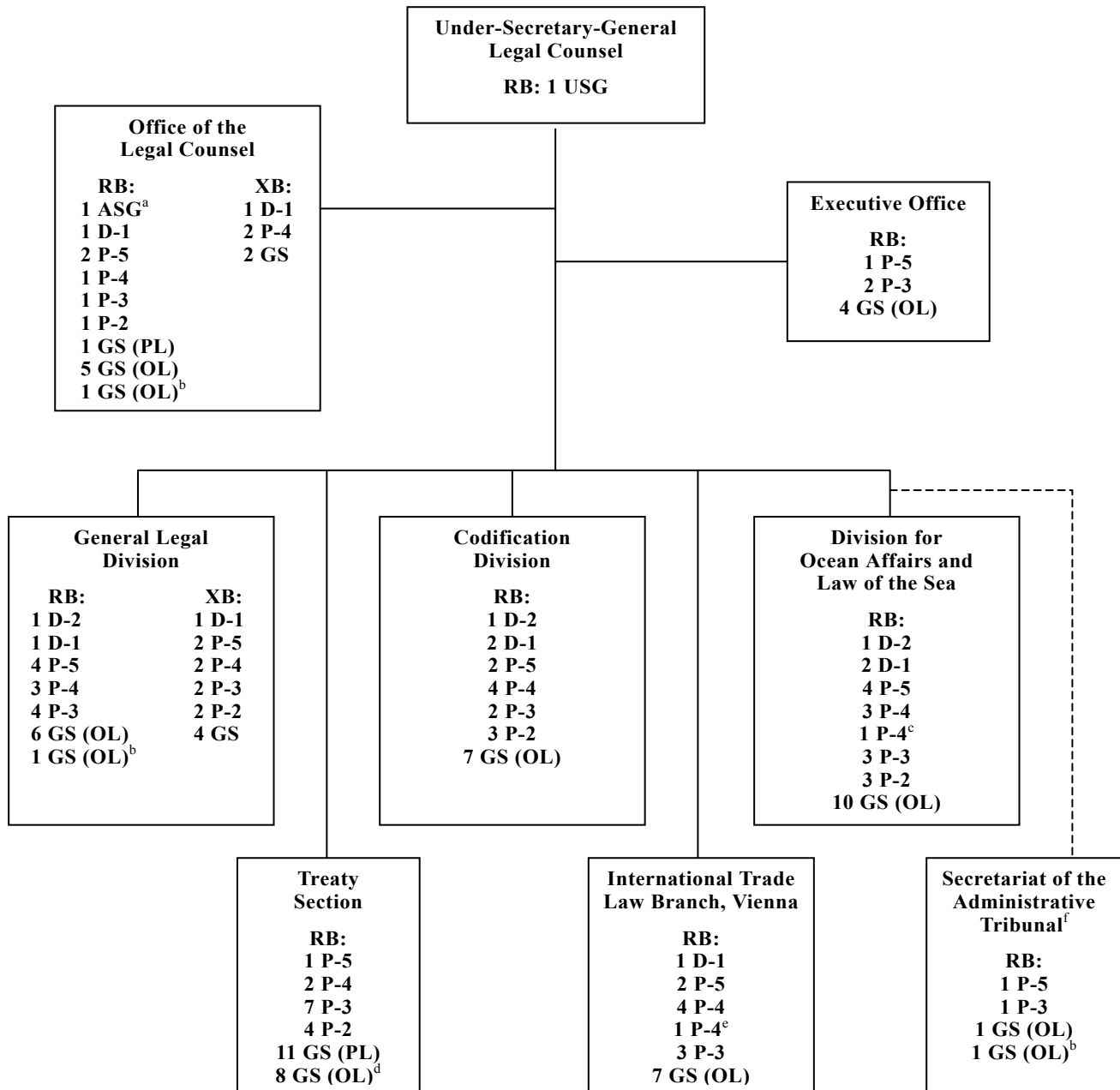

- A.8.17 The amount of \$3,070,700 provides for the continuation of eight posts in the Professional category and above and seven General Service posts, including one General Service (Other level) post redeployed from the Treaty Section to provide support to the legal archive.

Other staff costs

- A.8.18 The amount of \$4,000 covers the requirements for overtime inherent in providing support to the Under-Secretary-General.

Consultants and experts

- A.8.19 The provision of \$29,800 will enable the Office to respond to requests emanating from the intergovernmental process, such as commissions of investigation and inquiry requiring expertise not available in the Office.

Travel of staff

- A.8.20 The provision of \$196,100 reflecting a growth of \$34,300 based on 1999 and 2000 expenditure patterns, relates to travel of the Legal Counsel and other senior legal officers to deal with matters arising from resolutions of the Security Council relating to the maintenance of peace and security, as well as for the negotiation of international legal instruments with Member States.

Contractual services

A.8.21 The amount of \$130,800 provides for the portion of the Office of the Legal Counsel in engaging expertise related to the overall enhancement of information technology, with particular emphasis on the legal archive.

Hospitality

A.8.22 A provision of \$6,600 relates to the cost of official functions.

General operating expenses

A.8.23 The amount of \$24,100 provides for the maintenance costs of office automation equipment.

Furniture and equipment

A.8.24 A provision of \$56,100 is made for costs relating to acquisition and replacement of office automation equipment and computer software (\$36,100), and for specialized equipment related to the computerization of the legal archive (\$20,000).

Resource requirements (before recosting)*Posts*

- A.8.25 The amount of \$4,075,900 provides for the continuation of 13 posts in the Professional category and above and seven General Service posts, including the redeployment of one General Service post from the Treaty Section to handle the increased demand for support service in the Division.

Other staff costs

- A.8.26 Requirements of \$29,000 relate to the continuing need to retain the temporary services of additional lawyers during periods of peak workload, especially in cases of matters entrusted by the General Assembly or the Security Council to the Secretariat (\$20,800), and overtime (\$8,200).

Consultants and experts

- A.8.27 The resources required under this heading (\$37,000) relate to the cost of retaining the services of outside counsel for advice and assistance in matters requiring special expertise not available in the Secretariat, such as matters involving complex real estate and banking transactions, taxation questions, complex commercial claims and intellectual property matters, all of which require interpretation of national law or representation before national courts or administrative bodies, and for assistance in responding to unanticipated urgent matters.

Travel of staff

- A.8.28 The provision of \$11,800 provides for travel required to ensure: (a) provision of legal services and support to offices away from Headquarters for negotiation and preparation of contracts and other agreements; (b) representation of the Organization in legal proceedings; (c) provision of orientation to outside counsel in connection with the interpretation of relevant legal instruments, the resolution of disputes and the representation of the Organization; and (d) representation of the Secretary-General before the United Nations Administrative Tribunal at its sessions in Geneva.

Contractual services

- A.8.29 The amount of \$312,200, reflecting an increase of \$181,100, provides for the ongoing cost of subscriptions and usage fees in connection with the WESTLAW and LEXIS legal database services (\$181,400), which provide access to domestic and international legal materials and the judgements of the Administrative Tribunal, as well as other electronic data sources of legal information; and for the development of a computerized legal archive, as part of the overall enhanced use of information technology in the Office (\$130,800).

General operating expenses

- A.8.30 The amount of \$46,300 provides for the maintenance of office automation equipment in the Division.

Supplies and materials

- A.8.31 Resource requirements in the amount of \$6,100 are for office automation supplies and electronic publications.

Furniture and equipment

- A.8.32 The amount of \$93,700, reflecting an increase of \$25,000, provides for the acquisition of office automation equipment, the upgrading and replacement of electronic data-processing equipment required by the Division (\$73,700) and for specialized equipment related to the computerization of the legal archive (\$20,000).

- A.8.33 The amount of \$4,130,100 covers the cost of 14 continuing posts in the Professional category and above and seven General Service posts.

Other staff costs

- A.8.34 The provision of \$101,200, reflecting an increase of \$15,100, is required for general temporary assistance related to the preparation of, and reduction in the backlog of, the *Repertory of Practice of United Nations Organs* (\$76,100) and overtime incurred while servicing meetings of the Sixth Committee, the Preparatory Commission on the Establishment of an International Criminal Court and other committees (\$25,100).

Travel of staff

- A.8.35 The provision of \$20,700 relates to attendance by staff at meetings and conferences of United Nations organs and other bodies held away from Headquarters and meetings of regional bodies with which the International Law Commission has established formal links, including inter-sessional meetings organized by delegations of the Sixth Committee or subsidiary organs, in connection with such topics as the International Criminal Court and international terrorism, and meetings of the Asian-African Legal Consultative Committee.

Contractual services

- A.8.36 The amount of \$254,900, reflecting an increase of \$130,000, relates specifically to the integration of the work of the Division into the overall enhanced use of information technology in the Office (\$130,000), in particular the storage and retrieval of codification documentation in the legal archive, including the *Repertory of Practice of United Nations Organs*, the *Yearbook of the*

International Law Commission, and the *United Nations Juridical Yearbook*; and to the external printing costs of three volumes of the *United Nations Juridical Yearbook*, two volumes of the *Legislative Series*, one volume of the *United Nations Reports of International Arbitral Awards* and the supplements to the *Repertory of Practice of United Nations Organs* (\$124,900).

General operating expenses

- A.8.37 An amount of \$33,900 provides for the maintenance of office automation equipment.

Furniture and equipment

- A.8.38 The amount of \$52,900, reflecting an increase of \$27,800, provides for the acquisition of office automation equipment (\$32,900) and for equipment related to the computerization of materials to be included in the legal archive (\$20,000).

Grants and contributions

- A.8.39 The amount of \$371,000, provides for the cost of travel and stipends for approximately 46 fellowships (23 annually) to participants from developing countries and countries with economies in transition in connection with the United Nations/United Nations Institute for Training and Research fellowship programme in international law in Geneva.

- A.8.40 The amount of \$5,231,200 provides for 17 posts in the Professional category and above and 10 General Service posts, including the reclassification of one post from the P-3 to the P-4 level, in view of the additional responsibilities associated with the increased number of submissions from coastal States to the Commission on the Limits of the Continental Shelf and its subcommissions.

The added responsibilities include support for and follow-up to the meetings of the Commission and of the Meeting of States Parties to the United Nations Convention on the Law of the Sea, as well as cooperation with intergovernmental bodies, non-governmental organizations and law of the sea communities.

Other staff costs

- A.8.41 The amount of \$6,600, reflecting an increase of \$3,400, provides for overtime requirements related to servicing of Meetings of States Parties to the Convention, and the increased number of meetings related to the open-ended informal consultative process on oceans and the law of the sea.

Consultants and experts

- A.8.42 The amount of \$158,800, including an increase of \$33,100 because of, inter alia, the increased number of submissions from coastal States to the Commission on the Limits of the Continental Shelf, provides for specialized consultancy services not available in the Secretariat for preparation of material on specific topics related to technical aspects of the regime for the continental shelf and scientific aspects of the protection of the marine environment, as well as for preparation of data, information and management requirements for the effective implementation of the Convention, including sustainable development of oceans and seas and their resources (\$78,100); and for an ad hoc expert group meeting on assessment of the implementation of the Convention 20 years after its adoption (\$80,700).

Travel of staff

- A.8.43 The amount of \$109,000, reflecting an increase of \$12,000, relates to travel of staff to the meetings of organizations of the United Nations system and other organizations, and for consultations with regional, subregional and national agencies required in connection with the newly established consultative process on oceans and the law of the sea.

Contractual services

- A.8.44 The amount of \$140,200, reflecting an increase of \$93,200, provides for the Division's portion of the overall enhancement of information technology (\$50,000), the cost of the printing of recurrent and non-recurrent publications (\$12,100) and the subscription to databases in the field of law of the sea and ocean affairs (\$78,100).

General operating expenses

- A.8.45 The amount of \$44,400 provides for the maintenance of office automation equipment.

Supplies and materials

- A.8.46 The amount of \$26,400 provides for the cost of library books for the maintenance of the law of the sea reference collection. This collection is a central source of information for Member States, universities, legal practitioners and others.

Furniture and equipment

- A.8.47 The amount of \$92,200, reflecting an increase of \$26,800, provides for the cost of acquiring office automation equipment for the Division's portion of the enhancement of information technology (\$50,000) and the acquisition and replacement of automation equipment (\$42,200).

Resource requirements (before recosting)*Posts*

- A.8.48 The amount of \$2,491,400 provides for 11 posts in the Professional category and above and seven General Service posts. An increase in the amount of \$95,800 is attributable to one new post at the P-4 level that is required to strengthen the Branch for responding to the increasing number of requests from Member States, particularly developing States, for assistance in the use of UNCITRAL legal texts.

Other staff costs

- A.8.49 The amount of \$1,400 provides for overtime when servicing sessions of UNCITRAL and its working groups.

Consultants and experts

- A.8.50 The amount of \$105,500 provides for specialized consultancy services not available in the Secretariat to prepare studies relating to the three major topics dealt with by UNCITRAL namely: international contract practices, electronic commerce and settlement of commercial disputes (\$37,000), and the convening of six ad hoc expert group meetings proposed on the following topics: international contract practices; electronic commerce; and arbitration (\$68,500).

Travel of staff

- A.8.51 The amount of \$89,000, reflecting an increase of \$20,000, provides for attendance at meetings to implement the role of UNCITRAL as the core legal body in the coordination of the work of other organizations in the field of international trade law; attendance at meetings for the promotion of the adoption of UNCITRAL texts; and for responding to requests by Member States for legislative assistance.

Contractual services

A.8.52 The amount of \$50,000 provides for the Branch's portion of the overall enhancement of information technology in the Office of Legal Affairs.

General operating expenses

A.8.53 The amount of \$53,100 reflecting an increase of \$10,900 provides for the maintenance of office automation equipment.

Supplies and materials

A.8.54 The amount of \$95,400 provides for the acquisition of library books, including legal publications and updates for the UNCITRAL Library. The principle function of the Library is to provide the UNCITRAL secretariat and Government representatives with legal books, journals and updates in the fields of comparative law and different national legal systems. In addition, library services are made available to visiting officials, staff of the Vienna-based organizations, academics and scholars who are referred to the library for information or consultation on available publications.

Furniture and equipment

A.8.55 The amount of \$23,300 provides for the cost of replacing personal computers, one laserjet network printer and one scanner, as well as the cost of purchasing software.

Resource requirements (before recosting)*Posts*

- A.8.56 The amount of \$5,350,900 provides for the continuation of 14 posts in the Professional category and above and 19 General Service posts. There has been a decrease in requirements for support staff, owing to the successful implementation of new working methods in the Section, as a result of which three General Service posts will be redeployed to other divisions.

Other staff costs

- A.8.57 The amount of \$6,500, reflecting a reduction of \$60,700 for temporary assistance previously required for work related to the backlog in the *United Nations Treaty Series*, provides for overtime.

Consultants and experts

- A.8.58 The amount of \$116,100, reflecting an increase of \$73,800, provides for consultancy services in connection with the conversion of the United Nations Treaty Collection onto the database that will serve as the platform for the Internet.

Contractual services

- A.8.59 The amount of \$1,299,200, reflecting a decrease of \$1,042,700 in external printing costs for the backlog, would bring the *United Nations Treaty Series* up to date during the biennium. It provides for the external printing costs (\$1,091,800) of 300 volumes of the *United Nations Treaty Series*, 12 volumes of the *United Nations Treaty Series Cumulative Index*, external binding of 2 volumes of the *Multilateral Treaties Deposited with the Secretary-General* and for acquisition of software and hardware; rental of software necessary to run the program for the United Nations Treaty Collection on the Internet (\$137,400); and for an amount of \$70,000 for the Section's portion of the overall enhancement of information technology in the Office of Legal Affairs.

General operating expenses

A.8.60 The amount of \$115,100, provides for (a) the Section's share of the maintenance and support of the LAN technical infrastructure (including central servers) necessary for the support of central management services, such as electronic mail and UNIX for IMIS (\$52,300); and (b) maintenance of office automation equipment, including personal computers, two servers, one optical disk jukebox and one scanner that have been acquired (\$62,800).

Furniture and equipment

A.8.61 The amount of \$161,300, reflecting an increase of \$98,800, provides for the acquisition and replacement of office automation equipment and software necessary to run the United Nations Treaty Information System/LAN workflow system (\$131,300) and for the purchase of the Section's portion of the equipment specific to the overall enhancement of information technology in the Office of Legal Affairs (\$30,000).

Posts

A.8.62 The amount of \$1,124,900 provides for the continuation of three Professional posts and four General Service posts.

Other staff costs

A.8.63 The amount of \$118,800, reflecting an increase of \$22,600 on the basis of expenditure patterns, provides for the temporary replacement of staff on extended sick leave or maternity leave and for additional staff during periods of peak workload (\$112,800); and for overtime during periods of peak workload and unforeseen emergencies, as well as coverage of meetings (\$6,000).

General operating expenses

A.8.64 The amount of \$128,100 provides for electronic mail, long distance telephone and facsimile charges and other communications requirements of the Office of Legal Affairs (\$118,500), as well as for maintenance of office automation equipment of the Executive Office (\$9,600).

Supplies and materials

A.8.65 The amount of \$56,400 would provide for expendable office supplies and materials, for the Office of Legal Affairs as a whole.

Furniture and equipment

A.8.66 The amount of \$13,700 would provide for the purchase of new electronic data-processing equipment and the replacement of office automation equipment for the Executive Office.
