# **International cooperation for development**

### **Section 9**

#### **Economic and social affairs**

**(Programme 7 of the medium-term plan for the period 2002-2005)**

#### **Overview**

- 9.1 The programme of work under this section falls within the framework of programme 7 of the medium-term plan for the period 2002-2005 (A/55/6/Rev.1) and will be implemented by the Department of Economic and Social Affairs.
- 9.2 The overall orientation of the programme is to strengthen international economic and social cooperation and to promote development in a comprehensive, inclusive and far-sighted manner. The powerful tide of forces in a rapidly globalizing world is having a profound impact on development and on the need to strengthen multilateralism. The opportunities, challenges and risks call for deeper analysis, the building of international consensus and the strengthening of operational support. The Department's work in those three areas is mutually supportive and enriching. The programme will continue to pay particular attention to the overall objective of promoting sustainable development, in particular to eradicate poverty and to address the special needs of Africa, the least developed countries, the landlocked and transit developing countries and the small island developing States, as well as to promote South-South cooperation. The programme will be further guided by the need to empower women through gender mainstreaming, advocacy and the design of policies to achieve relevant targets.
- 9.3 The activities to be carried out by the Department reflect the responsibility of the Secretariat for providing substantive support to the General Assembly, in particular the Second and Third Committees, the Economic and Social Council and relevant subsidiary bodies, pursuant to their resolutions and decisions on international economic cooperation.
- 9.4 The major focus of the programme of work in the biennium 2002-2003 will be on promoting the implementation, monitoring and review of agreed plans, strategies, programmes or platforms for action, including the outcome of United Nations conferences and special sessions, in particular the High-Level International Intergovernmental Event on Financing for Development and the conferences to be held in 2002, namely the World Summit on Sustainable Development and the Second World Assembly on Ageing.
- 9.5 As part of its analytical work, the Department will monitor, analyse and evaluate global economic and social policies and trends, including population trends; make projections and identify new and emerging issues requiring the attention of the international community; monitor the advancement and empowerment of women; analyse the role of the State and the public sector in development; and compile and disseminate analytical statistical data and economic and social indicators with a view to facilitating the formulation and monitoring of development strategies and goals at the international, regional and national levels.
- 9.6 The Department's policy advisory services, supplemented by research and training, will support the efforts of Governments, at their request and in accordance with their national policies, to formulate development strategies and build national capacities aimed at the promotion of sustained economic growth and sustainable development in accordance with the relevant resolutions of the General Assembly and recent United Nations conferences.

- 9.7 In implementing the programme, the Department will also aim at strengthening linkages between the United Nations and civil society and at developing innovative means of cooperation and modes of partnership in areas of common interest, including through the appropriate use of panels and round tables and through encouraging dialogue.
- 9.8 The Department will also continue to assist the Secretary-General in enhancing policy coherence in the management of the economic and social activities of the United Nations and in promoting policy and programme coordination among organizations of the United Nations system. Thus, the Department will provide support to the Under-Secretary-General for Economic and Social Affairs in his or her role as convenor of the Executive Committee on Economic and Social Affairs, comprising, in addition to the Department, UNCTAD, UNEP, the regional commissions and some United Nations research institutes, and as programme manager of the Development Account.
- 9.9 The overall resources proposed under this section amount to \$112,973,800, including resource growth of \$542,000 (0.4 per cent). The changes reflected in table 9.2 are summarized as follows:
- (a) An increase of \$223,900 under policy-making organs for: additional requirements for travel of the members of the Statistical Commission (\$25,000) and the members of the Committee on the Elimination of Discrimination against Women (\$81,300), and one-time provisions in 2002-2003 in connection with the preparation and servicing of the Second World Assembly on Ageing (\$263,900) and the World Summit on Sustainable Development (\$757,300), offset by decreases of one-time provisions in the biennium 2000-2001 (\$903,600);
  - (b) An increase of \$50,200 under executive direction and management for additional requirements for specialized expertise not available in the Secretariat;
  - (c) An increase of \$287,900 under programme of work resulting from: (i) post requirements with respect to the establishment of one new P-4, one new P-2 and one new General Service (Other level) post to undertake various tasks related to the outcome of the twenty-third special session of the General Assembly, entitled "Women 2000: gender equality, development and peace for the twenty-first century", and activities resulting from the entry into force of the Optional Protocol of the Convention on the Elimination of All Forms of Discrimination against Women (subprogramme 2); the establishment of two new P-2 posts associated with activities related to sustainable development and energy issues (subprogramme 4); the establishment of three new P-2 posts to carry out various statistical functions, including methodological development work (subprogramme 5); the establishment of one new P-2 post to strengthen the programme of work on globalization and integration (subprogramme 7); the full biennial provision for two temporary posts (1 P-4 and 1 General Service (Other level) approved for 2001 for the Non-Governmental Organizations Section, the reclassification of one P-4 post to the P-5 level and a concurrent downward reclassification of one P-4 post to the P-3 level for the NGOs Section (subprogramme 1); and the abolition of six posts (\$490,200); and (ii) additional non-post requirements for general temporary assistance (\$120,000), consultants (\$155,700) and experts (\$231,500), and other contractual services (\$124,400) under various subprogrammes, offset by reductions for external printing (\$33,500), a small decrease for acquisition of office automation equipment (\$400) and a one-time advance to INSTRAW in 2001 (\$800,000);
  - (d) A reduction of \$20,000 under programme support related to a net decrease under posts for the establishment of two new P-2 posts to support the expansion and further development of the Integrated Meeting and Documentation Information System, offset by the abolition of two General Service (Other level) posts (\$53,800), and additional requirements for general temporary assistance during peak workload periods (\$15,000), contractual services for the enhancement of IMDIS (\$3,800) and supplies (\$15,000).

- 9.10 During the biennium 2002-2003, expected extrabudgetary resources amounting to \$117,712,000, or 49.3 per cent of the total resources available to the programme, will supplement resources from the regular budget to finance various activities such as technical advisory services, training, field projects and workshops. There is a substantial decrease in the anticipated level of extrabudgetary resources owing to the reduced level of funding from the traditional funding agencies (UNDP and UNFPA) for country project activities, the reduced level of involvement by the Department in the execution of a large electricity network rehabilitation project and decreased response to requests for bilateral and multilateral donor funding for technical cooperation activities, except in the area of public administration (subprogramme 8), where there is an expected increase due to commitments that have been made to the Department.
- 9.11 The percentage distribution of resources to be made available to the Department in the biennium 2002-2003 will be as shown in table 9.1.

- 9.13 Provision is made under this subsection for requirements related to standing intergovernmental organs and expert bodies, special sessions of the General Assembly and intergovernmental processes the servicing of which is the responsibility of the Department of Economic and Social Affairs and which are deemed to require specific provisions.
- 9.14 The amount of \$4,258,600 for policy-making organs provides for travel of representatives, members and experts; payment of honorariums to the 23 members of the Committee on the Elimination of Discrimination against Women; one-time provisions in 2002-2003 for general temporary assistance, consultants and experts, travel, external printing, hospitality and miscellaneous services in connection with the preparation for and servicing of the Second World Assembly on Ageing and the World Summit on Sustainable Development.

## **1. Standing intergovernmental organs and expert bodies**

### **Statistical Commission**

#### ***Resource requirements (before recosting): \$86,600***

- 9.15 The Statistical Commission was established by the Economic and Social Council in its resolution 8 (I) of 16 and 18 February 1946. Its terms of reference, as set out in Council resolutions 8 (I), 8 (II) of 21 June 1946 and 1566 (L) of 3 May 1971, are to assist the Council in: (a) promoting the development of national statistics and the improvement of their comparability; (b) coordinating the statistical work of the specialized agencies; (c) developing the central statistical services of the Secretariat; (d) advising the organs of the United Nations on general questions relating to the collection, interpretation and dissemination of statistical information; and (e) promoting the improvement of statistical methods in general.
- 9.16 Bearing in mind General Assembly resolution 50/227 of 24 May 1996 on the restructuring and revitalization of the United Nations in the economic, social and related fields and the need to provide for more continuity in the Commission's decision-making and oversight of the global statistical process, and with the aim of enabling the Commission to follow-up on the statistical implications of the major United Nations conferences and summits as well as the agreed conclusions of the high-level coordination segments of Economic and Social Council meetings, the Council, in its resolution 1999/8 of 26 July 1999, decided that the Statistical Commission should meet annually for a period of four working days in New York, beginning in 2000. The Council also decided that the Working Group on International Statistical Programmes and Coordination, established in its resolution 1306 (XLIV) of 31 May 1968, should cease to function.
- 9.17 The thirty-third and thirty-fourth sessions of the Statistical Commission are scheduled to be held in 2002 and 2003 respectively.

### **Commission on Population and Development**

#### ***Resource requirements (before recosting): \$99,500***

- 9.18 The Population Commission was established by the Economic and Social Council in its resolution 3 (III) of 3 October 1946. Its terms of reference were initially set out in Council resolution 150 (VII) of 10 August 1948. Following the International Conference on Population and Development and its adoption of the Programme of Action, the General Assembly, in its resolution 49/128 of 19 December 1994, renamed the Population Commission the Commission on Population and Development, decided that it should meet on an annual basis and revised its terms of reference. The mandate of the Commission was further revised by the Assembly in its resolution 50/124 of 20

December 1995. The membership of the Commission was increased from 27 to 47, with each member elected for a four-year term (Council decision 1995/320 of 12 December 1995). The Commission normally meets annually for a period of five working days.

- 9.19 The revised mandate of the Commission includes: (a) arranging for studies and advising the Economic and Social Council on population issues and trends, the integration of population and development strategies, population and related development policies and programmes and the provision of population assistance, as well as addressing any population and development questions on which either the principal or the subsidiary organs of the United Nations or the specialized agencies may seek advice; (b) monitoring, reviewing and assessing the implementation of the Programme of Action of the International Conference on Population and Development at the national, regional and international levels, identifying reasons for success and failure and advising the Council thereon; and (c) reviewing the findings of research and analysis pertaining to the interrelationship between population and development at the national, regional and international levels and advising the Council thereon.

### **Commission for Social Development**

#### ***Resource requirements (before recosting): \$166,000***

- 9.20 The Social Commission was established as a functional commission of the Economic and Social Council by Council resolution 10 (II) of 21 June 1946. As a result of a comprehensive reappraisal of the role of the Commission, the Council, in its resolution 1139 (XLI) of 29 July 1966, renamed it the Commission for Social Development to clarify its role as a preparatory body of the Council for the entire range of social development policy. Following the convening of the World Summit for Social Development in 1995, the Council, by its resolution 1995/60 of 28 July 1995, decided that the Commission should review, on a periodic basis, issues related to the follow-up and implementation of the Copenhagen Declaration on Social Development and the Programme of Action adopted by the Summit. The Council also decided that the Commission should review its mandate, terms of reference and scope of work in order to develop its multi-year programme of work and should review the frequency of its meetings in the light of its responsibility for the follow-up to and review of the implementation of the Summit. By its resolution 1996/7 of 22 July 1996, the Council decided to expand the membership of the Commission from 32 to 46 and to meet in annual sessions of eight working days. The Council also decided to invite experts to participate in the meetings of the Commission when priority subjects addressed in the Copenhagen Declaration and Programme of Action were under discussion. The fortieth and forty-first sessions of the Commission for Social Development are scheduled for 2002 and 2003 respectively.
- 9.21 In its resolution 54/24 of 10 November 1999, the General Assembly requested the Commission for Social Development, at its thirty-eighth session, to consider a long-term strategy on ageing in the context of a society for all ages. In that connection, the Commission decided to establish an in-session open-ended working group during its thirty-ninth and fortieth sessions, in 2001 and 2002, devoted to revising the International Plan of Action on Ageing and the development of a long-term strategy on ageing for presentation to the Second World Assembly on Ageing, to be held in 2002. By its resolution 54/262 of 25 May 2000, the Assembly decided that the Commission should serve as the preparatory committee for the Second World Assembly on Ageing.

**Commission on the Status of Women*****Resource requirements (before recosting): \$193,700***

- 9.22 The Commission on the Status of Women was established as a functional commission of the Economic and Social Council by Council resolution 11 (II) of 21 June 1946. Originally 15, the membership was increased to 18 in 1951, to 21 in 1961 and to 32 in 1966. By its resolution 1989/45 of 24 May 1989, the Council decided to enlarge the membership to 45 in 1990. The Commission reports to the Council on matters concerning the promotion of women's rights in the political, economic, social and educational fields and makes recommendations to the Council on problems requiring immediate attention in the field of women's rights. It meets annually in New York for 10 working days. Its sessions bring together observers from both within and outside the United Nations system.
- 9.23 The Commission has a central role within the United Nations system in monitoring the implementation of the Beijing Declaration and the Platform for Action and in advising the Council thereon in accordance with its strengthened mandate. In its resolution 1996/6 of 22 July 1996, the Council gave the Commission a catalytic role in mainstreaming the gender perspective in policies and programmes and confirmed its existing mandates. In accordance with General Assembly resolution 52/100 of 12 December 1997, the Commission served as the Preparatory Committee for the review and appraisal of the Platform for Action and was open-ended. Its forty-fourth session, in 2000, was extended by five days. The twenty-third special session of the General Assembly, entitled "Women 2000: gender equality, development and peace for the twenty-first century", was held from 5 to 9 June 2000.
- 9.24 In line with Economic and Social Council resolution 1995/29 of 24 July 1995, the Commission established an open-ended working group responsible for drafting an optional protocol to the Convention on the Elimination of All Forms of Discrimination against Women, which meets in parallel with the Commission. The Optional Protocol was adopted by the General Assembly in its resolution 54/4 of 6 October 1999 and entered into force on 22 December 2000.

**Commission on Sustainable Development*****Resource requirements (before recosting): \$763,800***

- 9.25 The Commission on Sustainable Development was established as a functional commission of the Economic and Social Council by Council decision 1993/207 of 12 February 1993. Its functions are set out in General Assembly resolution 47/191 of 22 December 1992. The Commission is composed of 53 members elected for a term of office of three years, meets annually for a period of two to three weeks and receives substantive and technical services from the Department. The Commission reports to the Council and provides recommendations to the Assembly through the Council. The Commission has a practice of establishing two ad hoc open-ended inter-sessional working groups that meet once a year for a period of one working week to deal with issues determined by the Commission.
- 9.26 The General Assembly, in its resolution 53/188 of 15 December 1998, stressed the importance of high-quality preparations for the 10-year review, in 2002, of Agenda 21 and the Programme for the Further Implementation of Agenda 21. In its resolution 54/218 of 22 December 1999, the Assembly called upon the Commission on Sustainable Development to continue to undertake the tasks related to the 10-year review of the implementation of the outcome of the United Nations Conference on Environment and Development and to address the challenges and constraints in the implementation of the commitments of the Conference. By its resolution 55/199 of 20 December 2000, the Assembly decided that the Commission on Sustainable Development at its tenth session

should meet as an open-ended Preparatory Committee that would provide for the full and effective participation of all States Members of the United Nations and members of the specialized agencies, as well as other participants in the Commission on Sustainable Development. In the same resolution, the Assembly further decided that the Commission, acting as the Preparatory Committee, should: (a) undertake the comprehensive review and assessment of the implementation of Agenda 21 and the other results of the United Nations Conference on Environment and Development; (b) hold three additional sessions, the first and second, to be held in January and March 2002 respectively; and (c) organize the third and final session of the Preparatory Committee at the ministerial level in May 2002 in Indonesia.

### **Committee for Development Policy**

#### ***Resource requirements (before recosting): \$308,600***

- 9.27 The Economic and Social Council, in annex I to its resolution 1998/46 of 31 July 1998, renamed the Committee for Development Planning, functioning in accordance with Council resolutions 1035 (XXXVII) of 15 August 1964 and 1079 (XXXIX) of 28 July 1965 and decision 1995/215 of 10 February 1995, as the Committee for Development Policy and reconfirmed its status as a subsidiary body of the Council. In accordance with Council resolution 1998/46, the Committee is composed of 24 independent experts with expertise drawn from the fields of economic development, social development and environmental protection and who reflect adequate geographical and gender balance. Its membership includes experts who are able to make a contribution on emerging issues and the multilateral process. The experts are nominated by the Secretary-General following consultation with interested Governments and are approved by the Council. The term of office of each member is three years. The Committee is called upon to undertake a triennial review of the status of least developed countries and to meet on that issue once every three years. The Council decides on the work programme of the Committee. The Committee's annual session is for five working days, and it submits its report to the Council at its substantive session in July. The report includes the Committee's proposals to the Council concerning its work programme for the following year for consideration and approval. The General Assembly, the Secretary-General and the subsidiary bodies of the Economic and Social Council may propose, through the Council, issues for consideration by the Committee. Information on the Committee's work is disseminated, inter alia, through an Internet web site and through a presentation by its Bureau following the outcome of its deliberations. In undertaking its responsibilities, the Committee, in addition to holding formal meetings, also explores the scope for effective preparations of its deliberations through informal networking arrangements, with assistance provided by the Secretariat. With respect to the submission of its report to the Council, the Committee has decided that its Chairman or a designated member should attend the session of the Council to introduce the report and respond to any queries raised.

### **Committee on Energy and Natural Resources for Development**

#### ***Resource requirements (before recosting): \$173,700***

- 9.28 The Committee on Natural Resources, a subsidiary organ of the Economic and Social Council whose terms of reference are defined in the annex to General Assembly resolution 46/235 of 13 April 1992, and the Committee on New and Renewable Sources of Energy and on Energy for Development, established by the Council in its decision 1992/218 of 30 April 1992, whose terms of reference are set out in General Assembly resolution 46/235, were merged into a single expert body named the Committee on Energy and Natural Resources for Development by the Council in its resolution 1998/46. The Committee is composed of two subgroups of 12 experts nominated by

Governments and approved by the Council for a term of four years. One subgroup deals with issues relating to energy, and the other with issues relating to water resources. The Committee meets biennially for two weeks.

#### **Committee on the Elimination of Discrimination against Women**

##### ***Resource requirements (before recosting): \$1,024,800***

- 9.29 The Committee on the Elimination of Discrimination against Women was established in accordance with the Convention on the Elimination of All Forms of Discrimination against Women, adopted by the General Assembly in its resolution 34/180 of 18 December 1979. It reviews reports of States parties submitted in accordance with article 18 of the Convention and formulates suggestions and general recommendations. The Committee reports annually through the Economic and Social Council to the Assembly. As from 1997, the 23-member committee holds two regular annual sessions in New York of 15 working days each, preceded by a five-day pre-session working group. The Committee is mandated under the Optional Protocol to the Convention to receive and consider communications from individuals or groups of individuals and to transmit its views with respect to such communications to the parties concerned. It is also empowered under the Optional Protocol to conduct inquiries into grave or systematic violations of the Convention in States parties.
- 9.30 In order to meet the additional responsibilities related to the Optional Protocol, a Working Group of the Committee will meet prior to each session in order to determine the admissibility of communications and make the necessary recommendations on the merits. The Working Group will comprise five members of the Committee, who will meet for a period of 5 working days after each session for a total of 10 working days annually. The Working Group will then submit its report to the Committee at its next session. The same level of conference servicing provided to the Committee will be required for the five-day session of the Working Group.
- 9.31 With respect to the inquiry procedure established by the Optional Protocol it is expected that the Committee will undertake three missions of inquiry annually for a period of two weeks for each mission. Each mission will consist of three members of the Committee for on-site visits for two weeks, for a total of six visits per biennium. The members will be assisted on those missions by staff members of the Secretariat.

#### **Meeting of Experts on the United Nations Programme in Public Administration and Finance**

##### ***Resource requirements (before recosting): \$156,100***

- 9.32 By its resolution 1199 (XLII) of 24 May 1967, the Economic and Social Council decided that the United Nations programme in public administration should be reviewed from time to time by a meeting of experts and that the report of the meeting should be submitted to it for consideration. Some 20 to 25 experts are invited by the Secretary-General in their individual capacity to participate in the Meeting of Experts on the United Nations Programme in Public Administration and Finance. The sixteenth meeting will be held in the first quarter of 2002 (Council decision 2000/231).

**Ad Hoc Group of Experts on International Cooperation in Tax Matters*****Resource requirements (before recosting): \$144,700***

- 9.33 The Ad Hoc Group of Experts on International Cooperation in Tax Matters was set up in accordance with Economic and Social Council resolution 1273 (XLIII) of 4 August 1967 and consists of 25 tax experts (10 from developed and 15 from developing countries) nominated by their Governments but acting in their personal capacity.
- 9.34 The Group reports to the Economic and Social Council and holds biennial sessions at Geneva for 10 days. The Group will hold its eleventh meeting in 2003. Its sessions are devoted to the conclusion of tax treaties between developed and developing countries that would be acceptable to both parties and that would fully safeguard their respective revenue interests.

**United Nations Forum on Forests*****Resource requirements (before recosting): \$119,900***

- 9.35 By its resolution 2000/35 of 18 October 2000, the Economic and Social Council established an intergovernmental body called the United Nations Forum on Forests to serve as a permanent policy and political forum. It further decided that the Forum should be established as a subsidiary body of the Council composed of all States Members of the United Nations and members of the specialized agencies and that it would operate under the rules of procedure of the functional commissions of the Council. In addition, the Council decided that the Forum would initially meet annually, that it could recommend the convening of ad hoc expert groups and that it would have high-level ministerial segments and multi-stakeholder policy dialogues similar to those in the Commission on Sustainable Development, the Intergovernmental Panel on Forests and the Intergovernmental Forum on Forests. The international arrangement on forests would also include a collaborative partnership on forests, built on the current Inter-Agency Task Force on Forests, which consists of eight international organizations, to support the work of the Forum and to enhance cooperation and coordination among its members. A compact secretariat composed of highly qualified experts is to be established to service the Forum and to support the collaborative partnership on forests.
- 9.36 In the same resolution, the Council also decided that the United Nations Forum on Forests would hold an organizational meeting for the purpose of electing its officers, determining the duration of their terms of office and considering all proposals on and options for the location of its secretariat, in conjunction with informal consultations regarding its draft multi-year programme of work. The first substantive session of the Forum is planned in mid-2001 in order, inter alia, to adopt its multi-year programme of work, to develop a plan of action for the implementation of the proposals for action of the Intergovernmental Panel on Forests/Intergovernmental Forum on Forests and to initiate its work with the collaborative partnership on forests.

**2. Special sessions and intergovernmental processes launched by the General Assembly****Follow-up to the International Year of Older Persons: Second World Assembly on Ageing*****Resource requirements (before recosting): \$263,900***

- 9.37 By its resolution 54/262 of 25 May 2000, the General Assembly decided to convene a Second World Assembly on Ageing in 2002 devoted to the overall review of the outcome of the first such

assembly and to the adoption of a revised plan of action and a long-term strategy on ageing, encompassing its periodic reviews, in the context of a society for all ages.

- 9.38 The General Assembly further decided, in its resolution 55/58, that the Second World Assembly on Ageing should be held in Madrid from 8 to 12 April 2002.

### **World Summit on Sustainable Development**

#### ***Resource requirements (before recosting): \$757,300***

- 9.39 In its resolution 55/199 of 20 December 2000, the General Assembly decided to organize the 10-year review of progress achieved in the implementation of the outcome of the United Nations Conference on Environment and Development in 2002 at the summit level and to call it the World Summit on Sustainable Development. By the same resolution, it accepted the generous offer of the Government of South Africa to host the Summit.

## **B. Executive direction and management**

#### ***Resource requirements (before recosting): \$4,412,600***

- 9.40 The Under-Secretary-General for Economic and Social Affairs is responsible for the overall direction, supervision and management of the Department in the implementation of its mandates and approved programme of work. The Under-Secretary-General also serves as convenor of the Executive Committee on Economic and Social Affairs. The Under-Secretary-General is assisted by the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs and the Assistant Secretary-General and Special Adviser to the Secretary-General on Gender Issues and Advancement of Women. The staffing requirements of the Office of the Special Adviser are reflected under subprogramme 2, Gender issues and advancement of women. The Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs will assist the Under-Secretary-General by providing senior substantive support to the Economic and Social Council and by overseeing the overall coordination of technical cooperation activities. He also serves as Secretary of the Administrative Committee on Coordination and, in that capacity, reports directly to the Secretary-General. A main focus of the Assistant Secretary-General's function is strengthening the interaction between the Economic and Social Council and ACC. The senior management of the Department will ensure the effective integration of capacities for normative, analytical and technical cooperation work to maximize complementarity and synergy within the organizational units of the Department.
- 9.41 The Office of the Under-Secretary-General will provide support and advice to the Under-Secretary-General and, as appropriate, to the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs on the planning, coordination, management and assessment of the work programme of the Department.

#### **Inter-agency affairs**

- 9.42 The main goal of the Office for Inter-Agency Affairs is to contribute to the overall strengthening of system cooperation and coordination. In order to achieve that goal, the Office provides the substantive support capacity required by the Administrative Committee on Coordination to pursue a policy-oriented, forward-looking and topical agenda, responsive to the requirements of intergovernmental bodies. In doing so, it draws more systematically on the work of all organizations of the system and the ACC subsidiary machinery so as to ensure that the Committee's decisions are relevant to and have an impact on their programmes and operational

concerns and that the total capacity of the system is effectively mobilized to support intergovernmental decision-making and to promote comprehensive follow-up to central intergovernmental policy. The Office for Inter-Agency Affairs is essentially staffed through secondments from member organizations.

- 9.43 The Office also supports the strengthening of the consultative process between the Secretary-General and members of the Administrative Committee on Coordination, helps to enhance information flows and promotes a continuous and timely dialogue among executive heads, particularly when new policy initiatives are being contemplated or when comprehensive and complementary responses to different aspects of major international developments are required. The availability and exchange of information on the programmatic and strategic planning activities of the Committee members will be enhanced through the maintenance of a series of databases and web sites. A clearing-house function for ideas and information on developments of interest to the system will be developed with a view to avoiding duplication and ensuring synergy.
- 9.44 Following a review process initiated by the Secretary-General in consultation with the executive heads of the organizations of the United Nations system, the Administrative Committee on Coordination, at its October 2000 session, decided to streamline its subsidiary machinery by establishing two high-level committees in the area of management and programmes. At the same time, ACC decided that the Office and the inter-agency-financed secretariats of ACC subsidiary bodies should function as a consolidated ACC secretariat. Accordingly, in addition to supporting the Secretary-General as Chairman of ACC and the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs in his capacity as Secretary of ACC, the head of the Office is responsible for the coordination of secretariat services for the ACC machinery as a whole.
- 9.45 The Office provides services by:
- (a) Overseeing system-wide coordination arrangements;
  - (b) Acting as a source of information for Member States and ACC member organizations on developments relating to the work of intergovernmental bodies of system-wide importance;
  - (c) Supporting the ongoing reform of ACC and its machinery through research and analysis and inter-agency processes;
  - (d) Facilitating, coordinating and undertaking research and analysis on issues of system-wide concern;
  - (e) Coordinating the preparation of documentation for ACC;
  - (f) Providing technical and substantive support with respect to other inter-agency cooperation and coordination activities as may be required, such as those in preparation for the World Summit on Sustainable Development;
  - (g) Ensuring implementation and follow-up to ACC decisions.

## Outputs

- 9.46 During the biennium 2002-2003, the following outputs will be delivered:
- (a) Inter-agency coordination and liaison
    - (i) Substantive and technical servicing of meetings:
      - a. Administrative Committee on Coordination (2 sessions per year, 4 meetings per session); one-day retreat in conjunction with one of its sessions;

- b. Meeting of ACC focal points to finalize the summary of conclusions of the Committee (2 sessions per year, 2 meetings per session);
- c. Inter-Agency Meeting on Sustainable Development (1 session per year, 4 meetings per session);
- d. Special sessions or inter-sessional meetings as required;
- (ii) Parliamentary documentation. Economic and Social Council: ACC annual overview report (2); report of ACC on programmes and resources for the biennium; system-wide responses to Joint Inspection Unit reports; and system-wide inputs to the reports on the follow-up to the Millennium Assembly;
- (b) Other substantive outputs
  - (i) Technical material: establishing, updating and maintaining the Executive Information Network and the ACC web site;
  - (ii) Recurrent publications: *Senior Officials Directory*;
  - (iii) Maintaining and updating reference material on the work of ACC and inter-agency bodies in the system.

- 9.47 The resource requirements of \$3,007,600 provide for the continuation of 14 established posts in the Office of the Under-Secretary-General. The amount of \$1,405,000 for non-post items provides for general temporary assistance, consultants and experts, travel of staff and the United Nations contribution to the funding of the activities of the Non-Governmental Liaison Service. The increase of \$50,200 relates to additional requirements for expertise on cross-cutting emerging issues that are within the responsibility of the Department.

- 9.48 The subprogramme is under the responsibility of the Division for Economic and Social Council Support and Coordination. The programme of work has been formulated on the basis of subprogramme 1 of programme 7 of the medium-term plan for the period 2002-2005.

### External factors

- 9.49 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) policy makers, both national and international, are fully involved in economic and social issues in the General Assembly and the Economic and Social Council; and (b) the international community is responsive to the recommendations and decisions of the Assembly and the Council.

### Outputs

- 9.50 During the biennium 2002-2003, the following outputs will be delivered:

- (a) Servicing of intergovernmental and expert bodies
- (i) General Assembly:
- a. Substantive servicing. General Assembly plenary (40-50); meetings and informal consultations of the Second Committee (40); panel discussions with delegations of the Second and Third Committees and interactive debates and keynote addresses (20);
  - b. Parliamentary documentation. Reports on: ACC comments on reports of the Joint Inspection Unit (5); comprehensive statistical data on operational activities for development for the years 2000 and 2001 (2); renewal of the dialogue on strengthening international economic cooperation through partnership (1); communication for development (1); cultural development (1); culture of peace/year for tolerance (1); dialogue among civilizations (1); HIV/AIDS (1); industrial development (1); operational activities that may arise from the 2001 triennial comprehensive policy review of operational activities (1); restructuring and revitalization of the United Nations in the economic, social and related fields (2); policy issues to be determined by the General Assembly, including those relating to globalization (2); and implementation of recommendations of the Joint Inspection Unit (2);
- (ii) Economic and Social Council:
- a. Substantive servicing. Meetings, including general and high-level segments and informal consultations, during the resumed sessions (11); meetings and informal consultations during the substantive sessions (100); meetings and informal consultations during the organizational sessions (16); meetings and informal consultations during the special sessions (24); joint meetings of the Economic and Social Council Bureau with the bureaux of its functional commissions (10); and the organization of special meetings and events involving the relevant departments of the United Nations, the organizations of the system, including the Bretton Woods institutions, and civil society organizations in support of deliberations of the Council;

Reports on: a main theme to be identified by the General Assembly at its fifty-sixth session or by the Economic and Social Council in its substantive session of 2002 arising from the triennial comprehensive policy review of operational activities for development (2), progress on the implementation of General Assembly recommendations emerging from the triennial policy review of operational activities for development (2), malaria and diarrhoeal diseases (1) and tobacco or health (1); reports to: special meetings (April 2002 and May 2003) (4), and the general segment (2), the coordination segment (2), and the high-level segment (2) of the council; and reports on: the consolidated outcome of the functional commissions for submission to the general segment (2) and the follow-up of the outcomes of the 2001 and 2002 coordination segments for submission to the general segment (2);
- (iii) Committee on Non-Governmental Organizations:
- a. Substantive servicing. Meetings of the Committee on Non-Governmental Organizations at its substantive regular and resumed sessions (100); assistance to the Bureau in preparing for Committee meetings; and ad hoc meetings at resumed sessions convened by the Committee, as required (100);

- b. Parliamentary documentation. Reports on more than 580 new applications and reclassifications and approximately 700 quadrennial reports (5);
- (iv) Executive Committee on Economic and Social Affairs: Substantive servicing. Substantive and technical servicing of the bimonthly meetings of the Committee with respect to the formulation of United Nations positions on development issues and the coordination of budget issues, as well as preparations for the meetings of the Committee;
- (b) Other substantive outputs

- (c) International cooperation and inter-agency coordination and liaison
  - (i) Representing the United Nations and contributing to the provision of substantive support to meetings of the Administrative Committee on Coordination and its standing committees, to the chairmanship of its working group on the resident coordinator system and to various other task forces on the evaluation and follow-up of intergovernmental directives; coordinating inter-agency inputs to reports on system-wide activities in the implementation of charter provisions related to assistance to third States affected by the application of sanctions under Chapter VII of the Charter of the United Nations; and organizing support for executive briefings and panel discussions involving the United Nations system and others;
  - (ii) Participation on behalf of the Department in meetings of the United Nations Development Group and its related subcommittees and in United Nations Development Support Group meetings and related activities, plus a variety of other meetings, including subgroups on programming policies and programming, programme operations, common premises and services, personnel and training, resident coordinator issues, gender, the right to development and information;
  - (iii) Focal point responsibilities for: the World Decade for Cultural Development; special years and anniversaries; food security, nutrition and the eradication of hunger, HIV/AIDS; malaria and diarrhoeal diseases, in particular cholera; tobacco and health; and drug abuse control; cooperation and liaison, as required, with the Organization of African Unity, the Organization of American States, the League of Arab States, the Caribbean Community, the Economic Cooperation Organization, the International Organization for Migration, the Agency for Cultural and Technical Cooperation and the

Organisation for Economic Cooperation and Development on issues of economic and social development and with WFP on food issues; and cooperation with intergovernmental, non-governmental and regional organizations on issues in the economic and social fields;

- (iv) Cooperation between the United Nations and non-governmental organizations with a view to forging links between the NGO community and the United Nations by strengthening the reciprocal exchange of information and supportive activities and by means of the electronic network and a comprehensive database in order to facilitate the use of information and advice from NGOs wherever feasible in the work of the United Nations Secretariat;
- (d) Technical cooperation. Field projects: impact evaluations that may arise from the triennial comprehensive policy review pursuant to decisions of the General Assembly.

- 9.51 The resource requirements of \$8,652,200 for posts reflect an increase of \$247,200 because of the provision for the full biennium for two temporary posts (1 P-4 and 1 General Service (Other level)) approved by the General Assembly in its resolution 54/265 of 15 June 2000 for 2001, which are to be converted to established posts, and for the reclassification of one P-4 post to the P-5 level and a concurrent downward reclassification of one P-4 post to the P-3 level in the NGO Section. The increase of \$30,000 for non-post resources provides for general temporary assistance during peak workload periods.

## **Subprogramme 2**

### **Gender issues and advancement of women**

#### ***Resource requirements (before recosting): \$8,417,600***

- 9.52 The subprogramme will be implemented by the Office of the Special Adviser on Gender Issues and Advancement of Women and by the Division for the Advancement of Women, which the Special Adviser heads. The programme of work has been formulated on the basis of subprogramme 2 of programme 7 of the medium-term plan for the period 2002-2005 and was reviewed, in draft form, by the Commission on the Status of Women at its forty-fifth session, in 2001. Subsequent to the formulation of the medium-term plan for the period 2002-2005, the General Assembly, at its twenty-third special session, entitled "Women 2000: gender equality, development and peace for the twenty-first century", assessed the implementation of the Beijing Declaration and the Platform for Action, identified obstacles and challenges thereto and proposed actions and initiatives to overcome them so as to achieve its full and accelerated implementation. In its resolution 55/71 of 4

December 2000, the Assembly called upon the relevant entities of the United Nations system, within their respective mandates to take effective action to achieve the full and effective implementation of the Beijing Declaration and the Platform for Action and the outcome of the twenty-third special session of the General Assembly. The activities under this subprogramme also reflect the recommendations of that resolution.

- 9.53 The Special Adviser reports directly to the Secretary-General on: gender issues, including the progress made by departments and offices in the United Nations Secretariat and the secretariats of the United Nations system in mainstreaming a gender perspective in every sector; the status of women in the Secretariat; progress made to achieve the goal of having 50 per cent of Professional posts filled by women and related policies, strategies and activities; and actions aimed at creating a more gender-sensitive working environment. The Special Adviser, assisted by the Focal Point for Women in the Secretariat, also facilitates, monitors and oversees the implementation of the special measures for the achievement of gender equality. Together they support and advise programme managers in their efforts to meet General Assembly-mandated targets on gender balance, and they participate in the development of a gender-sensitive and equitable working environment as described in the strategic plan of action for the improvement of the status of women in the Secretariat (1995-2000), which was endorsed by the Assembly in its resolution 49/167 of 23 December 1994. The Assembly, in its resolution 55/71, reaffirmed that the United Nations system should promote an active and visible policy of mainstreaming a gender perspective, including through the work of the Special Adviser and through the maintenance of gender units and focal points. As Chairperson of the ACC Inter-Agency Committee on Women and Gender Equality, the Special Adviser provides leadership in the area of gender mainstreaming in both the substantive and operational areas.

**Objective:** To promote the effective implementation of the Beijing Declaration and the Platform for Action of the Fourth World Conference on Women and the outcome of their review by the General Assembly at its twenty-third special session, held in June 2000. The subprogramme works to ensure women's full enjoyment of their human rights, and to this end it provides support to assist the Committee on the Elimination of Discrimination against Women in increasing its effectiveness and efficiency. An important objective of the subprogramme is to support the mainstreaming of a gender perspective at all levels. Improving the gender balance and gender equality in the United Nations Secretariat and promoting a more gender-sensitive work environment are also part of the subprogramme's objectives.

*Expected accomplishments*

- 9.56 The resource requirements of \$7,744,900 for posts reflect an increase of \$292,000, which is due to the establishment of three new posts (1 P-4, human rights officer, 1 P-2, associate legal officer and

1 General Service (Other level) secretary) to undertake various tasks related to the outcome of the twenty-third special session of the General Assembly and tasks resulting from the entry into force of the Optional Protocol of the Convention. The increase of \$202,400 for non-post resources provides for general temporary assistance during peak workload periods and additional consultants and expert group meetings foreseen in the biennium 2002-2003. The former element relates to the establishment of the Optional Protocol and the latter to studies on the implementation of the Platform of Action and the outcome documents of the twenty-third special session (General Assembly resolutions S-23/2, annex, and S-23/3, annex).

### Subprogramme 3 Social policy and development

#### *Resource requirements (before recosting): \$13,088,900*

- 9.57 The subprogramme falls under the responsibility of the Division for Social Policy and Development.
- 9.58 The programme of work has been formulated within the framework of subprogramme 3 of programme 7 of the medium-term plan for the period 2002-2005, and also takes into account the outcome of the twenty-fourth special session of the General Assembly, entitled "World Summit for Social Development and Beyond: achieving social development for all in a globalizing world", in which it reaffirmed the Copenhagen Declaration and Programme of Action and made a strong commitment to accelerate social development, including social justice for all in a globalizing world. In recognizing that there is a growing awareness of the positive impact of effective social policies on economic and social development, the special session stressed that social development requires, inter alia, not only economic activity, but also a reduction in inequality in the distribution of wealth and more equitable distribution of the benefits of economic growth within and among nations.
- 9.59 The subprogramme will continue to provide effective coordinated support, through policy analysis and the monitoring of progress, trends and emerging issues, in implementing further actions and initiatives identified within its mandates.
- 9.60 The work to be carried out under this subprogramme was reviewed, in draft form, by the Commission for Social Development at its thirty-ninth session.

- 9.63 The increase in non-post requirements of \$50,000 provides for additional general temporary assistance for follow-up activities related to the implementation of the decisions of the twenty-fourth special session of the General Assembly.

### **Subprogramme 4** **Sustainable development**

#### ***Resource requirements (before recosting): \$12,187,900***

- 9.64 The subprogramme is under the responsibility of the Division for Sustainable Development. The programme of work has been formulated on the basis of subprogramme 4 of programme 7 of the medium-term plan for the period 2002-2005, and was reviewed, in draft form, by the Commission on Sustainable Development at its ninth session.
- 9.65 Just prior to the adoption by the General Assembly of the medium-term plan for the period 2002-2005 at its fifty-fifth session, the Economic and Social Council, at its resumed session in October 2000, adopted resolution 2000/35, in which it decided to establish the United Nations Forum on Forests.
- 9.66 At the time of writing it was not possible to assess definitive resource requirements for the functioning of the secretariat of the United Nations Forum on Forests, since decisions on the location of the secretariat and the secondment of staff had yet to be taken during the Forum's

substantive session, in July 2001. The matter will therefore be further considered by the General Assembly at its fifty-sixth session in the light of whatever decisions are taken by the Economic and Social Council on the recommendations of the Forum. The secretariat of the former Intergovernmental Forum on Forests continues in the meantime to function as the secretariat of the United Nations Forum on Forests.

- 9.67 The work programme envisaged under this subprogramme also includes outputs related to the servicing of the United Nations Forum on Forests, pending decisions yet to be taken.

- 9.70 The decrease of \$166,200 in resource requirements for posts relates to the outward redeployment of one General Service (Other level) post associated with cartographic activities to subprogramme 5 (Statistics) and the abolition of two General Service (Other level) posts whose functions are no longer required, offset by the establishment of two new P-2 posts to cope with increased activities in connection with indicators of sustainable development and energy issues.

- 9.74 The increase of \$31,700 in resource requirements for posts provides for one General Service (Other level) post redeployed from subprogramme 4 to carry out cartographic functions and for the establishment of three new P-2 posts to carry out various functions, including methodological development work, offset by the abolition of three General Service (Other level) posts that are no longer required. - 9.88 The Executive Office assists the Under-Secretary-General in the discharge of the Department's responsibilities in the areas of personnel, finance and general administration. In addition, the Office provides administrative and programme support for the implementation of the operational programmes of the Department, including the Development Account, technical cooperation activities, extrabudgetary projects and other special operations.
- 9.89 In the biennium 2002-2003, the focus of the Office will be on enhancing the effectiveness of programme support, both in the traditional areas of responsibility and in the additional areas of human resources management that are expected to be decentralized and delegated from the central administration to the Department.

The Committee also noted that the response to its recommendation, as set out in table 9.33 of the proposed programme budget for the biennium 2000-2001, was not satisfactory, in particular in regard to the cost of ACC and its machinery (para. IV.12).

The Advisory Committee recalled its observation on the 1998-1999 proposed programme budget, whereby it requested information on the total level of resources proposed for NGOs. The matter has not been addressed by the Secretariat. The Committee reiterated its view that the time had come to appraise the impact on the United Nations programme budget of the large increase in NGOs involved in the work of the United Nations since administration and cost implications would become more critical in view of the financial constraints facing the Organization. In future budgets, this information should be included as to both the programmatic and the financial aspects (para. IV.16).

The response to the recommendation of the Advisory Committee, as set out in table 9.33 of the proposed programme budget for the biennium 2000-2001, was not satisfactory. The Committee pointed out that action taken by other Secretariat units and legislative bodies had been summarized in a number of sections (11A, 17 and 19). The Committee welcomed cooperation between the Department of Economic and Social Affairs and UNCTAD in the preparation of a number of reports, and recommended that in the next budget submission such information be included in section 9, including reviews of

are not normally associated with a specific office but continue to be covered through the Department of Economic and Social Affairs and central administration budgets. Costs for travel and consultants are included under Executive Direction and Management of the present budget section and are explained under that heading in the annex. Costs for servicing the jointly financed subsidiary bodies are reflected in section 29. With regard to the costs associated with ACC and its subsidiary machinery, it should be noted that in 1999 the Secretary-General launched a process of review to streamline the functioning of the Committee and of its subsidiary machinery and the replacement of standing bodies with more flexible coordinating arrangements. The results of that review are reported under section 29.

The matter was addressed at the resumed fifty-fourth session of the General Assembly, and additional resources were provided on the basis of demonstrated requirements. A further report of the Secretary-General containing an analysis of the workload and resources of the NGO Section of the Department will be submitted to the Fifth Committee of the General Assembly in May 2001.

The areas of cooperation between the Department and UNCTAD are clearly indicated in the proposed programme budget for 2002-2003. The draft programmes of work have been submitted to and considered by all relevant functional commissions of the Economic and Social Council. Recurrent and non-recurrent publications are indicated under the outputs of each subprogramme.

The Committee also recommended that, in the narrative under each subprogramme, the number of recurrent and non-recurrent publications estimated for the next biennium be indicated systematically, as presented in the budget sections for UNCTAD and the regional commissions (para. IV.20).

The Advisory Committee recommended that in future budget presentations the level of resources needed to maintain the capacity to execute technical cooperation programmes be clearly reflected (para. IV.22).

The Advisory Committee noted that information on technical cooperation funds did not clearly indicate their use, and that that weakness should be addressed in future budgets. In addition, information on the role of intergovernmental machinery should be provided (para. IV.23).

The extrabudgetary resources reflected under the Executive Office (programme support) are used exclusively for the implementation of the technical cooperation programme. For subprogrammes 3, 4 and 8, the extrabudgetary posts reflected are also devoted to project execution. In addition, in order to ensure that the Department can maintain its capacity to deliver its project portfolio, the regular budget staff are assigned a certain level of responsibility, vis-à-vis the technical cooperation programme.

The funds reflected under operational projects represent the estimated project portfolio that the Department anticipates for technical cooperation activities. These activities are largely implemented at the country level and can be broken down into five main categories: personnel (experts, consultants, administrative support, national professionals and United Nations Volunteers), subcontract services, training (fellowships, study tours, and workshops) equipment and reporting/sundry. The allocation of those funds among subprogrammes is dependent upon the field of activity of the individual projects. The Department reports annually to UNDP, and information on the technical cooperation programme is submitted to the Economic and Social Council through the UNDP Governing Council. Although the Department does not specifically report on its technical cooperation programme to the intergovernmental machinery, it has attempted, since its inception, to strengthen the synergy between the outcome of the intergovernmental processes and the projects that are being developed at the field level.

*Brief description of the recommendation**Action taken to implement the recommendation*

The Advisory Committee encouraged the Department to expand the use of new technology in disseminating its products and in communication services. However, it requested that, in the next budget submission, clear information be provided on new technology projects and related costs for the maintenance of existing and proposed projects under this section. The budgetary presentation should reflect the level of coordination with other structures of the Secretariat, such as the regional commissions (para. IV.24).

The Advisory Committee recommended that in future the Secretariat, in all sections of the budget, differentiate clearly contingency funds that might be required to implement existing mandates. The Committee further recommended that under section 9, the number of ad hoc expert groups requested and the related number of meetings be disclosed, preferably in tabular form, under each subprogramme. It also requested that it be provided with similar information for the last two bienniums, including the number of ad hoc expert groups convened (para. IV.28).

The Advisory Committee reiterated its view (see A/52/7/Rev.1, chap. II, paras. IV.10 and 11 and A/54/7, chap. II, para. IV.16) that the Secretariat should submit a comprehensive report on the administration and management implications of the large increase in NGOs involved in the work of the United Nations, particularly the impact of this growth on the United Nations programme budget (para. 6).

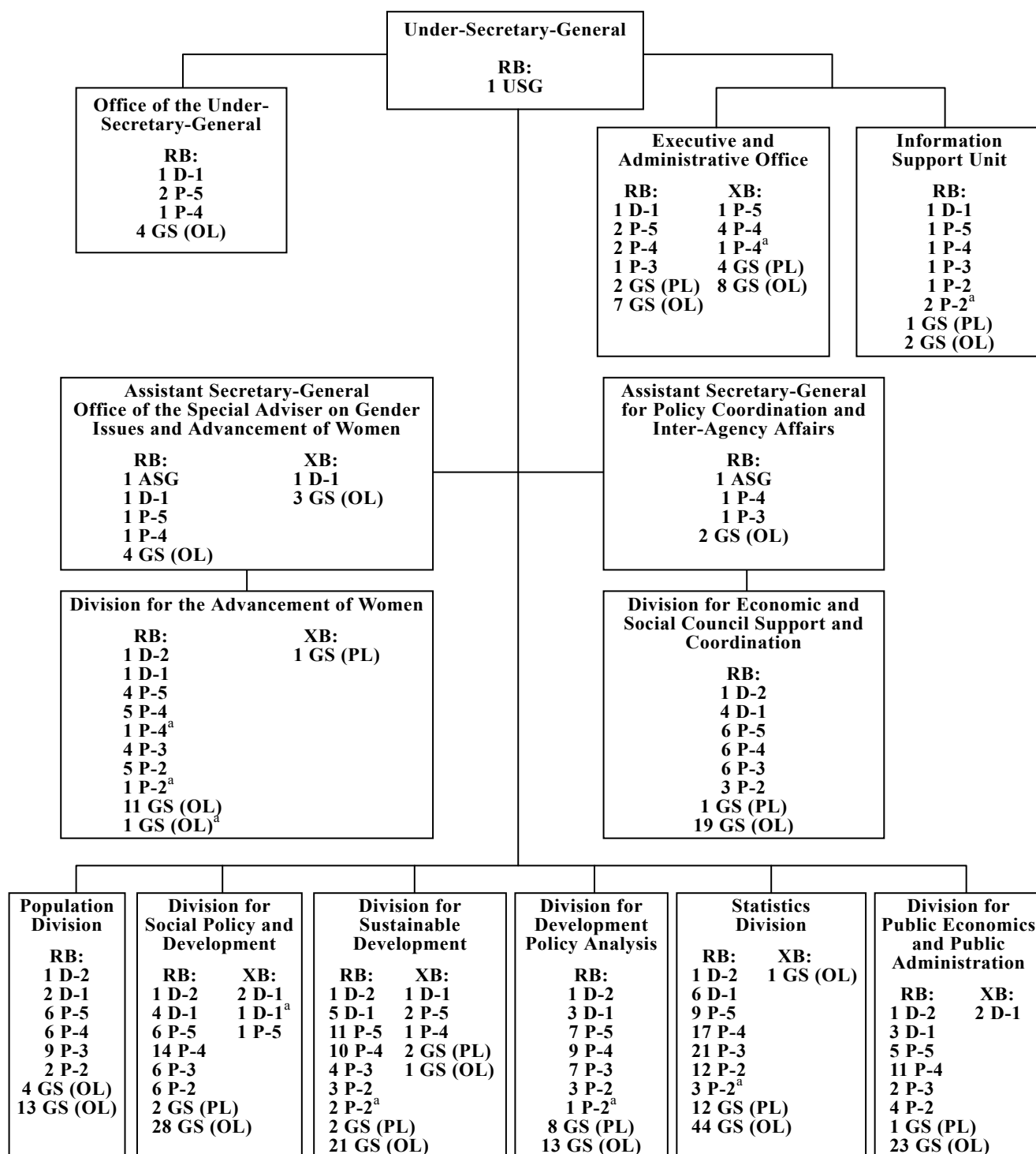
In its report on the outcome of the consolidation of the three former economic and social departments into the Department of Economic and Social Affairs (A/55/750), the Office of Internal Oversight Services noted that the Department had taken advantage of its new integrated capacity to introduce information technology into its work across the board.

This requirement has been met for the programme budget for the biennium 2002-2003. Detailed information on the last two bienniums will be made available at the time of the review of the present programme budget.

A report of the Secretary-General containing the analysis of the workload and resources of the Non-Governmental Organizations Section of the Department will be submitted to the Fifth Committee in May 2001.

IMDIS has undergone expansion in the current biennium, and provision has been made for its further expansion in the biennium 2002-2003.

**Resource requirements (before recosting)***Other staff costs*

- A.9.1 In the context of preparing for and servicing the special conferences to be held in 2002-2003, new and non-recurrent provisions of \$441,100, reflecting a net increase of \$72,200, are proposed to cover anticipated requirements under general temporary assistance and overtime. The net increase of \$72,200 results from increases for new and non-recurrent provisions of \$441,100, offset by reductions for one-time provisions in 2000-2001 for the follow-up to the Fourth World Conference on Women and full implementation of the Beijing Declaration and the Platform for Action (\$127,800) and for the special session of the General Assembly for an overall review and appraisal of the implementation of the outcome of the World Summit for Social Development (\$241,100), as follows:
- (a) Follow-up to the International Year of Older Persons: Second World Assembly on Ageing. A provision of \$100,600 is proposed under general temporary assistance, equivalent to six work-months each for one P-3 and two General Service staff;
  - (b) World Summit on Sustainable Development. The General Assembly has mandated an overall 10-year review and appraisal of the outcome of the United Nations Conference on Environment and Development to be held at the summit level. A provision is made of \$340,500 under general temporary assistance, equivalent to about 24 work-months, for three temporary personnel at the P-4 level and 18 work-months at the General Service level.

*Non-staff compensation*

- A.9.2 The requirements of \$146,300, at the maintenance level, relate to the provision for honoraria for the 23 members of the Committee on the Elimination of Discrimination against Women.

*Consultants and experts*

- A.9.3 A new and non-recurrent provision of \$362,200, reflecting a net increase of \$37,800, will be required for consultancy services to provide expertise not available in the Department of Economic and Social Affairs. The net increase of \$37,800 results from increases for new and non-recurrent provisions of \$362,200, offset by reductions for one-time provisions in the biennium 2000-2001 for:
- (a) The follow-up to the Fourth World Conference on Women and full implementation of the Beijing Declaration and the Platform for Action \$83,600
  - (b) The special session of the General Assembly for an overall review and appraisal of the implementation of the outcome of the World Summit for Social Development \$178,000
  - (c) The Ad Hoc Open-ended Working Group of the General Assembly on Financing for Development, as follows: \$62,800
    - (i) Follow-up of the International Year of Older Persons: Second World Assembly on Ageing: consultants to undertake studies and prepare syntheses and promotional materials (\$40,200) and one ad hoc expert group to review studies and documents on interregional approaches to the implementation of the revised International Plan of Action on Ageing for submission to the General Assembly (\$50,300);
    - (ii) World Summit on Sustainable Development: consultants to prepare analytical studies and to serve as resource persons in relation to the main themes of the 10-year review

and the key issues to be identified through the national assessments and regional and subregional preparatory meetings to be held in 2001 (\$120,900); and the holding of at least two ad hoc expert group meetings to develop proposals on effective ways and means, as well as the most promising policy approaches and forward-looking strategies for expediting the implementation of Agenda 21 and the Programme for the Further Implementation of Agenda 21 (\$150,800).

*Travel of representatives*

- A.9.4 The requirements of \$3,091,100, reflecting a net increase of \$106,300, are due to increases in travel costs for the biennium 2002-2003 of \$233,200, offset by decreases for one-time provisions in 2000-2001 for the follow-up to the Fourth World Conference on Women and full implementation of the Beijing Declaration and the Platform for Action (\$32,700) and the special session of the General Assembly for an overall review and appraisal of the implementation of the outcome of the World Summit for Social Development (\$94,200). They provide for travel costs as follows:
- (a) Statistical Commission (2 annual sessions): \$86,600, including an increase of \$25,000 to provide for two annual sessions of the Commission for a period of four working days during each session in New York in accordance with Economic and Social Council resolution 1999/8;
  - (b) Commission on Population and Development (2 annual sessions): \$99,500;
  - (c) Commission for Social Development (2 annual sessions): \$166,000;
  - (d) Commission on the Status of Women (2 annual sessions): \$193,700;
  - (e) Commission on Sustainable Development (2 annual sessions of the Commission and 4 meetings of the Ad Hoc Open-ended Inter-sessional Working Group: \$763,800, reflecting a decrease of \$49,900 due to the redeployment of resources provided for the International Forum on Forests to the United Nations Forum on Forests;
  - (f) United Nations Forum on Forests (2 annual sessions): \$119,900, including an increase of \$49,900, relating to the balance of the provision made for the International Forum on Forests, transferred from the provisions for the Commission on Sustainable Development;
  - (g) Committee for Development Policy (2 annual sessions): \$308,600 for travel and per diem costs;
  - (h) Committee on Energy and Natural Resources for Development (1 biennial session): \$173,700 for travel and per diem costs;
  - (i) Committee on the Elimination of Discrimination against Women: \$878,500, including an increase of \$81,300 based on actual expenditures for the holding of three weeks of meetings twice a year and providing for travel and per diem costs of the 23 members of the Committee as well as the travel and subsistence costs of the members, the Chairperson or her/his representative when attending meetings of other United Nations organs dealing with human rights (\$797,200); the cost of the two annual meetings of the Working Group on the Optional Protocol (\$38,500); and the costs of the three annual missions of inquiry (\$42,800);
  - (j) Meeting of Experts on the United Nations Programme in Public Administration and Finance: \$156,100 for the travel and per diem costs of the experts attending the sixteenth meeting in 2002;
  - (k) Ad Hoc Group of Experts on International Cooperation in Tax Matters: \$144,700 for the travel and per diem costs of the experts attending the eleventh meeting in Geneva in 2002.

*Travel of staff*

A.9.5 The amount of \$150,200 provides for:

- (a) Follow-up to the International Year of Older Persons: Second World Assembly on Ageing: travel of staff to participate in expert meetings and round-table discussions as well as other related meetings organized by Governments and international organizations as part of the preparatory process (\$50,300);
- (b) World Summit on Sustainable Development: travel of staff for national briefings, meetings and other related activities prior to and after the special session (\$99,900).

*Contractual services*

A.9.6 A new and non-recurrent provision of \$50,300, reflecting a decrease of \$12,800, will be required for the external production of publications related to the follow-up to the International Year of Older Persons: Second World Assembly on Ageing (\$20,100) and the World Summit on Sustainable Development (\$30,200). A net decrease of \$12,800 results from increases for new and non-recurrent provisions of \$50,300, offset by reductions for one-time provisions in the biennium 2000-2001 for the follow-up to the Fourth World Conference on Women and full implementation of the Beijing Declaration and the Platform for Action (\$42,100) and for the special session of the General Assembly for an overall review and appraisal of the implementation of the outcome of the World Summit for Social Development (\$21,000).

*General operating expenses*

A.9.7 A new and non-recurrent provision of \$9,000 will cover other miscellaneous expenses in connection with the World Summit on Sustainable Development. A net decrease of \$11,300 results from increases for new and non-recurrent provisions of \$9,000, offset by reductions for one-time provisions in the biennium 2000-2001 for the follow-up to the Fourth World Conference on Women and full implementation of the Beijing Declaration and the Platform for Action (\$5,100) and for the special session of the General Assembly for an overall review and appraisal of the implementation of the outcome of the World Summit for Social Development (\$15,200).

*Hospitality*

A.9.8 A new and non-recurrent provision of \$8,400 will cover anticipated hospitality for the follow-up to the International Year of Older Persons: Second World Assembly on Ageing (\$2,400) and the implementation of the World Summit on Sustainable Development (\$6,000).

### Resource requirements (before recosting)

#### *Posts*

- A.9.9 The requirements of \$3,007,600, reflecting no increase, provide for the posts shown in table A.9.7 above.
- A.9.10 As indicated in the main part of the present section, the Office for Inter-Agency Affairs, shown under executive direction and management, comprises staff on non-reimbursable loan from member organizations of the Administrative Committee on Coordination, either on an ongoing basis or for specific tasks. Within the Secretariat, arrangements currently in force assign, during the biennium, a Director-level post to the Office from the Executive Office of the Secretary-General, one P-5 and one General Service (Principal level) post from the Division for Economic and Social Council Support and Coordination and two General Service (Other level) posts from the Office of the Under-Secretary-General of the Department of Economic and Social Affairs.

#### *Other staff costs*

- A.9.11 The amount of \$191,400, reflecting no increase, will cover 24 work-months of general temporary assistance requirements for the coordination of the Department's technical cooperation activities.

#### *Consultants and experts*

- A.9.12 A provision of \$209,800, reflecting an increase of \$50,200, will be required for specialized expertise in selected cross-cutting emerging issues within the responsibility of the Department (\$105,100), for the preparation of specialized documentation for the Administrative Committee on Coordination and for information system requirements related to the work of the Committee (\$104,700).

#### *Travel of staff*

- A.9.13 The requirements of \$604,800, reflecting no increase, provide for: (a) travel to be undertaken by the Under-Secretary-General, the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs and the Under-Secretary-General's immediate staff to meetings of United Nations bodies; consultations with Governments, intergovernmental and non-governmental organizations and institutions and the specialized agencies; and representational missions on behalf of the Secretary-General (\$208,700); (b) travel related to the organization of panels of eminent personalities and experts to be held in conjunction with the sessions of the Second and the Third Committees of the General Assembly and the Economic and Social Council and its subsidiary bodies on issues of concern to them, including the high-level meeting on the renewal of dialogue on strengthening international economic cooperation for development through partnership. It is estimated that eight such panels would be required, two during each year of the biennium for the General Assembly and two each year for the Council and its subsidiary bodies. While the travel resources are reflected under the Office of the Under-Secretary-General, the related outputs are cited under subprogramme 1 (\$236,000); and (c) travel of staff to service and participate in the meetings of ACC and its subsidiary bodies in Geneva and other duty stations, and for liaison and coordination missions with the specialized agencies (\$160,100).

#### *Grants and contributions*

- A.9.14 The requirement of \$399,000, reflecting no increase, relates to the United Nations contribution to the activities of the Non-Governmental Liaison Service.

**Resource requirements (before recosting)***Posts*

- A.9.15 The requirements of \$8,652,200, reflecting an increase of \$247,200, will cover the cost of the 46 posts, 26 Professional and above and 20 General Service, shown in table A.9.12 above. The net increase is due to the full biennial provision for two new temporary posts (1 P-4 and 1 General Service (Other level)) approved by the General Assembly in its resolution 54/265 of 15 June 2000 for 2001, to cope with the increase in the volume and complexity of the workload of the Non-governmental Organizations Section (\$251,200). Further review of the functions attached to the posts has determined the continuing nature of the work and the eligibility for conversion of those two temporary posts to established posts. The continuing functions include, inter alia: (a) for the P-4 post, broad-based and in-depth research and analytical activities as well as responsibility for all documentation generated by the Section, including brochures and training materials for the outreach programme; and (b) for the General Service post, organization and maintenance of the complex filing system, comprising electronic databases as well as hard-copy files for each NGO requesting and holding consultative status with the Economic and Social Council. The net increase is offset by a decrease (\$4,000), arising from the upward reclassification of one P-4 post to the P-5 level and the downward reclassification of one P-4 post to the P-3 level. The justification for the upgrade of one P-4 post to the P-5 level is that the exponential increase in requests by NGOs for consultative status with the Council, which necessitated a higher level of organization and coordination regarding the preparation and servicing of the Committee on Non-Governmental Organizations, has also generated expanded follow-up activities with the members of the Committee. Over the past two years several policy papers requested by the Committee for a discussion of work methods regarding the processing of the large increase in requests submitted by NGOs had to be produced with the assistance of a senior NGO officer. Increased liaison with the organs, funds, programmes and specialized agencies, necessitated an overall review of the coordination of meetings and a higher level of responsibilities. The responsibilities of the incumbent require him or her to interact with senior officers of the Secretariat and senior officials of Governments, often at the ambassadorial level, outside the Secretariat. The reclassification is

also expected to meet the need for a senior Professional post to assist with in providing substantive support to the Committee on Non-Governmental Organizations and the Council, thereby improving the post structure of the Non-Governmental Organizations Section. A concurrent downward reclassification of one P-4 post to the P-3 level addresses the overall post structure of the Economic and Social Council and the Inter-organization Cooperation Branch and the need for a junior Professional post to provide support to its coordination function and preparatory work with respect to the convening of panels and special meetings for the Council and the Second Committee. The staff member will also assist the Chief of the Branch in carrying out the functions of the Branch as the focal point for a number of economic and social issues.

*Other staff costs*

- A.9.16 The amount of \$30,000 provides for general temporary assistance to enable the Non-Governmental Organizations Section to exercise the required flexibility in providing support to the Committee to cope with its ever-increasing workload during peak periods.

*Consultants and experts*

- A.9.17 The amount of \$144,100, reflecting no growth, provides for specialized expertise not available in the Secretariat to assist in:

- A.9.18 The amount of \$147,900, reflecting no growth, provides for travel of staff for the substantive servicing of meetings of the Economic and Social Council and meetings of the Administrative Committee on Coordination held in Geneva (\$42,400); the provision of substantive support to other coordination meetings (\$14,600); NGO training workshops, including the joint workshop at the International Training Centre of ILO (\$21,900); field assessment missions on the implementation of policy directives and the evaluation of technical cooperation activities (\$43,800); liaison with NGOs (\$10,900); evaluation of the United Nations Development Assistance Framework (UNDAF) (\$8,800); and workshops with resident coordinators and Governments to develop operational guidelines based on good practices and evaluation findings (\$5,500).

*Contractual services*

- A.9.19 The provision of \$22,100, at the maintenance level, will cover publication production costs.

*Grants and contributions*

- A.9.20 The requirement of \$80,900 represents the contribution by the United Nations to the ACC Subcommittee on Nutrition under the terms of Economic and Social Council resolution 2107 (LXIII) of 3 August 1977. The cost of the Subcommittee's operations are shared among its member organizations.

**Resource requirements (before recosting)***Posts*

- A.9.21 The amount of \$7,744,900, reflecting an increase of \$292,000, provides for the posts shown in table A.9.14 above. The increase of \$292,000 is for three new posts, comprising one P-4 human rights officer, one P-2 associate legal officer and one General Service (Other level) secretary to undertake the various tasks related to the outcome of the twenty-third special session of the General Assembly and those resulting from the entry into force of the Optional Protocol to the Convention on the Elimination of All Forms of Discrimination against Women. The functions to be undertaken, which are related to the petition procedure and the inquiry mechanism of the Optional Protocol, will be as follows: (a) the P-4 human rights officer will be responsible for: providing substantive and administrative support in the petition procedure by responding to petitions from individuals and providing advice on the procedures to be followed; forwarding petitions to States parties and advising them on the procedures to follow; providing draft decisions on admissibility for the use of the working group of the Committee on petitions; processing final decisions for publication and analysing information that could trigger an inquiry; submitting information to the State concerned and requesting its comments; providing analyses to the Committee; providing documentation for required visits and accompanying Committee members on such visits; and preparing reports for transmittal to the States parties concerned, as required by the Optional Protocol; (b) the P-2 associate legal officer will be responsible for assisting in the procedures of the Optional Protocol and providing substantive support and servicing to the Committee and its working groups; and (c) the General Service (Other level) post will provide the necessary secretarial support.

*Other staff costs*

- A.9.22 The amount of \$40,000 provides for general temporary assistance required in support of emerging issues related to gender perspectives and mainstreaming and for the support of the Optional Protocol mechanism during peak workload periods.

- A.9.25 The amount of \$159,000, reflecting no growth, provides for the travel of the Special Adviser on Gender Issues and Advancement of Women and other staff to undertake missions for the implementation of the programme of work, in particular to United Nations offices away from Headquarters and to attend meetings of intergovernmental and non-governmental organizations involved in women's rights; travel for consultation with Governments and other organizations on behalf of the Secretary-General; and travel for activities related to the programme of work of the Division, including attendance at meetings of the Economic and Social Council in Geneva, substantive servicing and participation in conferences and meetings of intergovernmental and non-governmental organizations, attendance at inter-agency meetings and undertaking inquiry missions to Member States with Committee members in accordance with article 8 of the Optional Protocol to the Convention and decisions of the Commission on Human Rights.

*Contractual services*

- A.9.26 A provision of \$40,100, at the maintenance level, is required for the cost of externally printing the following publications related to gender issues: *DAW Newsletter*, *The Work of CEDAW*, volumes 11 and 12, and *Women 2000*.

*Hospitality*

- A.9.27 The requirements of \$3,400, at the maintenance level, cover the cost of official functions to be hosted by the Special Adviser on the occasion of the sessions of the Commission on the Status of Women and the Committee on the Elimination of Discrimination against Women and special events.
