## Addressing the humanitarian consequences of large movements – Taking stock and looking ahead two years on from the New York Declaration

## 1. Background & themes:

The New York Declaration, which laid the foundation for the Global Compact for Safe, Orderly and Regular Migration (GCM), was adopted at the 2016 High-level plenary meeting on addressing large movements of refugees and migrants. This high-level meeting was motivated by the emerging consensus in 2015 that the crises and vulnerability along key migratory routes, most notably the Mediterranean, the Andaman Sea, the Gulf of Aden and the Central American corridor were morally indefensible and politically untenable.

While the New York Declaration acknowledged the positive contribution of migrants to sustainable development, it also pointed to the vulnerability and complex challenges of forced displacement and irregular migration in large movements. It did so recognizing that we are witnessing an unprecedented level of human mobility and that large movements of refugees and migrants have political, economic, social, developmental, humanitarian and human rights ramifications, which cross all borders. As noted in the GCM, refugees and migrants are entitled to the same human rights and fundamental freedoms, which must be respected, protected and fulfilled at all times. While both may be particularly vulnerable to the risk of violations and abuses of their rights, only refugees are entitled to additional protections under international refugee law.

## 2. Content and expected outcomes:

Keeping in mind the moral and humanitarian challenges identified in the New York Declaration, this side-event will explore concrete action already taken to deliver on the promise of 2016 to address the humanitarian concerns of migrants in transit. Specifically, it will demonstrate how action and lessons from international cooperation, regional and inter-regional responses and partnerships, if replicated and upscaled, can guide the international community in its implementation of aspects of the GCM objectives to address and reduce vulnerabilities in migration (objective 7), save lives (objective 8) and enhance availability of pathways for migrants in a situation of vulnerability (objective 5). In so doing, it will also explore further efforts that could be taken to reduce vulnerability as well as combat the abuses and exploitation of migrants in situations of vulnerability, consistent with States' obligations under international law, as well as the commitment in the New York Declaration to consider developing non-binding principles and voluntary guidelines on the treatment of migrants in vulnerable situations, the Secretary General's recommendation that Member States lay out a strategy for dealing with large movements of migrants, as well as broader efforts to address displacement.
