Revisiting the objectives

- Achieved:
 - Key policy questions presented and discussed.
 - Integrated macro-micro modelling framework described.
 - Results of recently completed projects on MDG financing strategies and real-time simulation results presented and discussed.
 - Key aspects of international support measures reviewed.
 - Stock of data availability taken.
- Pending:
 - More discussion on institutional arrangements under which capacity building activities will be undertaken.
 - Agree on future data collection/estimations (“what” and “who”).
 - Agree on a timeline.

Key questions

- What does it take to achieve the MDGs?
 - What are MDG determinants?
 - How would MDG achievement influence other aspects of economic and social development?
- Do we know how much it will cost and can we afford achieving the goals on time?
- What policy options do we have in financing the MDG strategy? What are the trade offs when:
 - scaling up aid or borrowing abroad?
 - enhancing domestic resource mobilization?
 - reallocate government spending across sectors?
 - improve efficiency of spending

Other policy questions and model features

- Gender inequalities: capture in labour market?
- Migration and expat workers?
- Policy issues:
 - Tax policies (do we have enough detail in SAM?)
 - Subsidy policies: what kind? How are subsidies captured in SAM?
 - Trade policies?
 - Infrastructure investment?

Scope for strengthening capacities

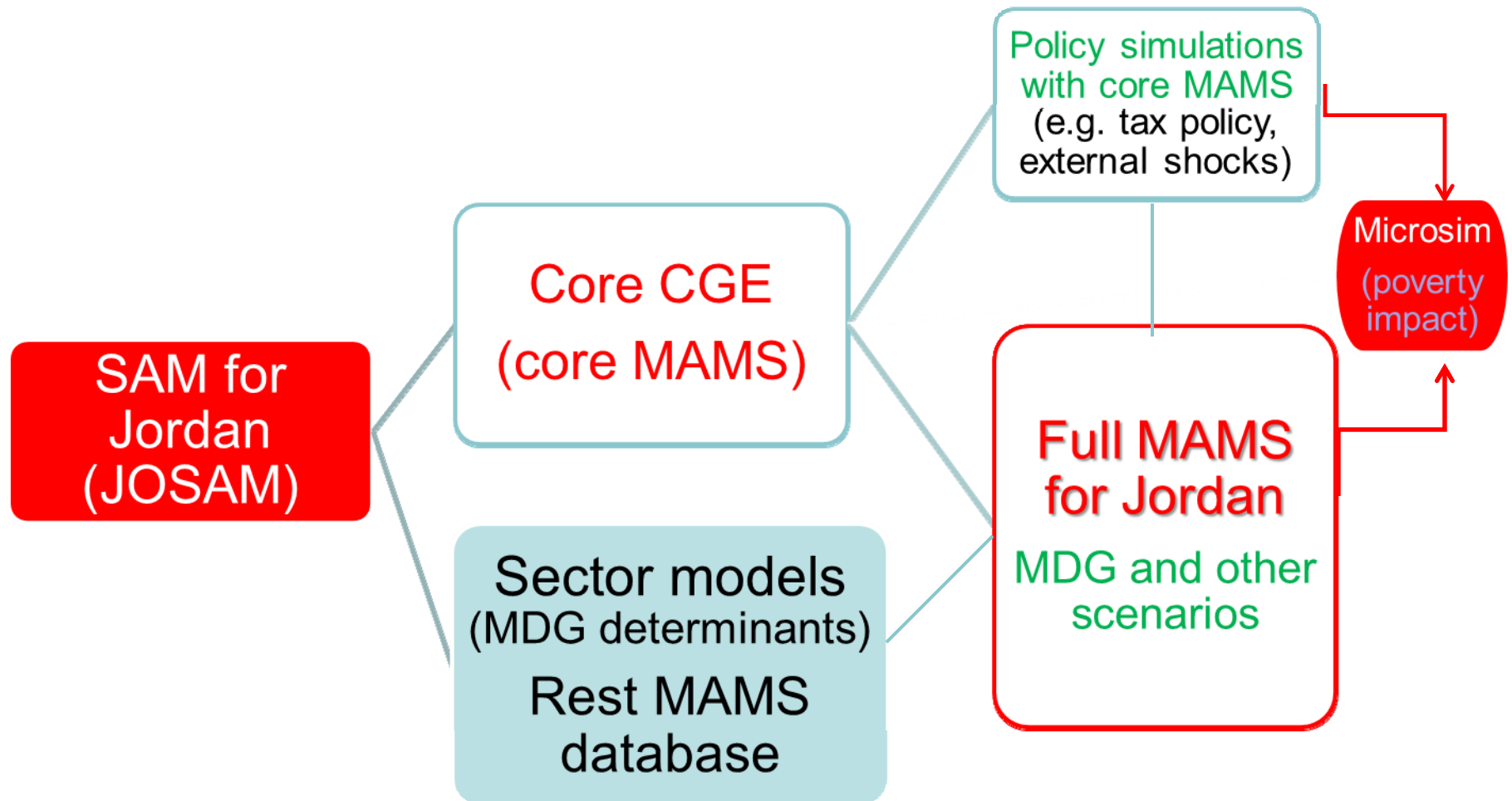
- Contingency planning: “what if” (....there is a global shock) and “what could happen” (...in terms of setbacks in human development) and “what could we do” (.. to mitigate or avoid such impact)
- Policy coherence: use model to see through interactions across key policy areas and coherence in outcomes in terms of defined goals and targets (such as the MDGs)
- Beyond MDGs: framework flexible to set different than internationally agreed targets or assess feasibility of attaining other policy targets

Next steps (1-5)

1. *Scoping mission and first workshop:*

- Identify key policy questions; how to adapt framework; available country expertise; data availability

2. Formation and consolidation of “technical unit”, also:

- initiation inter-agency policy platform;
- include activity in program with UNDP

3. Adaptation Social Accounting Matrix, completion of MAMS dataset

- Base year? How to aggregate/disaggregate JOSAM?
- Sector studies (estimation of MDG elasticities)

4. Calibration of Core CGE/MAMS for Jordan with new dataset; pilot policy simulations with Core CGE/MAMS

5. **Workshop 2:** Calibration Full MAMS (and ISIM-MAMS), updating of data set, initial runs of MDG and other policy scenarios

Next steps (6-10)

6. Final fine-tuning of MAMS for Jordan
7. **Workshop 3:** implementation of policy simulations and elaboration of policy notes/briefs, microsimulations training
8. Implementation of policy simulations and elaboration of policy notes/briefs
 - *Policy briefs in what areas?*
9. **Workshop 4:** presentation/discussion of policy notes/briefs, follow-up steps, uses to support policymaking, and policy dialogue.
10. Strengthening the policy dialogue: continuous presentations of results to policy makers and stakeholders; identification of new demands for policy analysis
