The Committee is also responsible for reviewing the status of Least Developed Countries and for monitoring their progress after graduation from the category.

*Global Governance and Rules for the post-2015 Era*, edited by José Antonio Alonso and José Antonio Ocampo, has been published by Bloomsbury in association with the United Nations. The book reflects the outcome of a research programme carried by a group of independent development experts brought together by the CDP. The researchers provide a unique assessment of global rules and governance, a reflection of past and present development experiences, identification of weaknesses in global governance mechanisms and suggestions for policy answers. New rules and governance mechanism are needed to address today's global challenges and to shape the new development agenda for the post-2015 era. ## Participants

**Prof. José Antonio Ocampo Gaviria** is Chair of the CDP since 2013. He is Professor of Professional Practice in International and Public Affairs, and Director, Economic and Political Development Concentration, School of International and Public Affairs, Columbia University. His current research is on macroeconomic theory and policy, and international financial and monetary issues. He served UN as Under-Secretary-General for Economic and Social Affairs, and Executive Secretary of the ECLAC. He served the Government of Colombia as Minister of Finance and Public Credit, and Minister of Agriculture.

**Prof. José Antonio Alonso** is a member of the CDP since 2007. He is Professor of Applied Economics, Complutense University. He has published books and articles on growth and economic development, international development cooperation, Spanish and European relations with Latin America, and globalization.

**Prof. Keun Lee** is a member of the CDP since 2013. He is Director of Center for Economic Catch-up, Professor of Economics, Seoul National University, and the President-Elect of the International Schumpeter Society. His main research areas include economics of catch-up, with focus on corporate organization and growth, industrial policy, innovation policy, and system transition in Asia.
