The Southern African Migration Project is a multi-faceted research, policy and training programme designed to facilitate the formulation and implementation of new initiatives on cross-border population migration in the region. The Project, which began in May of 1996, is funded by the Canadian International Development Agency (CIDA) and the UK Department for International Development (DFID).



### Incoming Stream 1: Cross-Border Traffic

- Massive increase in Cross-Border Traffic To and Within SADC Region Between 1990 and 2000
- Total Visitors to South Africa Increased from 1 Million to 5.1 Million
- African Visitors to South Africa Increased from 550,000 to 4 Million
- SADC Country Visitors to South Africa Increased from 500,000 to 3.7 Million



Employment on South African Gold Mines




## Contract Migration: Role of Foreign Labour

- Mine workforce is being "externalized"
- Proportion of non-South Africans has increased 40% in 1987 to nearly 60% at present.
- South African and foreign miners laid off in 2:1 ratio.
- Mozambique has experienced no downsizing at all. Proportion of Mozambicans on South African gold mines increased from 10% to 25% between 1990 and 2000.

# Incoming Stream 3: Undocumented Migration: Flood or Stream?

- Marked increase in clandestine migration to and within SADC since 1990.
- Major sources of clandestine migration are Mozambique, Zimbabwe, Malawi and Angola.
- Major recipients are South Africa and Botswana.
- Numbers involved are unknown (unknowable). Discredited official estimates in 4-8 million range. Real number probably closer to 500,000.
- Major work sectors are construction, services and agriculture.
- Evidence of abuse and exploitation by employers. Employer sanctions not enforced.
- Research shows that:
  - vast majority are temporary residents
  - economic motivations are paramount
  - majority enter legally and overstay

### Refugee Origins

- Majority of refugee claimants from:
  - > DRC (12%)
  - Angola (11%)
  - > India (10%)
  - > Somalia (9%)
  - Pakistan (8%)
  - Nigeria (8%)
  - Senegal (7%)
- > Several countries have rejection rates over 75% including:
  - > India (88%)
  - ➤ Nigeria (82%)
  - > Senegal (82%)
  - ➤ Pakistan (78%)
- Only Somalia has an acceptance rate > 80%. Others include Angola (65%), DRC (63%) and Rwanda (50%).

- World Bank estimates total emigration for the period 1998-2003 at 521,571 (compared to 130,965 in the official data).
- Overall, between 1987 and 2003, South Africa therefore lost an estimated 720,000 emigrants to five major developed countries.
