SWITZERLAND'S SUGGESTIONS TO ANNEX II

TOWARDS A GLOBAL COMPACT FOR SAFE, ORDERLY AND REGULAR MIGRATION

1. Introduction

- 1.1 We commit to launch a process of intergovernmental negotiations leading to the adoption of a Global Compact for Safe, Orderly and Regular Migration.
- 1.2 This Global Compact would set out a range of principles and understandings among UN Member States regarding international migration in all its dimensions. It would make an important contribution to global governance on international migration. It would present a framework for comprehensive international cooperation on migrants and human mobility. It would deal with the humanitarian, developmental, human rights-related and other aspects of migration and would be rooted in the 2030 Agenda.

2. Content

- 2.1 Elements for the Global Compact would include the following:
 - International migration as a multidimensional reality of major relevance for the development of countries of origin, transit and destination (as recognized in the 2030 Agenda).
 - The contribution made by migrants to sustainable development and the complex interrelationship between migration and development.
 - The impact of migration on human capital in countries of origin.
 - Remittances as an important contribution to development and a source of private capital.
 - A holistic view of migration in all its dimensions.
 - Effective protection of the human rights and fundamental freedoms of all migrants, especially women and children, regardless of their migratory status. The specific needs of migrants in vulnerable situations, in particular women and children.
- The provision of gender-responsive services, such as comprehensive health care, including sexual and reproductive health care services and prevention and protection services to address sexual and gender-based violence.
 - Border management.
 - Combatting human trafficking and migrant smuggling.
 - Promotion of the inclusion migrants in host societies.

- The facilitation of safe, orderly and regular migration; the creation and expansion of safe, regular pathways for migration.
- A framework for greater international cooperation to improve migration governance.
- Data on international migration.

3. The way forward

- 3.1 The Global Compact would be elaborated through a process of intergovernmental negotiations. This process, which will begin in the coming months, will culminate in an intergovernmental conference on international migration in 2018 at which the Global Compact would be adopted. lead to the adoption of the Global Compact at the third UN High Level Dialogue on International Migration and Development, to be held not later than 2019.
- 3.2 The President of the General Assembly is invited to make arrangements for the determination of the modalities, timeline, possible preparatory conferences and other practicalities relating to the intergovernmental negotiations, including the integration of Geneva-based migration expertise. He would furthermore appoint two co-facilitators to lead the negotiations.
- 3.3 As the Third High-Level Dialogue on International Migration and Development is to be held in New York "no later than 2019," a role should be envisaged for the High-Level Dialogue in the process. The date and modalities for the third UN High Level Dialogue on International Migration and Development will be decided upon at the seventy-first session of the UN General Assembly (Ref. §32 A/RES/69/229)
- 3.4 The UN Secretariat and the International Organization for Migration would <u>jointly</u> provide support for the negotiations <u>and act as Secretariat for the third UN High Level Dialogue</u>. The Global Forum for Migration and Development and the Global Migration Group would also make contributions, as would the Special Representative of the Secretary General for International Migration.
- 3.4bis We furthermore request the UN Secretary General to extent the mandate of his Special Representative for International Migration, Mr. Peter Sutherland, and additionally to entrust him with the coordination of the various relevant work-streams and contributions to the negotiations notably by the Global Forum for Migration and Development and the Global Migration Group.
- 3.5 Regional consultations in support of the negotiations would be desirable.
- 3.6 Civil society, the private sector, diaspora communities and migrants themselves would contribute to the process for the preparation of the Global Compact.
