# <u>Armed Escorts for Humanitarian Convoys: To Use or Not to Use?</u>

The ECOSOC Humanitarian Affairs Segment is an excellent platform to introduce, promote, and encourage the implementation of the updated "IASC Non-Binding Guidelines on the Use of Armed Escorts for Humanitarian Convoys" to a wide and relevant audience.

Principled civil-military coordination is facing a number of major and often interconnected challenges including restrictions imposed by State and non-State actors, the Global War on Terror, stabilization strategies, and targeted attacks on humanitarian personnel and operations. Today these guidelines are increasingly relevant given the growing complexities of the environments where humanitarian action is required and armed escorts are frequently considered as a means to obtain access to the affected people.

The guidelines are intended to assist members of Humanitarian Country Teams, and the wider humanitarian community, in making informed, collective (where possible) and coordinated decisions regarding the movement of humanitarian supplies, goods, assets and personnel. . The document is designed to assist humanitarian organisations make principled and pragmatic decisions, while balancing the humanitarian imperative with security risks and the principles of operational independence, impartiality and neutrality, necessary to maintain the civilian character of humanitarian assistance and protect humanitarian operating space.

- 5. If a decision is made to use armed escorts, what are the Guidelines' principles to assist an agency or group of agencies to do this successfully?
- 6. How can we avoid becoming dependent on armed escorts?
