Evaluation can help explain what works and what doesn't work in order to achieve better development results. **EvalPartners** and the **United Nations Evaluation Group (UNEG)** have joined forces in declaring 2015 the International Year of Evaluation. 2015 was identified as a strategic year in order to mainstream evaluation in the post-2015 development agenda at the international and national levels.

**This side event will explore what can be done to:**

- Put the issue of national evaluation capacity building on the post-2015 global agenda;
- Recognize this global grassroots movement towards the 2015 International Year of Evaluation;
- Show that Member States consider evaluation for development an important issue in a changing development landscape;
- Act as a catalyst for evaluation at the national, regional and global levels, as well as within the UN system.

**EvalPartners** is an innovative multi-stakeholders partnership to enhance national capacities to demand, supply and use evaluation in policy making so that public policies are based on evidence, and incorporate considerations of equity. EvalPartners gathers all Voluntary Organizations of Professional Evaluators (VOPEs), including 149 national VOPEs; UN agencies; Governments; private foundations; Non-Governmental Organizations and academia.
