

Preparatory Meeting for the Development Cooperation Forum 9 February, 2012, New York

The Changing Context of Development: What does it mean for Cooperation and Global Partnership

The meeting will provide an opportunity for Member States, together with leading experts, to reflect on recent major rapidly changing development context and what are its implications for development cooperation and the global partnership for development. These questions need to be addressed in the preparations for the 2012 DCF and the upcoming Rio+20 conference.

The development agenda agreed at the United Nations conferences and summits is the centerpiece of international development cooperation. In a rapidly changing development landscape, there is a widely acknowledged need for rethinking and updating the agenda.

Over the past twenty years the world has witnessed strong economic growth and significant poverty reduction. These trends are being threatened by the current economic crisis. The world has also witnessed rapidly shifting economic influence and new contours of global power structure.

These trends are redefining the traditional development cooperation. This became evident in the Fourth High- Level Forum held in Busan in November 2011. New dynamics of development cooperation offer opportunities and challenges, which should be addressed.

One of the key features of the changing development landscape is the broad agreement that the world should embark on a more sustainable path to development, while keeping the focus on poverty eradication. The upcoming 2012 United Nations Conference on Sustainable Development 2012 (Rio+20) is an opportunity to lay a strong foundation for such a development framework, with human beings and their well being at the centre. A key question is what are the implications for development cooperation.
