H.E. Nestor Osorio ECOSOC

H.E. Mr. Néstor Osorio is the President of the Economic and Social Council and the Permanent Representative of Colombia to the United Nations. Prior to his current appointment, he was the Executive Director of the International Coffee Organization and Special Advisor to his Government on Coffee and Trade Affairs and from 1994 to 1999 Colombia's Permanent Representative to the World Trade Organization. From 1978 to 1994, Mr. Osorio served as permanent representative to the International Coffee Organization. Mr. Osorio earned his Doctorate in Law from Bogotá's University del Rosario and was awarded a Doctorate in Administrative Law by the Paris-based Université de Droit, d'Économie et de Sciences Sociales. Mr. Osorio taught constitutional law and public law and economics at Rosario University.

Thomas Stelzer has been Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs at the United Nations Department of Economic and Social Affairs since March 2008. Before, he was Permanent Representative of Austria to United Nations Offices in Vienna. He has held a number of diplomatic and international posts, including Special Assistant to the Executive Secretary of the CTBTO Preparatory Commission, Deputy Director of the Austrian Cultural Institute in New York and Minister-Counsellor at the Permanent Mission of Austria to the United Nations Headquarters in New York. He obtained his doctorate in law from Vienna University, a Master of Arts in Latin American Studies from Stanford University and a diploma in International Relations from the Johns Hopkins University, School of Advanced International Studies, Bologna Center.

Sigrid Kaag UNDP



Sigrid Kaag is heading UNDP's Bureau for External Relations and Advocacy (BERA) as Assistant Secretary-General and Assistant Administrator since 1 August 2010. In this function Ms. Kaag is advising UNDP's Administrator in the direction and strategic leadership of the organization as part of the senior management team. She oversees UNDP's strategic external engagement, organization-wide communication and advocacy as well as resource mobilization. Previously, Ms. Kaag has worked among others in senior positions at UNICEF, the International Organization for Migration (IOM) and the United Nations Relief and Works Agency for Palestine Refugees (UNRWA). Sigrid Kaag started her career with Shell International

	and the Dutch Foreign Service.

Mr Bishop is also the author of "Essential Economics". Mr. Bishop chaired the World Economic Forum's Global Agenda Council on Philanthropy and Social Innovation and was a member of the Advisors Group to the United Nations International Year of Microcredit in 2005. He is on the advisory board of the Social Progress Index.

She is a professor of Economics at Faculty of Economics and Political Science, Cairo University, and currently the Executive Director of "Sawiris Foundation for Social Development" (since 2007). She is also a Board Member of the "General Fedration of Non Governomental Organization" (since 2004), General Secretary of both the "Arab Foundation Forum" (since 2009), and the "Egyptian Association for the Protection of Competition" (since 2011). Previously, she served as Executive Director of the "National Law Commission", mandated with modernizing Egypt's economic legislations (2006-2008). Concurrently, She was a board member of the "Egyptian Competition Authority" (ECA) (2005-2009), and a member of the "General Authority For Investment Board of Trustees" (GAFI) (2007). She worked closely with the Minister of Finance as an Economic Advisor (1997- 2005), and chaired the Political Participation Committee at the "National Council for Women" (2000-2003). Prof. Dr. Gannat has written extensively over the last three decades, about fiscal policies, private investments promotion and institutional reforms as well as about gender and civil society issues.

Sundaa Bridgett-Jones joined The Rockefeller Foundation in 2012. As Associate Director, International Development, she develops Foundation initiatives that contribute to global discourse on international development trends and multilateral processes concerning resilience, equitable growth, gender equality, and innovation. Prior to joining The Rockefeller Foundation, Ms. Bridgett-Jones was Acting Director for Policy Planning and Public Diplomacy with the U.S. Department of State Bureau of Democracy, Human Rights and Labor. Her previous professional experience also includes serving as an International Affairs Fellow at the Council on Foreign Relations, Director of the Scholars in the Nation's Service Initiative at Princeton University, and Special Assistant to the Assistant Secretary-General for Political Affairs for Asia and the Middle East at the United Nations. She began her career with the U.S. Agency for International Development, where she worked for nearly a decade leading democracy and governance initiatives. Ms. Bridgett-Jones holds a Master's degree in Public and International Affairs from the University of Pittsburgh and a Bachelor of Science degree in International Affairs from Georgetown University.

Barbara Lethem Ibrahim is founding director of the John D. Gerhart Center for Philanthropy and Civic Engagement, established in 2006 at the American University in Cairo. Prior to that she served as regional director for West Asia and North Africa of the Population Council and was a program officer for urban poverty and women's studies at the Ford Foundation regional office in Cairo. She serves on the board of a number of organizations, including WINGS, Worldwide Initiatives for Grantmaker Support; ICSERA, International Council of Voluntarism, Civil Society, and Social Economy Research Associations; Virtual Activism; and the Ibn Khaldoun Center for Development Studies in Cairo. She has held visiting scholar posts at the Center for the Study of Philanthropy, City University of New York; the Center for Contemporary Arab Studies, Georgetown University; and the Center on Philanthropy, Indiana University. Her most recent research and publications trace the rise of a new generation of youth activists in the Arab region. Her most recent book, From Charity to Social Change: Trends in Arab Philanthropy was published by American University in Cairo Press in 2008

and translated into Arabic. Other publications are in the areas of youth-led service organizations, faith and philanthropy, and costs of marriage and family formation in Egypt. In 1999 she was inducted into the International Educators' Hall of Fame. She received the Lifetime Achievement Award of the Association of Middle East Women's Studies in 2003.
