## High-level Meeting on Nuclear Disarmament

## **Organizational Information**

#### General

In Resolution A/Res/67/39 entitled "High-level meeting of the General Assembly on nuclear disarmament", the General Assembly decided to convene a high-level meeting of the General Assembly on nuclear disarmament, that will be held as a one day plenary meeting on 26 September 2013, to contribute to achieving the goal of nuclear disarmament.

## Structure of the High-level meeting

The one-day high-level meeting will include an opening session, two consecutive high-level plenary sessions, as well as a closing session.

## Venue and Time of the High-level meeting

The opening session of the high-level meeting will take place in the temporary General Assembly Hall in the North Lawn Building on 26 September from 9am to 10am. The two consecutive sessions as well as the closing session will take place in the Trusteeship Council Chamber in the Conference Building. The morning session will take place from 10am to 1pm, and the afternoon session from 3pm to 5.45pm. A short closing session will take place from 5.45pm to 6pm.

#### Chair

The Opening and the Closing session will be chaired by the President of the 68<sup>th</sup> Session of the General Assembly. The two consecutive substantive sessions will be chaired by General Assembly Vice-Presidents.

## List of Speakers

The list of speakers for the two consecutive sessions will be open by the end of July/early August (together with all other HLM for September) and Member States can inscribe on a first come first serve basis, following relevant protocol regulations. The opening of the list of speakers will be announced in the journal.

The opening session will hear statements from the President of the General Assembly, the UN Secretary-General, the Non-Aligned Movement as well as Heads of State or Heads of Government invited by the President of the General Assembly. There will be no open list of speakers for the opening session.

#### Time limits for statements

Due to the expected large number of Member States who would like to speak, and the meeting limited to a one-day meeting, time limit for individual statements will be 3min, and 5min for group statements. To have as many Member States participate actively in the event, the President encourages delegations to deliver a shortened version of their statements and distribute the full statements in the room. In addition, all Statements will be published on a special website set up for the High-level meeting by the Office for Disarmament Affairs.

## Civil Society Participation

The President initiated the process to draw up a list of representatives of non-governmental organizations in consultative status with the Economic and Social Council that will participate in the high-level meeting. This list will be shared with Member States as soon as available. There will be a ten minutes time slot at the end of the afternoon session to allow two representatives of civil society organisations to speak.

#### Outcome

The President will prepare a summary as the outcome of the high-level meeting, which will be issued as a document of the General Assembly. For this, the President will receive support from the substantive branches of the Secretariat.
