HELSINKI PROCESS SIDE-EVENT AT THE UN SECOND COMMITTEE 10:00-13:00 7 NOVEMBER, 2007, UN HEADQUARTERS, NEW YORK

Draft concept, 22 October 2007

BACKGROUND

With the rise of multiple non-state actors, states are no longer the sole arbiters of international policy, as different stakeholders – such as civil society, private sector and local authorities – have become as much involved in global governance. The international community has acknowledged that tackling global problems, ranging from climate change to economic crisis and debt, require new and innovative forms of cooperation between different actors and regions.

The Helsinki Process on Globalisation and Democracy, co-chaired by the governments of Finland and Tanzania, is based on the notion that various stakeholders can play a major role in accelerating thinking on global problem-solving and on implementing global commitments. Since its launch in 2002, the Helsinki Process has strived to promote more democratic governance of globalisation by fostering cooperation among different stakeholders and between the North and South.

The United Nations provides us with a unique forum for tackling the challenges and realising the possibilities of globalisation. The engagement of non-state actors in the UN has grown both in depth and quantity, but difficulties and gaps still remain. The Helsinki Process side-event aims to discuss concrete examples and best practises of multi-stakeholder cooperation in order to further promote cooperation among different actors within the UN, and in particular within the Second Committee.

- 1. What are the challenges posed by globalisation to existing governance mechanisms and what is the value-added that multi-stakeholder cooperation could bring in addressing these challenges?

- 3. What are the key lessons-learned and how could multi-stakeholder cooperation best work within the UN context?
