**Order No. 258/Corr. 1<sup>1</sup> (2016)**

1. On 17 December 2015, the United Nations Dispute Tribunal (UNDT) in Geneva issued Judgment No. UNDT/2015/116 in the cases of *Sutherland, Reid, Marcussen, Goy, Jarvis, Baig, Edgerton and Nicholls v. Secretary-General of the United Nations*.

2. Each of the eight named individuals has filed an appeal against Judgment No. UNDT/2015/116, and the Registry has registered each appeal as follows:

4. Pursuant to Article 18*bis*, subsection 1, of the Appeals Tribunal Rules of Procedure, “[t]he President may, at any time, either on a motion of a party or on his or her own volition, issue any order which appears to be appropriate for the fair and expeditious management of the case and to do justice to the parties”.

5. In light of the fact that all sixteen appeals before us challenge the same UNDT Judgment, Judgment No. UNDT/2015/116, it is “appropriate for the fair and expeditious management of the case and to do justice to the parties” to consolidate these 16 appeals for all purposes.

**IT IS HEREBY ORDERED** that, in the interests of justice, Case Nos. 2016-891 through 2016-989 and Case Nos. 2016-909 through 2016-916 shall be consolidated for all purposes.
