RECONSTRUCTION OF PUBLIC BUILDINGS

- Seven major public buildings are under reconstruction in East Timor including two in the capital Dili and five in Baucau, Ermera, Liquiça, and Oecussi districts. Since June 2000, **32 major public buildings have been completed** by East Timor Transitional Administration, now known as the East Timor Public Administration.
- This public reconstruction is being supervised by the East Timor Public Administration's **architects and engineers, both East Timorese and international.**
- The **seven buildings now under reconstruction** will house, among others, the Ministry of Health in Dili, and, outside the capital, the reconstruction includes District Administration Headquarters, Revenue, Education and Road Offices.
- So far, the East Timor Public Administration has signed contracts for the reconstruction of public buildings worth **US\$ 7.5 million.**
- **Twenty East Timorese companies and 11 foreign companies** have conducted or are conducting the rehabilitation work and have been responsible for the direct employment of more than **1,000 East Timorese workers.** Numbers will increase once all **seven projects currently under tender** start.
- This reconstruction does not include the rehabilitation of public buildings conducted by UNTAET's Assessed Budget. The budget includes: **more than 20 buildings in Dili**, including the UNTAET and Peacekeeping Headquarters and the Radio and Television Building; as well as some **240 buildings in the districts** – Civilian Police stations, civil registration offices, district field offices, power houses, transmitter stations, workshops and warehouses, all of which are part of the Public Administration's facilities.
- These figures do not include reconstruction projects in the health and education sectors, namely clinics and elementary schools (see Fact Sheets on Health and Education).
