**AFRICA**

**CAR: Sanctions: Secretariat to provide options for elaboration of benchmarks to assess arms embargo and information on recommended working group**

Resolution 2339 (2017) of 27 January 2017

Para. 29: Requests the Secretariat to provide to the Security Council, by 30 May 2017, options for the elaboration of benchmarks, in coordination with EUTM and other active partners in the field of SSR and in consultation with the CAR Authorities, to assess the arms embargo measures according to the progress of the SSR, including FACA and Internal Security Forces and their needs, as well as additional information on the Panel of Experts' recommended arms embargo working group to be potentially established within MINUSCA by the Security Council, including on the composition, tasks, functioning, resource requirements and implication with regards the implementation of MINUSCA's mandate, of such a working group, with reference to previous similar experiences in other UN Peacekeeping Missions;

The report is expected to be issued in June 2017.

**CAR: SG reports on the situation in CAR and MINUSCA**

Resolution 2301 (2016) of 26 July 2016

Para.58: Requests the Secretary-General to keep the Council regularly informed of the situation in the CAR and the implementation of the mandate of MINUSCA, to report to the Council, on 1 October 2016, and then every four months from that date, and to include in his reports to the Council updates on and recommendations related to the dynamic implementation of MINUSCA's mandated tasks, including by providing appropriate financial information, information on the security situation, the priority political elements as defined above on political progress, progress on mechanisms and capacity to advance governance and fiscal management, relevant information on the progress, promotion and protection of human rights and international humanitarian law as well as a review of the troop and police levels, force and police generation and deployment of all MINUSCA's constituent elements;

The report of the Secretary-General is expected to be issued in June 2017.

**CAR: France to report to SC on implementation of mandate to support MINUSCA**

Resolution 2301 (2016) of 26 July 2016

Para.56: Authorizes French forces, within the limits of their capacities and areas of deployment, from the commencement of the activities of MINUSCA until the end of MINUSCA's mandate as authorized in this resolution, to use all necessary means to provide operational support to elements of MINUSCA from the date of adoption of this resolution, at the request of the Secretary-General, and requests France to report to the Council on the implementation of this mandate and to coordinate its reporting with that of the Secretary-General referred to in paragraph 58 of this resolution;

### **Central African region: SG reports on UNOCA**

S/PRST/2015/12 of 11 June 2015

Last para.: The Security Council requests that the Secretary-General keep it informed through a report on the situation in Central Africa and UNOCA's activities to be submitted before 30 November 2015 and every six months thereafter, on the activities of UNOCA, progress made in conducting assessments of the LRA's evolving area of operations and logistical and support networks, and the efforts being undertaken respectively by missions in the region and relevant United Nations agencies to implement the UN's Regional Strategy.

The report of the Secretary-General dated 31 May 2017 (S/2017/465) is before the Security Council .

### **Côte d'Ivoire: UNOCI mandate**

Resolution 2284 (2016) of 28 April 2016

Para.14: Decides that the mandate of UNOCI as set out in paragraphs 15 and 18 below shall be extended for a final period until 30 June 2017;

The mandate will expire on 30 June 2017.

### **Côte d'Ivoire: Oral briefing on the completion of UNOCI's mandate and its closure**

Resolution 2284 (2016) of 28 April 2016

Para.36: Requests the Secretary-General to keep the Council regularly informed of the situation in Côte d'Ivoire, and to provide to it a report by 31 January 2017 on the implementation of the mandate of UNOCI and its phased drawdown, including an update on the continued transition of the security responsibilities to the Government of Côte d'Ivoire, and an oral briefing by 30 June 2017 on the completion of UNOCI's mandate and its closure;

The Secretary-General is expected to brief by 30 June 2017.

### **Côte d'Ivoire: French forces mandate**

Resolution 2284 (2016) of 28 April 2016

Para.25: Decides to extend until 30 June 2017 the authorization that the Security Council provided to the French Forces in order to support UNOCI, within the limits of their deployment and their capabilities;

### **DRC: SG to update SC in writing on implementation of the 31 December 2016 agreement**

Resolution 2348 (2017) of 31 March 2017

Para. 53: Requests the Secretary-General to update the Security Council in writing every 45 days on political and technical progress and obstacles to the implementation of the 31 December 2016 agreement, when no regular reports are due;

The report of the Secretary-General dated 17 May 2017 (S/2017/435) is before the Security Council.

### **DRC: SG reports on MONUSCO**

Resolution 2348 (2017) of 31 March 2017

Para. 52: Requests the Secretary-General to report to the Council every three months on the implementation of MONUSCO's mandate, including its Intervention Brigade, as set out in this resolution, including on:

- (i) progress made by the DRC on the implementation of the 31 December 2016 agreement and the electoral process, including on the provisions of paragraphs 1 to 6 above, as well as on the ways in which MONUSCO will be best prepared to address security risks and to monitor and report on human rights violations and abuses in the context of the elections, including in terms of deployment of the Force in areas identified as potential zones of instability and configuration of civilian and police component of MONUSCO, sexual violence and the impact of conflict on women and children, and any gender considerations made;
- (ii) the situation on the ground, including updates on operations to neutralize armed groups, in accordance with paragraph 34.i.d, and any instances where the Mission is not effectively fulfilling its protection of civilians mandate, and the circumstances surrounding these instances;
- (iii) progress made by the DRC on protecting human rights and in the implementation of its commitments under the PSC Framework, including through the establishment and implementation of a national SSR roadmap, its provincial stabilisation plan supported by the ISSSS and on the implementation of the DDR and DDRRR plans;
- (iv) progress in the implementation of the measures taken to transform MONUSCO's Force and improve its performance, including measures to ensure Force effectiveness as outlined in paragraphs 44 to 47, the deployment of rapidly deployable battalions and employment of the Intervention Brigade's capabilities, to become more mobile, efficient and effective in implementing its mandate, and on the definition of an exit strategy for MONUSCO, including the Intervention Brigade;
- (v) the risks and their implications for the safety and the security for the United Nations personnel and facilities as a result of the possible military operations as well as measures taken to strengthen their security and mitigate risks;

The report of the Secretary-General is expected to be issued in June 2017.

**DRC: Sanctions: Group of Experts final report**

Resolution 2293 (2016) of 23 June 2016

Para.9: Requests the Group of Experts to fulfil its mandate as consolidated below, and to provide to the Council, after discussion with the Committee, a mid-term report no later than 30 December 2016, and a final report no later than 15 June 2017, as well as submit monthly updates to the Committee, except in the months where the mid-term and final reports are due:

The final report of the Group of Experts is expected to be provided no later than 15 June 2017.

**Liberia: SG report on UNMIL and oral updates**

Resolution 2333 (2016) of 23 December 2016

Para.21: Requests the Secretary-General to keep it regularly informed of the situation in Liberia and the implementation of the mandate of UNMIL and to provide a report on the situation on the ground and implementation of this resolution no later than 15 June 2017, with an oral update for the Security Council on elections preparation no later than 31 August 2017 and another oral update after elections no later than 15 December 2017, with a concluding report by 15 April 2018;

The report of the Secretary-General is expected to be issued no later than 15 June 2017.

**Libya: UNSMIL: SG to report to SC on the implementation of resolution 2323 (2016)**

Resolution 2323 (2016) of 13 December 2016

Para.5: Requests the Secretary-General to continue to report to the Security Council on the implementation of this resolution at least every 60 days;

The Secretary-General is expected to report in June 2017.

**Libya: Authorization to inspect vessels bound to or from Libya which Member States have reasonable grounds to believe are carrying arms or related materiel to or from Libya**

Resolution 2292 (2016) of 14 June 2016

Para.3: Decides, with a view to addressing the threat posed by unsecured arms and ammunitions in Libya and their proliferation, to authorize, in these exceptional and specific circumstances for a period of 12 months from the date of this resolution Member States, acting nationally or through regional organizations, with appropriate consultations with the GNA, in order to ensure strict implementation of the arms embargo on Libya, to inspect, without undue delay, on the high seas off the coast of Libya, vessels bound to or from Libya which they have reasonable grounds to believe are carrying arms or related materiel to or from Libya, directly or indirectly, in violation of paragraphs 9 or 10 of resolution 1970 (2011), as modified by paragraph 13 of 2009 (2011), paragraphs 9 and 10 of 2095 (2013) and paragraph 8 of 2174 (2014), provided that those Member States make good-faith efforts to first obtain the consent of the vessel's flag State prior to any inspections pursuant to this paragraph, and calls upon all flag States of above-mentioned vessels to cooperate with such inspections;

The authorization will expire on 14 June 2017.

**Libya: Sanctions: Committee reports**

Resolution 1970 (2011) of 26 February 2011

Para.24: Decides to establish, in accordance with rule 28 of its provisional rules of procedure, a Committee of the Security Council consisting of all the members of the Council (herein "the Committee"), to undertake to following tasks:

(e) To report within thirty days to the Security Council on its work for the first report and thereafter to report as deemed necessary by the Committee.

The Chair of the 1970 Committee is expected to report in June 2017.

**Libya: Sanctions: Panel of Experts final report to SC**

Resolution 2278 (2016) of 31 March 2016

Para.13: Decides that the Panel shall provide to the Council an interim report on its work no later than 180 days after the Panel's appointment, and a final report to the Council, after discussion with the Committee, no later than 15 June 2017 with its findings and recommendations;

The final report of the PoE is expected to be provided no later than 15 June 2017.

**Mali: MINUSMA mandate**

Resolution 2295 (2016) of 29 June 2016

Para.14: Decides to extend the mandate of MINUSMA until 30 June 2017;

The mandate will expire on 30 June 2017.

**Mali: SG reports on MINUSMA, focusing on progress in the implementation of the Agreement on Peace and Reconciliation and MINUSMA's efforts to support it**

Resolution 2295 (2016) of 29 June 2016

Para.46: Requests the Secretary-General to report to the Security Council every three months after the adoption of this resolution on the implementation of this resolution, focusing on the progress in the implementation of the Agreement on Peace and Reconciliation in Mali and on MINUSMA's efforts to support it, and, in this regard, requests the Secretary-General to include in his December report benchmarks and timelines as referred to in paragraph 12, and, then, to report on these benchmarks in his regular reports;

The report of the Secretary-General is expected to be issued in June 2017.

**Mali: Report by France on implementation of mandate to support MINUSMA**

Resolution 2295 (2016) of 29 June 2016

Para.35: Authorizes French forces, within the limits of their capacities and areas of deployment, to use all necessary means until the end of MINUSMA's mandate as authorized in this resolution, to intervene in support of elements of MINUSMA when under imminent and serious threat upon request of the Secretary-General, and requests France to report to the Council on the implementation of this mandate in Mali and to coordinate its reporting with the reporting by the Secretary-General referred to in paragraph 46 below;

**Mali: French forces mandate**

Resolution 2295 (2016) of 29 June 2016

Para.35: Authorizes French forces, within the limits of their capacities and areas of deployment, to use all necessary means until the end of MINUSMA's mandate as authorized in this resolution, to intervene in support of elements of MINUSMA when under imminent and serious threat upon request of the Secretary-General, and requests France to report to the Council on the implementation of this mandate in Mali and to coordinate its reporting with the reporting by the Secretary-General referred to in paragraph 46 below;

**South Sudan: SG to provide detailed information on UNMISS force, impediments and obstructions**

Resolution 2327 (2016) of 16 December 2016

Para.31: Requests that the Secretary-General provide detailed information within 30 days on force generation, restructuring of the UNMISS force, logistical support and enablers, and civilian personnel to implement the mandate, as well as whether the TGNU has maintained its consent in principle to deployment of the RPF and not imposed any political or operational impediments to operationalizing the RPF or obstructed UNMISS in the performance of its mandate, and requests the Secretary-General to review needs on the ground, and provide an updated assessment of the RPF's operations, deployment, and future requirements, as well as any political or operational impediments to operationalizing the RPF and obstructions to UNMISS in performance of its mandate, within 30 days after the adoption of this resolution, and every 30 days thereafter;

The report of the Secretary-General is expected in June 2017.

**South Sudan: SG report on implementation of the UNMISS mandate**

Resolution 2327 (2016) of 16 December 2016

Para. 32: Requests the Secretary-General to report to the Council on implementation of the UNMISS mandate including UNMISS' RPF as well as to report on progress in implementing the HRDDP per paragraph 17 above, an update on how UNMISS is working toward fulfilling its protection of civilian duties, including but not limited to new patrol areas and proactive deployment per paragraph 15 above, and the consideration of gender as cross cutting through the mandate per paragraph 14 above, and to present the recommendations on the steps to adapt UNMISS to the situation on the ground and to increase efficiency of the implementation of its mandate in a same comprehensive written report to be submitted within 90 days of the date of adoption of this resolution, and every 90 days thereafter;

The report of the Secretary-General is expected to be issued in June 2017.

**South Sudan: SG to provide a review of progress made in ceasing hostilities and recommend adjustments to UNMISS mandate**

Resolution 2327 (2016) of 16 December 2016

Para. 34: Requests the Secretary-General to provide within 6 months of adoption of this resolution a review of progress made by the parties in ceasing hostilities, returning to the path of dialogue, and achieving inclusiveness within the government, as well as recommend any relevant adjustments to the UNMISS mandate;

The report of the Secretary-General is expected to be issued in June 2017.

**South Sudan: Sanctions: Panel of Experts updates**

Resolution 2353 (2017) of 24 May 2017

Para.2: Decides to extend until 30 June 2018 the mandate of the Panel of Experts as set out in subparagraphs (a), (b), (c), (e) and (f) of paragraph 12 of resolution 2290 (2016), and decides that the Panel of Experts should provide to the Council, after discussion with the Committee, an interim report by 1 December 2017, a final report by 1 May 2018, and, except in the months when these reports are due, updates each month, and expresses its intention to review the mandate and take appropriate action regarding the further extension of the mandate no later than 31 May 2018;

The update from the PoE is expected to be provided in June 2017.

**Sudan: UNAMID mandate**

Resolution 2296 (2016) of 29 June 2016

Para.1: Decides to extend the mandate of UNAMID, as set out in resolution 1769 (2007), until 30 June 2017, and further decides that UNAMID shall consist of up to 15,845 military personnel, 1,583 police personnel and 13 formed police units of up to 140 personnel each;

The mandate will expire on 30 June 2017.

**Sudan: SG reports on UNAMID**

Resolution 2296 (2016) of 29 June 2016

Para.34: Requests the Secretary-General to report to the Council every 90 days following adoption of this resolution on UNAMID, including:

- (i) information on the political, humanitarian and security situation in Darfur, including detailed reporting on incidents of violence and attacks against civilians, by whomsoever perpetrated;
- (ii) information on violations of the Status of Forces Agreement, including those involving attacks or threats of attack on UNAMID, violations of international humanitarian law perpetrated by any party to the conflict, as well as access restrictions and significant operational obstacles such as those related to customs clearances and visas;
- (iii) developments and progress towards achievement of UNAMID's strategic priorities and benchmarks, including progress in response to the Secretary General's recommendations on practical steps requested in paragraph 33 of this resolution;
- (iv) developments and progress in addressing the challenges facing UNAMID as identified in the review of UNAMID; and
- (v) on the implementation of this resolution;

The report of the Secretary-General is expected to be issued in June 2017.

**Sudan: SG recommendations on what practical steps need to be taken by Sudanese parties with support of UNAMID to make tangible progress towards achieving benchmarks**

Resolution 2296 (2016) of 29 June 2016

Para. 33. Takes note of ongoing consultations between the United Nations, the African Union and the Government of Sudan, notably in the frameworks of the Tripartite mechanism and the Joint Working Group, including discussion of operational and logistical issues pertaining to the mission's operation as well as the development of an exit strategy in accordance with the mission's benchmarks; requests the Secretary-General to make recommendations, within 120 days of the adoption of this resolution, including by building on any agreed recommendations of the Joint Working Group and undertakes to consider the Secretary-General's recommendations in due course, on what practical steps need to be taken by all Sudanese parties with the support of UNAMID in order to make tangible progress towards achieving the benchmarks;

SG Letter of 28 October (S/2016/915)

Para. 21. For that purpose, a joint African Union-United Nations strategic review should be undertaken that would provide detailed recommendations to the Security Council and the African Union Peace and Security Council on the Operation's priorities and its configuration and, if necessary, propose a further revision of the benchmarks to reflect the realities in Darfur. The strategic review should be undertaken during the month of December 2016 and be presented to the two councils by the end of January 2017. In accordance with established practice, the strategic review will be conducted in close consultation with the Government.

The report of the Chairperson of the African Union Commission and the Secretary-General dated 18 May 2017 (S/2017/437) is before the Security Council.

**Sudan: ICC Prosecutor briefing**

Resolution 1593 (2005) of 31 March 2005

Para.8. Invites the Prosecutor to address the Council within three months of the date of adoption of this resolution and every six months thereafter on actions taken pursuant to this resolution.

The ICC Prosecutor is expected to report in June 2017.



## AMERICAS

### **Colombia: SG report on implementation of the Mission's mandate**

Resolution 2261 (2016) of 25 January 2016

Para.5: Further requests the Secretary-General, based on the reporting of the special representative to the Secretary-General, to report to the Security Council on the implementation of the Mission's mandate every 90 days after the start of its monitoring and verification activities and on completion of the Mission;

SG letter of 26 October 2016 (S/2016/902)

First para.: (...) I plan to present my first progress report on the activities of the Mission by 26 December 2016, at the conclusion of the initial 90 days of its 12-month mandate.

The report of the Secretary-General is expected to be issued in June 2017.

## ASIA/MIDDLE EAST

### **Afghanistan: SG reports on UNAMA**

Resolution 2344 (2017) of 17 March 2017

Para. 37: Requests that the Secretary-General reports to the Council every three months on developments in Afghanistan, and to include in his reports an evaluation of progress made against the benchmarks for measuring and tracking progress in the implementation of UNAMA's mandate, including at the subnational level, and priorities as set out in this resolution;

The report of the Secretary-General is expected to be issued in June 2017.

### **Iraq: Authorization to maintain escrow accounts and retain funds (oil for food termination)**

Resolution 2335 (2016) of 30 December 2016

Para. 2: Authorizes the Secretary-General to continue to maintain the escrow accounts authorized in paragraphs 3, 4 and 5 of resolution 1958 (2010) and to retain the funds in those accounts until 30 June 2017, at which time all remaining funds are to be transferred to the Government of Iraq;

The authorization expires on 30 June 2017.

### **Middle East (Syria): OPCW DG to report to SC (through SG) on impl. of resolution 2118 (2013)**

Resolution 2118 (2013) of 27 September 2013

Para.12: Decides to review on a regular basis the implementation in the Syrian Arab Republic of the decision of the OPCW Executive Council of 27 September 2013 and this resolution, and requests the Director-General of the OPCW to report to the Security Council, through the Secretary-General, who shall include relevant information on United Nations activities related to the implementation of this resolution, within 30 days and every month thereafter, and requests further the Director-General of the OPCW and the Secretary-General to report in a coordinated manner, as needed, to the Security Council, non-compliance with this resolution or the OPCW Executive Council decision of 27 September 2013.

The report is expected to be presented in June 2017.

**Middle East (Syria): SG to report on implementation of resolutions 2139 (2014), 2165 (2014), 2191 (2014), 2258 (2015) and 2332 (2016)**

Resolution 2139 (2014) of 22 February 2014

Para.17: Requests the Secretary-General to report to the Council on the implementation of this resolution by all parties in Syria, in particular paragraphs 2 through 12, in 30 days of its adoption and every 30 days thereafter, and upon receipt of the Secretary-General's report, expresses its intent to take further steps in the case of non-compliance with this resolution;

Resolution 2191 (2014) of 17 December 2014

Para.5: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all parties to the Syrian domestic conflict, within the framework of its reporting on resolutions 2139 (2014) and 2165 (2014);

Resolution 2258 (2015) of 22 December 2015

Para.5: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all relevant parties in Syria, within the framework of its reporting on resolutions 2139 (2014), 2165 (2014) and 2191 (2014), and further requests the Secretary-General to include in his reports overall trends in humanitarian access;

Resolution 2332 (2016) of 21 December 2016

Para.5: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all relevant parties in Syria, within the framework of its reporting on resolutions 2139 (2014), 2165 (2014), 2191 (2014) and 2258 (2015), and further requests the Secretary-General to include in his reports overall trends in humanitarian access;

The report of the Secretary-General is expected to be issued in June 2017.

**Middle East (Syria): SG report on the implementation of resolution 2268 (2016)**

Resolution 2268 (2016) of 26 February 2016

Para.10: Requests the Secretary-General to report to the Council on the implementation of this resolution, including by drawing on information provided by the ISSG ceasefire taskforce, and on resolution 2254 (2015), within 15 days of the adoption of this resolution and every 30 days thereafter;

The Secretary-General is expected to report in June 2017.

**Middle East (Syria): JIM: SG (in coordination with OPCW DG) to present progress report**

Resolution 2319 (2016) of 17 November 2016

Para.8: Requests the United Nations Secretary-General, in coordination with the OPCW Director-General, present a report to the United Nations Security Council and inform the OPCW Executive Council every 60 days on the progress made;

The report of the Secretary-General is expected in June 2017.

**Middle East: The situation in the Middle East, including the Palestinian question**

Resolution 1322 (2000) of 7 October 2000

Para.7: Invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

**The situation in the Middle East, including the Palestinian Question: SG to report to the Council on the implementation of resolution 2334 (2016)**

Resolution 2334 (2016) of 23 December 2016

Para.12: Requests the Secretary-General to report to the Council every three months on the implementation of the provisions of the present resolution;

The Secretary-General is expected to report in June 2017.

**Middle East (UNDOF): UNDOF mandate**

Resolution 2330 (2016) of 19 December 2016

Para.11: Decides to renew the mandate of UNDOF for a period of six months, that is, until 30 June 2017, and requests the Secretary-General to ensure that UNDOF has the required capacity and resources to fulfil the mandate in a safe and secure way;

The mandate will expire on 30 June 2017.

**Middle East (UNDOF): SG reports on developments in the situation and measures taken to implement resolution 338 (1973)**

Resolution 2330 (2016) of 19 December 2016

Para.12: Requests the Secretary-General to report every 90 days on developments in the situation and the measures taken to implement resolution 338 (1973).

The report of the Secretary-General is expected to be issued in June 2017.

**UNRCCA: SG to inform SC about activities**

PSC Letter of 15 May 2007 (S/2007/280)

I have the honour to inform you that your letter dated 7 May 2007 (S/2007/279) concerning your intention to establish a United Nations Regional Centre for Preventive Diplomacy in Ashgabat has been brought to the attention of the members of the Security Council. They take note of the information contained in your letter and the intention expressed therein, and invite you to inform them about the activities of the newly established Centre and its impact on the ground. They would welcome receiving such a report, for example, six months after the Centre becomes fully operational.

The Secretary-General is expected to report in June 2017.

**OTHER**

**Cooperation between UN and regional/subregional organizations: SG to continue working closely with the AU to refine options for further cooperation on the relevant AU proposals for support for AU peace support operations and provide the SC with a detailed report**

Resolution 2320 (2016) of 18 November 2016

Para.8: Requests the Secretary-General to continue working closely with the AU to refine options for further cooperation on the relevant AU proposals, including joint planning and the process for mandating AU peace support operations, subject to authorization by the Security Council and to provide the Security Council with a detailed report within six months of the adoption of this resolution;

The report of the Secretary-General dated 25 May (S/2017/454) is before the Security Council.

**Cooperation between UN and regional/subregional organizations: SG to include in regular reporting assessments of progress on the cooperation between the UN and relevant regional organizations**

Resolution 1809 (2008) of 16 April 2008

Para.17: Requests the Secretary-General to include in his regular reporting to the Security Council, assessments of progress on the cooperation between the United Nations and relevant regional organizations;

The report of the Secretary-General dated 15 July 2016 (S/2016/621) is before the Security Council.

**ISIL (Da'esh) and Al-Qaeda: SG strategic-level reports**

Resolution 2253 (2015) of 17 December 2015

Para.97: Recalling the threat posed to international peace and security by ISIL and associated individuals, groups, undertakings, and entities, requests the Secretary-General to provide an initial strategic-level report that demonstrates and reflects the gravity of the aforementioned threat, including foreign terrorist fighters joining ISIL and associated groups and entities, and the sources of financing of these groups including through illicit trade in oil, antiquities, and other natural resources, as well as their planning and facilitation of attacks, and reflects the range of United Nations efforts in support of Member States in countering this threat, in 45 days and provide updates every four months thereafter, with the input of CTED, in close collaboration with the Monitoring Team, as well as other relevant United Nations actors;

The report of the Secretary-General is expected to be issued in June 2017.

**ICTY: Assessments by President/Prosecutor**

Resolution 1534 (2004) of 26 March 2004

Para.6: Requests each Tribunal to provide to the Council, by 31 May 2004 and every six months thereafter, assessments by its President and Prosecutor, setting out in detail the progress made towards implementation of the Completion Strategy of the Tribunal, explaining what measures have been taken to implement the Completion Strategy and what measures remain to be taken, including the transfer of cases involving intermediate and lower rank accused to competent national jurisdictions; and expresses the intention of the Council to meet with the President and Prosecutor of each Tribunal to discuss these assessments.

The letter from the ICTY President dated 17 May 2017 (S/2017/436) is before the Security Council.

**Non-proliferation (Iran): Joint Commission reports**

Resolution 2231 (2015) of 20 July 2015

JCPOA Annex IV – Joint Commission para. 6.10.: The Joint Commission will report to the United Nations Security Council at least every 6 months on the status of the Procurement Working Group's decisions and on any implementation issues.

Facilitator's proposal as agreed on 17 March 2017

The Joint Commission is expected to report in June 2017.

**Non-proliferation (Iran): Facilitator to brief the other members of the SC**

Note by the PSC of 16 January 2016

Para.3: To facilitate its work under resolution 2231 (2015), the Security Council shall select on an annual basis one member to serve as its facilitator for the functions specified in the present note. The facilitator shall brief the other members of the Council on its work and the implementation of the resolution every six months, in parallel with the report submitted by the Secretary-General in accordance with paragraph 7 below.

Faciliator's proposal as agreed on 17 March 2017

The Facilitator is expected to brief in June 2017.

**Non-proliferation (Iran): SG reports on the implementation of resolution 2231 (2015)**

Note by the PSC of 16 January 2016

Para.7: The Security Council requests that the Secretary-General report to the Security Council every six months on the implementation of resolution 2231 (2015). Prior to the public release of that report, the Security Council shall meet informally, normally at the expert level, to review the findings and recommendations contained in the report.

Faciliator's proposal as agreed on 17 March 2017

The report of the Secretary-General is expected to be issued in June 2017.

**Peacekeeping operations: SG report on the role of policing**

Resolution 2185 (2014) of 20 November 2014

Para.33: Requests the Secretary-General to submit a report by the end of 2016 on the role of policing as an integral part of peacekeeping and post-conflict peacebuilding, with particular focus on the challenges faced by Police Components of United Nations peacekeeping operations and special political missions, and making recommendations on how best to strengthen their contribution to the achievement of mission mandates.

**Terrorism/Cross-border crime: SG report on UN efforts to address the threat of terrorists benefitting from transnational organized crime in affected regions**

Para.20: Requests the Secretary-General to submit to the Council a report on the efforts of the United Nations entities to address the threat of terrorists benefitting from transnational organized crime in affected regions, including Africa, with respect to matters with which the Council is seized, with input from the relevant entities of the United Nations system including the UNODC, CTED, the Analytical Support and Sanctions Monitoring Team, and other relevant CTITF entities;

Para.21: Further requests that the report include recommendations of concrete options for strengthening Member States' capabilities, including financing such proposed UN projects and activities to build capacity with existing resources and contributions in the UN system, as well as UN activities to reduce the negative impacts of terrorists benefitting from transnational organized crime including those relevant to its conflict resolution efforts with a focus on border security, counter-terrorist financing, and anti-money-laundering, and that the report be submitted to the Council no later than six months from the adoption of this resolution;

**Women and peace and security: Annual reports on the implementation of resolutions on WPS and resolution 2106 (2013) (SVC)**
