## **II. ANNOTATIONS TO THE PROVISIONAL AGENDA**

1. At its eleventh session, the Commission on Sustainable Development decided that its multi-year programme of work beyond 2003 would be organized on the basis of seven two-year cycles, with each cycle focusing on selected thematic clusters of issues. Each "implementation cycle" would consist of a review year and a policy year. In the review year, the Commission would evaluate the progress made in implementing sustainable development goals and identifying obstacles and constraints, while in the policy year it would decide on measures to speed up implementation and mobilize action to overcome these obstacles and constraints.
2. The Commission furthermore invited the United Nations regional commissions to organize regional implementation meetings to provide regional inputs for the work of the Commission, preferably before the review sessions. The Economic Commission for Europe held three Regional Implementation Meetings on Sustainable Development, in January 2004, December 2005 and January 2008, respectively, as a contribution to the twelfth, the fourteenth and the sixteenth sessions of the Commission on Sustainable Development.
3. The Commission on Sustainable Development has now started its fourth two-year cycle. Its eighteenth session is scheduled to be held from 3 to 14 May 2010 and will focus on the following thematic clusters: transport; chemicals; waste management; mining; and the 10-Year Framework of Programmes on Sustainable Consumption and Production Patterns. Linkages to cross-cutting issues<sup>1</sup> will also be addressed, as in every cycle.
4. In line with the above, the Economic Commission for Europe at its sixty-third session decided to hold the Fourth Regional Implementation Meeting on 1 and 2 December 2009 in Geneva, as a contribution to the eighteenth session of the Commission on Sustainable Development (CSD-18).
5. The Fourth Regional Implementation Meeting will specifically address the role of partnerships and interlinkages between the thematic priorities within each session. The Meeting

will focus on evaluation of the progress achieved and obstacles and constraints remaining in each thematic area. It will also assess the challenges ahead and necessary next steps to be taken.

6. Each session will have a different high-level chairperson. The session will be opened with a keynote address. Subsequently, two additional prepared statements will be presented, one from a government representative and one from a major group representative, followed by an open interactive discussion from the floor.

A set of three to four questions will be prepared in advance with a view to facilitate the discussion. The Chairperson of the session will summarize the discussion.

**Item 9. The 10-Year Framework of Programmes on Sustainable Consumption and Production Patterns**

**Item 10. Cross-cutting issues and interlinkages**

18. The session will review the current situation with regard to cross-cutting issues and interlinkages (see para.3 of this document). The session will open with a keynote address by a minister or other high-level official. Subsequently, two additional prepared statements will be presented, one from a government representative and one from a representative of a major group, followed by an open interactive discussion from the floor. A set of three to four questions will be prepared in advance with a view to facilitate the discussion. The Chairperson of the session will summarize the discussion.

**Item 11. Chairperson's summary and closure of the meeting**

19. The Chairperson will present her/his summary of the meeting, which will be submitted as the regional contribution of the Economic Commission for Europe to CSD-18.

The Chairperson's summary will focus on breakthroughs achieved and on obstacles encountered regarding the implementation of actions, measures and partnerships related to the priority clusters and cross-cutting issues; on this basis, the summary could also highlight key messages for the policy session.
