- TITLE OF FUND:** Trust Fund to Support Activities to the Follow-up to the International Conference on Financing for Development (HIA)
- IMPLEMENTED BY:** Financing for Development Office (FFDO)/Department for Economic and Social Affairs
- OBJECTIVES:** To support the follow-up process to the International Conference on Financing for Development (Monterrey, Mexico, 18-22 March 2002)

ACTIVITIES FUNDED:

- (a) Travel of experts to multi-stakeholder consultations on Sovereign Debt Restructuring (18 May 2012, New York), (19 September 2012, London) and (12 October 2012, Tokyo)
- (b) Travel of representatives to attend official events of the FfD follow-up process, including: (a) consultations between the ECOSOC Bureau and the Executive Boards of the World Bank and IMF (22 February 2012, Washington DC)
- (c) Travel of staff to attend multi-stakeholder consultations, conferences, regional meetings and other events on the follow-up to the Monterrey Consensus and Doha Declaration on Financing for Development and representation of DESA at various meetings on FfD-related matters.

OUTPUTS:

The above-mentioned extra budgetary activities supported the following outputs as listed in the Proposed Programme Budget for the biennium 2012-2013:

Parliamentary documentation: multi-stakeholder reports for the annual spring meetings of the Council with the Bretton Woods institutions, the World Trade Organization and UNCTAD on financing for development; 9.96 (b) Other substantive activities: (ii) Non-recurrent publications: outcomes of multi-stakeholder consultations on financing for development; (vi) Seminars for outside users: seminars and interactive discussions with the participation of Governments, institutional and non-institutional stakeholders (civil society and the private sector) on financing for development; (c) (ii) regional seminars/workshops, organized in cooperation with the United Nations regional commissions (Economic Commission for Africa, Economic Commission for Europe, Economic Commission for Latin America and the Caribbean, Economic and Social Commission for Asia and the Pacific and Economic and Social Commission for Western Asia) and regional development banks, with the participation of representatives of relevant institutional and non-institutional stakeholders, on region-specific policy issues related to the implementation of the Monterrey Consensus and its follow-up; training courses/workshops for officials and practitioners from developing countries and countries with economies in transition for national capacity-building in selected areas of financial sector development and fiscal management.
