



## Group Meetings on "Capacity Building on Tax Treaty Negotiation and Administration" 28-29 January 2013 Rome. Italy

# **INFORMATION NOTE**

# General

The Financing for Development Office (FfDO) of UN-DESA and the International Tax Compact (ITC) are jointly organizing two parallel meetings on "Capacity Building on Tax Treaty Negotiation and Administration", to be held on 28-29 January 2013, at the International Fund for Agricultural Development (IFAD) Headquarters, Via Paolo di Dono, 44 00142 Rome, Italy.

# How to get to IFAD

<u>Metro:</u> IFAD Headquarters is a 15 minute walk from the Laurentina Metro station, the last stop on the Metro Line B, which directly connects with the city centre of Rome. The station also serves as a bus terminal. Tickets for public transportation can be purchased at Metro stations (self-service machines), tobacco shops, and newspaper kiosks. They have a validation time of 75 minutes including one underground transport and unlimited bus travel.

<u>Shuttle bus service</u>: A shuttle bus service runs from Monday to Friday (with the exception of IFAD holidays) from 7:40 to 9:25 am between Laurentina Metro Station and IFAD Headquarters and from 16:45 to 18:50 pm from IFAD Headquarters to Laurentina. The pick-up and drop-off point at Laurentina station is on Viale Luca Gaurico, on the main road behind the station. The drop-off and pick-up at IFAD Headquarters is at the regular yellow bus stop adjacent to the main entrance of the guardhouse (between via Paolo di Dono, 44-82).

<u>Airports</u>: The two main airports in Rome are Leonardo da Vinci (Fiumicino) Airport and Ciampino Airport. Fiumicino Airport is 36 km west of Rome and Ciampino Airport is 16 km southwest of Rome. Fiumicino can easily be reached by public transport on Line B). From Ciampino Airport there are Terravision shuttle buses connecting with Termini Station. There is no direct rail connection to the city centre from Ciampino airport.

# Organization of the meeting

There will be joint <u>opening session</u> for both meetings, which will be held on 28 January 2013, from 9:30 a.m. – 10:20 a.m. in the Oval Room S120 which is located on the (- 1) floor. Following the opening, the meetings will split into their respective parallel sessions. The parallel sessions of the Group Meeting on "Capacity Building on Tax Treaty <u>Negotiation</u>" will be held in Conference Room C-100, which is located at the 1<sup>st</sup> floor. The parallel sessions of the Group Meeting on "Capacity Building on Tax Treaty <u>Administration</u>" will be held in Conference Room C-500, which is located at the 5<sup>th</sup> floor.

In the course of the meetings there will be additional joint sessions, which will be held in the Oval Room S120 on the (-1) floor. Please refer to the tentative programme of the meetings for more detailed information on the programme.

### **Registration and Identification Badge**

Participants will receive their IFAD guest passes at the IFAD Security main gate, upon presenting a valid photo ID (Passport, National ID or Driver's license). Participants are advised to arrive by 9:00 a.m. to complete the security procedures.

Participants will collect their Identification Badges at the Registration Desk just outside the Oval Room S-120 located on the (-1) floor. For identification and security reasons, all participants are requested to wear their badges at all times during the meeting.

Only the names of duly registered participants will be included in the provisional list of participants.
