- 1. We understand that encouraging the submission of more voluntary national reports (VNRs) is crucial for gauging the level of achievement of the Global Forest Goals. In this respect, we put high importance on the VNRs. As previously mentioned at UNFF17, we think that the UNFF Secretariat should establish first a draft roadmap and timeline for the next reporting cycle. This would help stimulate member countries to start working on their VNRs more easily.
- 2. We think that the UNFF Secretariat would be more effective in generating its own voice, if it starts seeing a substantially higher submission rate for its voluntary national reports from member states. This would be proprietary data, and would provide the UNFF with an authoritative voice in the field, based on direct submission of information from its member base. More thought should be given on how this could be improved upon, as a future guide for UNFF's course of action.
- 3. We do not appreciate the UNFF replicating courses of actions, for example, of other CPF members' mandates, especially by trying to develop projects in those verticals. The UNFF is a discussion forum, not a project development/implementation office, and we are concerned to see programming budget documents that appear to imply that it is, seeking to measure UNFF results based on writing up projects for a couple of countries. That is not the core function of this body.
- 4. CPF member organizations have their own governing bodies, and may not be in a position to "support" the UNFF in its policy development work, particularly if the work could be duplicative. As the Secretariat of the CPF, UNFF needs to think about how it could reinforce voluntary collaboration in areas which are cross cutting and which also would not represent duplication of effort. This could involve magnifying existing bodies of work, as appropriate, with the appropriate attribution of entities involved.
- 5. Websites are expensive and difficult to upkeep. Monitor and report on traffic measures (number of click throughs, unique users accessing information) to gauge impact. If there is dwindling traffic over the website, it could be indicative of a need for a review as to the usefulness of the website.
- 6. Do not propose measures that cannot be operationalized or be approved under the context of UN rules, regulations and /or existing mandate structure of the UNFF.
- 7. Given request to increase efficiency in the operations of the network, the proposal should primarily focus on how it could enhance delivery under the existing setup of the organization.

- 2. We strongly suggest independent consultants carry out this work, connecting with Secretariat staff, but without external influence on their findings. An organizational chart and historical timeline documenting staff size would helpful to include, as well as documenting past CPF secondments to the Secretariat staff.
- 3. It is important for the consultants to speak directly with a broad and diverse group of CPF focal points, including but not limited to FAO. CPF members did not have a chance to provide input on this section of the Annex; we highly value their views, especially on #3 "considering the suitability of establishing criteria for membership of the Partnership."
- 4. We suggest consultants speak with a range of sources to examine actions related to GFFFN, such as Member States that have worked with the Network, donor countries, private sector professionals that have presented at past UNFF sessions, and past and present UNFF GFFFN Secretariat staff.
- 5. We are interested in charting historical data and contributions to the trust fund and their impact on core activities. We suggest consultants speak with donor countries that may have stopped contributing in recent years to the trust fund.
- 6. We appreciate the detailed actions listed in the implementation of the UNSPF section regarding the exploration of the suitability and timeline for the next national voluntary report deadline after the publication of the FRA. We suggest consultants review the outcomes and discussions of the December 2021 MAR EGM and its post-EGM survey for a fulsome review.
