Voluntary National Report to the 11th Session of the United Nations Forum on Forests

Background

The eleventh session of the United Nations Forum on Forests (UNFF11) will be held from 4 to 15 May 2015 in New York. In accordance with the Forum's Multi-Year Program of Work for 2007-2015, the overall theme of UNFF11 is *Forests: progress, challenges and the way forward on the international arrangement on forests (IAF)*. The UNFF11 will, *inter-alia*:

- 1. Review progress towards the achievement of the Global Objectives on Forests (GOFs) and implementation of the Non-Legally Binding Instrument on All Types of Forests (hereinafter referred to as the "Forest Instrument"), and
- 2. Review the contribution of forests and the IAF, including the Forest Instrument, to the internationally agreed development goals, including the Millennium Development Goals (MDGs).

The submission of national reports by UNFF Member States on the above items will provide a crucial input to the Secretary-General's analytical, consolidated report to UNFF11 on the progress and trends in the above-mentioned areas, as well as to the Forum's deliberation on the future of the IAF.

Pursuant to Resolution 10/1 of the tenth session of the Forum¹, the UNFF Secretariat (UNFFS) in collaboration with the CPF member organizations and in close consultations with countries, revised and streamlined the reporting format. The attached revised format builds on and further simplifies the UNFF10 reporting format. Specifically, the number of questions has been reduced by consolidating previous areas of overlap, and Member States are asked to submit <u>only information that is not currently provided</u> to CPF member organizations, or that is unavailable in other international databases.

The UNFF11 reporting format is presented in two parts. Part I includes questions related to the progress on the implementation of the Forest Instrument, including achievement of the GOFs. Part II includes questions on the contribution of forests and SFM to the achievement of the MDGs.

To the extent possible, the information submitted by countries to the UNFFS will be supplemented with quantitative data, *inter alia*, from the following international data providers:

- FAO, Forest Resources Assessment (FRA)/Collaborative Forest Resources Questionnaire (CRFQ) FAO, Forest Europe, UNECE, ITTO, Montreal Process and OFAC
- Joint Forest Sector Questionnaire (JFSQ) FAO, ITTO, UNECE, EUROSTAT
- FAO, State of the World's Forests (SOFO) 2014
- Forest Stewardship Council (FSC) and Programme for the Endorsement of Forest Certification (PEFC).

- 3. Submit any graphic elements included in their national report, as separate electronic files.
- 4. Check all boxes that apply to questions that have multiple-choice components. In addition to the "Yes" or "No" answers, countries are encouraged to provide brief descriptive narratives, as this provides context and background. Please also note that space provided for the descriptive information is limited to 250 words per question.

The system provides accurate accounting of forest resources in the online mode and is based on marking timber by special barcode tags and use of mobile electronic devices for accounting operations in forest conditions.
- In accordance with the current Ukrainian legislation certificate of origin of timber is required for export transactions. This certificate confirms the legality of timber harvesting. State forest enterprises are carried out work focused on improvement of forest infrastructure. At present the density of forest road network in Ukraine is 7.3 km per 1 thou ha (in Europe -32-36 km per 1 thou ha). Amount of forest roads construction is growing every year: 2007-2010 years - 709 km; 2011 - 460.6 km; 2012 - 943,2 km; 2013 - 1132 km Further construction of forest roads will facilitate the implementation of complex environmental measures aiming to improve forest maintenance, protection against fires, improve forest recreational potential and support tourism development.

- Very different climatic and geographic condition within a country what caused very unequal forest distribution. Forests growth in various natural areas (Polessye, Forest steppe, Steppe, Mountain Ukrainian Carpathians and Crimea), which have significant differences in growing conditions and requires different forest management approaches.
- Mainly ecological importance of forests and high proportion (50%) forests with restriction on forest use.
- 16.6% of forest lands are reserved with a strong tendency to increasing of reserved areas. It is leading to a very low intensity of use of forest resources.
- Historically formed situation of giving state forests for permanent use to enterprises, institutions and organizations under subordination of several dozen ministries and agencies;
- Half of Ukrainian forests is artificially created and requires intensive care.
- Significant part of Ukrainian forests is affected by Chernobyl catastrophe.
- Unsufficient level of financial support for forestry.

Conducting drawing and esse competition within pupils on the theme "Human and Forest" is also part of the campaign.

Regional departmants of the State Forest Resources Agency of Ukraine are also held regional campaigns, in particular "Plant your tree", "House for the birds" etc.

Objective 1

State Forest Resources Agency of Ukraine is provided activities aimed at preserving and enlargement forest area. In Ukraine every second hectare of forest is created artificially according to afforestation and forest regeneration work. Every year, new forests are created on an area not less than 35-40 thou hectares. Thus, the area covered by forest in Ukraine and its growing stock is increased steadily. Volumes of created new forests for the last 3 years are 1.5 times more than the area of annual clear cutting.

Question of increasing forest cover in Ukraine is included in the priority areas of forest sector development.

For providing large-scale afforestation it is created sufficient facilities. Under the responsibility of state forest enterprises there are operating 2,2 thou ha of permanent and temporary nurseries and greenhouses where it is growing annually over 400 million standard planting material of valuable forest species

Objective 2

Forest Ukraine is crucial for rural areas aiming empoyment for rural population. Besides forest enterprises in most cases, is the largest source of pumping up the local budgets in the northen and westen part of the country

Objective 3

According the latest forest inventory 13,2% of Ukrainian forests are reserved. In comparison - in a total 6% of whole country territory is reserved. Practically in every region level of reserved forests is much higher the in average figures.

A significant percentage of protected forests in Ukraine shows that forestry was created strict criteria on the management principles and they fully meet all European strategy for the conservation of biological and landscape diversity.

Objective 4

State target oriented program "Forests of Ukraine" for 2010-2015 was adopted by Ukrainian Government by Resolution of 16.09.09 № 977.

State target oriented Program "Forests of Ukraine" is the main normative document for forest management in Ukraine, which presents the main indicators of forest management within the largest permanent forest users.

The main objective of a new program is ensuring sustainable forest management, enhancing environmental, social and economic functions of forests in Ukraine. The strategic objective is further increasing area, stability and productivity of forest stands.

All work associated with the implementation of planned activities are carried out by the state and local budget means, revenue received from wood, wood products and services. From state budget there are mainly funded activities on afforestation, protection of forests against fire, pests and diseases, partially solved problem of purchasing forestry equipment and construction of forest roads.
