Poverty prevention

Education

- ▶ Full enrollment in primary education lays the foundation for eradicating illiteracy and promotes lifelong learning
 - ▶ Increased access to education in younger age will ease problems dealing with technological change throughout life
 - ▶ Knowledge-based society requires policies that ensure lifelong access to education and training
- Increasing educational attainment will contribute to poverty prevention in old age

Poverty prevention

Employment

- ▶ Empower older persons to actively participate in their societies and to work as long as they wish
 - ▶ Facilitate access to credit and micro-credit
 - ▶ Ensure continuous training and skills updating
 - ▶ Enable reconciliation of work with care-giving responsibilities
- Elements will contribute to the sustainability of social protection systems and the eradication of poverty

Regional Workshop on Ageing and Poverty, Tanzania

Objectives:

- ▶ Exploration of practical links between the agreements made in Madrid in 2002 and poverty related operational programmes in sub-Saharan Africa.
- ▶ Review of evidence on ageing and poverty across Africa
- ▶ Development of recommendations for governments, international financial institutions, development agencies and civil society for the incorporation of ageing into national poverty strategies, PRSPs and the MDGs.

Regional Workshop on Ageing and Poverty, Tanzania cont'd

Findings:

- ▶ Participation in poverty eradication policy designs allows older persons to become full partners in development.
- ▶ Mainstreaming the concerns of older persons is necessary for linking ageing to existing policy and operational programming instruments.
- ▶ National capacity has to be strengthened and awareness of the rights and priority needs of the older poor is needed.

Interregional Meeting on National Implementation of the MIPAA, Austria

Objectives:

- ▶ Identify obstacles to national level implementation of MIPAA
- ▶ Produce guidelines to mainstream the issue of ageing into national development agendas
- ▶ Contribute to the development of a technical assistance programme for national capacity building for the implementation and follow-up of MIPAA
- ▶ Identify pilot countries for capacity building and training

Interregional Meeting on National Implementation of the MIPAA, Austria cont'd

Findings:

- ▶ View older persons as active agents of development
- ▶ Need for more disaggregated data to contribute to a more accurate view of the living conditions of older persons
- ▶ Recognize the often inherent bias against older persons and how it will affect the outcomes of policies if not addressed consciously
- ▶ Empowerment and participation are important vehicles in efforts to mainstream the concerns of older persons

International Action

HelpAge International

Older Citizens Monitoring Project

- ▶ Aims at engaging older persons with relevant agencies
- ▶ Supports local and national advocacy with and by older people
- ▶ Develops locally relevant indicators and benchmarks
- ▶ Promotes dialogue with local and international development agencies

International Action

UNFPA

- ▶ Conducts participatory exercises at the country level for needs assessment and programme development
- ▶ Currently in the process of finalizing a guidance note on population ageing, which will encourage country offices to advocate for the mainstreaming of population ageing into national development frameworks and poverty reduction strategies

International Action

UN Statistics Division

Suggestions for the 2010 round of national censuses:

- ▶ Review of the age and sex categories for disaggregation of data on a wide range of demographic and social characteristics (e.g. income, poverty) of the population
- ▶ Raise upper age cut-off for tabulating the data to 100 years plus
- ▶ Provide national numerical frameworks for review and appraisal of the MIPAA

International Action

UN Programme on Ageing

- ▶ Provided technical cooperation on policy development concerning ageing and older persons in Senegal, Egypt, and Kyrgyzstan
- ▶ Drafted a strategy paper on 'Mainstreaming the concerns of older persons into the social development agenda'
- ▶ Developed an indicators chart to review and appraise the implementation of MIPAA including progress with regard to reducing poverty of older persons

What needs to be done?

- ▶ More age-disaggregated data for informed policy interventions
- ▶ National indicators' development to evaluate the living conditions of older persons
- ▶ Mainstreaming the concerns of older persons into the budget and all relevant policies
- ▶ Awareness raising, advocacy and education (MDGs, PRSPs, media)
- ▶ Better coordination of global, regional, national and local efforts regarding policy development
