Affairs for the biennium 2010-2011****Note by the Secretariat**

1. The draft programme of work of the Division for Social Policy and Development, Department of Economic and Social Affairs, for the biennium 2010-2011 (see annex) is submitted for the consideration of the Commission for Social Development in compliance with the Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, the Monitoring of Implementation and the Methods of Evaluation.
2. The General Assembly has already approved in its resolution 63/247 the biennial programme plan for the period 2010-2011, which includes the elements of the “programme narrative”, namely the objectives, expected accomplishments and indicators of achievement of the subprogramme.
3. The draft programme of work presented in the annex includes, in addition to the programme narrative, a list of outputs, which has been formulated within the framework of subprogramme 3 (social policy and development) of programme 7 (economic and social affairs) for the period 2010-2011.
4. The Commission is invited to take note of the programme narrative and review the proposed outputs to be included in the Secretary-General’s proposed programme budget for the biennium 2010-2011, which will be submitted to the Advisory Committee on Administrative and Budgetary Questions and the General Assembly at its sixty-fourth session.

Subprogramme 3: Social policy and development

The subprogramme falls within the responsibility of the Division for Social Policy and Development and has been formulated drawing on subprogramme 3 of programme 7 of the proposed biennial programme plan and priorities for the period 2010-2011.

Objective of the Organization: to strengthen international cooperation, raise awareness on the importance of social development and enhance national capacity with particular attention to poverty eradication, employment generation and social inclusion, especially with due regard to issues relating to older persons, persons with disabilities, family, youth and indigenous peoples

Strategy

The strategy will include:

- (a) Promoting greater awareness of and supporting the integrated follow-up to and the implementation, within the overall orientation provided by the United Nations Millennium Declaration and the 2005 World Summit Outcome, of the commitments agreed upon at relevant United Nations conferences and summits, especially the World Summit for Social Development and the twenty-fourth special session of the General Assembly; the Second United Nations Decade for the Eradication of Poverty; the preparation towards the International Year of Cooperatives; the Convention on the Rights of Persons with Disabilities; the Programme of Action for Youth; the follow-up to the Second World Assembly on Ageing; the Programme on Family; the United Nations Declaration on the Rights of Indigenous Peoples and the mandates of the Permanent Forum on Indigenous Issues and the Second International Decade of the World's Indigenous People, with emphasis on greater integration of social and economic concerns and objectives in policymaking;
- (b) Supporting the strengthening of technical and institutional capacity of Member States and of civil society to develop and implement inclusive policies and programmes for social development.

Outputs

During the biennium 2010-2011, the following final outputs will be delivered:

- (ii) Training courses, seminars and workshops: applied research, field studies, and electronic publications, as well as group training, including symposia, seminars and workshops to promote networking, capacity-building, advocacy and capacity-building

for policy research, policy planning, implementation, and evaluation of development programmes and policies;

- (iii) Field projects: for piloting, operationalizing institutional capacities and technology transfer in policy formulation, programme and project development and programme management at the country level.
