The official and self-organised space for children and youth in certain intergovernmental and allied process at the

United Nations

Vision of UN MGCY

Children and youth are planning, designing, implementing, monitoring, reviewing and evaluating sustainable

development policies.

What gives us the mandate?

1) Agenda 21

2) UN General Assembly Resolutions (such as 2013's A/Res/67/290)

3) Agreements with UN bodies and conferences

Who are Members?

- 1. Any individual 30 years old or under who signs up to the MGCY online or in person.
- 2. Any organisation, network, commiQee, group or other association of individuals that signs up to the MGCY online or in person and that fulfills either of the following requirements:
 - a. Representative of the interests of children and/or youth, and has a policymaking body controlled by people 30 years old or under; or
 - b. Works with children and/or youth but doesn't have a policymaking body controlled by individuals 30 years old or under.

	Organising Partners (OPs) Eligible Organisations mandated to co-ordinate the activities of the UN Major group for Children and Youth (UN MGY). One permanent (legal entity and board) and 5 elected eligible organisations collectively make up the OPs. Mandated Tasks

- Facilitation, Governance and Outreach as pertains to External Working Groups.
- Liaising with the UN on Respective Policies in coordination with OPs. Coordinating statements, Facilitating position development and Advocacy.

Children and Youth International is the board and the legal entity of the UN MGCY. All MGCY Participants are members of Children and Youth International.

Selection/Election

- The board members of CYI are elected in a staggered manner at the annual UN
- MGCY General Assembly (Votes are distributed as 50 50 %.)
- All named/lead people of OP organisations are on the board ex officio.
- CYI takes up a permanent, non-elected OP place to ensure continuity for the MGCY at the UN. There is no named OP for CYI.

- The decision to establish such focal points can be based on a UN mandate or a decision taken by the Working Group.
- The mission of the UN MGCY RFPs is to facilitate and coordinate the children and youth engagement in the specific process for their respective regions. The importance of this position can not be understated as it will allow for the necessary outreach work to be competently carried out, while ensuring the prioritization of challenges specific to constituents of those regions.



Policy recommendation

- 1. Deliver social services and social protection for all, especially lifelong learning-education, health, water and sanitation through a rights based approach that delinks a any status of a person from access to these, specially age in the context.
- 2. Public Spaces are emerging as a critical priority in the Habitat III process, they will only be fully effective if that can be accessed by people of all ages and abilities. The accessibility to all is what makes a space public.
- 3. Disaggregation has become a buzzword in the process, but we need to focus and shift attention to investment in statistical capacity so as we can actually be able to do this and operationalise its intended promise.

What we can do?

- 1. Recognise stakeholders on ageing as one of key partners and mainstream aging across all groups. Both are needed, one is not a substitute for another.
- 2. Do not be silo when we are criticising silo approach. As age issues are not just age issues, they are sustainable development issues that are need to be age proofed. Old people are not only users of social security, but resources of knowledge and expertise, and are also affected by unsustainable consumption and production patterns as well.
- 3. An intergenerational approach, does not only imply that the world and older generations owe something to the young. We too need to play our role in designing agendas and Implementing projects designed for all ages and abilities.
