At its fourteenth session in 2015, the Permanent Forum will review the following: (a) Outcome of the high-level plenary also known as the World Conference on Indigenous Peoples; (b) Post-2015 Development Agenda; (c) Youth, self-harm and suicide.

1. Please provide information on how your agency is working with these important issues in the seven socio-cultural regions of the Permanent Forum¹. Where possible, please include information on the situation of indigenous women in your responses.

FAO, together with the rest of the Inter-Agency Support Group on Indigenous Peoples' Issues, is fully participating in the discussions and preparation of the System-wide action plan (SWAP) to ensure a coherent approach to achieving the ends of the UNDRIP, as requested in the Outcome document of the WCIP.

The core of the SWAP will be to integrate the action plan within key regional initiatives and relevant national programmes.

At the national level, it was discussed together with IASG that the UNDAF should accommodate an additional objective in key countries with significant indigenous population in order to include an objective related to the SWAP.

The SWAP will be integrated in the Post 2015 efforts that the different UN agencies are leading.

FAO will work on the Governance of tenure of lands, territories, natural resources and fisheries, as well as on indigenous food systems and traditional knowledge.

In addition, FAO has started a capacity development programme of indigenous women leaders in 4 countries (Bolivia, Peru, Philippines and India) and during the 2015 additional capacity efforts will take place on the Governance of land with 4 additional countries already targeted (Panama, Mexico, Nicaragua, Guatemala).

- 2. With respect to the implementation of the recommendations of the Permanent Forum addressed specifically to your agency:
 - (i) What are some of the obstacles your agency has encountered in implementing the recommendations of the Permanent Forum, including those addressed specifically to your agency?

The Permanent Forum recommended that FAO and other agencies, in cooperation with indigenous peoples, organize a workshop on the implementation of the Voluntary Guidelines on the Responsible Governance of Tenure of Land, Fisheries and Forests in the Context of Food Security of the Food and Agriculture Organization of the United Nations in order to strengthen indigenous peoples' rights to land, territories and resources. The major obstacle encountered on this issue has been the lack of knowledge and understanding of the relevance of the guidelines for Indigenous Peoples.

However, several national workshops on the guidelines have been carried out throughout 2014 and will continue to be organized for 2015, and Indigenous Peoples have been increasingly involved in these. Moreover, a study on the relevance of the guidelines for Indigenous Peoples is currently been conducted and a technical meeting with a session on the guidelines and how they can be used by indigenous communities to address the main issues they encounter in relation to tenure will be held in FAO's headquarters in February 2015.

(ii) What are some of the factors that facilitate your agency's implementation of the recommendations of the Permanent Forum, including those addressed specifically to your agency?

In relation to the recommendation to include pastoralism in the development agenda², the launch, at the beginning of 2015, of FAO's Pastoralist Knowledge Hub, whose main objective is to enhance the capacity of pastoralists to improve their livelihoods, strengthen their networks and influence policy, will contribute to provide the opportunity to work globally towards building the enabling conditions for capturing the opportunities of sustainable development for pastoralists and nomadic peoples.

The recent review of FAO's project cycle guide and Environmental and Social Management Guidelines has allowed to ensure specific reference is made to Indigenous Peoples (and not simply include them under the terms "marginalized and vulnerable groups") throughout the work of the organization. Furthermore, the Environmental and Social Management Guidelines follow now international standards by incorporating Free, Prior and Informed Consent as a pre condition for any activity affecting indigenous peoples. This is also aligned with the 2010 FAO Policy on Indigenous Peoples.

The creation of an Indicators Working Group within the Interagency Support Group of the UN will facilitate the implementation of the recommendation to recognize indigenous peoples' views and priorities for development, including appropriate indicators and data disaggregation⁴. FAO is discussing internally to see how FAO's statistics department could get involved in the indicators working group

FAO Policy on Indigenous and Tribal Peoples (2010)

(ii) Recent programmes on indigenous peoples' issues;

FAO as a leading technical agency on Food and agriculture has been working with indigenous peoples at different levels within its technical work. For instance in forestry, fisheries and pastoralism, FAO has been working with indigenous peoples and several projects have been implemented at national level.

Recently, work has started in Asia at the regional level, where FAO and indigenous peoples have undertaken an analysis of shifting cultivation in 7 countries. FAO is working at establishing a global programme as well as 3 regional programmes

in Asia, Latin America and Africa. This is working progress and will not be completed before 2016.

Budgetary allocations for indigenous peoples' issues; (iii)

FAO has a cross cutting approach to Indigenous Peoples, therefore there are different budgets within different divisions.

The Unit coordinating indigenous peoples within FAO will have about US 100 000 in 2015.

Projects/activities on indigenous peoples' issues, (iv)

In 2014 the following projects on indigenous peoples were carried out:

"Regional Support to Indigenous Peoples for Livelihood and Food Security" 1) focusing on the subject of shifting cultivation practices, including case studies from Bangladesh, Cambodia, India, Laos and Thailand.

"Asistencia de emergencia a las comunidades indígenas de Prinzapolka, Región 2)

Autónoma Atlántico Norte (RAAN), afectadas por las inundaciones."

"Land Rehabilitation and Rangelands Management in Smallholders Agro-3) pastoral production systems in South Western Angola"

"Support for sustainable land governance and the implementation of the 4) Voluntary Guidelines in communal lands of Kenya".

Moreover, the following seminars were organized:

- 1) Nicaragua: "Mujeres productoras emprendedoras hacia el cuidado y conservación de la Madre Tierra."
- 2) Peru: International Expert Seminar on 'Cultural Diversity, Food Systems and Traditional Livelihoods'
- 3) Colombia: "Encuentro nacional de pueblos indígenas".
- 4) Guatemala: "Encuentro nacional de pueblos indígenas".

Also, the technical guide on "Respecting Free, Prior and Informed Consent. A practical guide. Governance of tenure." was published.

Does your agency have regular or ad hoc capacity-building programmes on indigenous peoples' issues for staff, or a plan for capacity-building activities in this area, at headquarters or in the field?

Awareness raising and capacity building activities on the Free, Prior and Informed Consent process to be followed for all FAO projects and programmes involving Indigenous Peoples will be carried out in 2015 for staff in HQ and in the field. These will include seminars for all relevant staff, and e-learning material, to be developed with an indigenous organization to be identified.

All the World Committee on Food Security meetings since 2011 have seen indigenous peoples actively participating in its discussions through the Civil Society Mechanism.

Furthermore the negotiations and approval of the Voluntary Guidelines for the Governance of Tenure (2012) and the Voluntary Guidelines for Small Scale fisheries (2014) have seen active participation of indigenous leaders and representatives. FAO has been actively supporting the participation of indigenous people in these important fora.
