  - a. The WCIP Outcome Document recalls "the responsibility of transnational corporations and other business enterprises to respect all applicable laws and international principles, including the United Nations Guiding Principles on Business and Human Rights, and to operate transparently in a socially and environmentally responsible manner."<sup>2</sup>

The UN Global Compact launched a Business Reference Guide to the UN Declaration on the Rights of Indigenous Peoples at the Second Annual UN Forum on Business and Human Rights in 2013. The Guide aims to increase understanding among business of the rights of indigenous peoples and to provide practical suggestions for respecting and supporting these rights. As of, August 2014, the Practical Supplement to the Reference Guide features twenty case studies showing business initiatives that respect and support indigenous peoples' rights in all but two of the Permanent Forum's seven socio-cultural regions (Arctic and Africa).<sup>3</sup>

In addition to the Business Reference Guide, the Global Compact has been working stridently to ensure that multi-national companies' understanding of indigenous peoples' rights themes is enhanced through the Human Rights and Business Dilemmas Forum (HRBDF). The indigenous peoples' rights sub-section of this important resource includes a comprehensive introduction with scenarios, dilemmas, examples, and suggestions among others, twenty-six on-the-ground case studies exploring dilemmas faced by organizations around the world, a Forum promoting dialogue between different stakeholders, and external resources on indigenous peoples. The forum also includes a similar subsection to gender equality, including several case studies that show good practice actions by the private sector in relation to indigenous women.

- b. The Post-2015 agenda will require unprecedented efforts and levels of interplay between business, governments, civil society, and other key stakeholders to be developed and implemented. The UNGC has been key in these efforts by linking and promoting a convergence of interests between the public and private sector. This increased convergence between both sectors is clearly reflected in the Post-2015 Business Engagement Architecture, which was released at the UNGC Leaders Summit in September 2013 and is designed as an invitation to organizations, initiatives and networks working globally to engage business on sustainable development to join forces with the UN Global Compact and other like-minded organizations in supporting corporate commitments and actions that advance UN goals.

In addition, from January to April 2013, country-based Local Networks carried out 43 consultations on the Post-2015 agenda in five major regions. Over 500 corporate participants attended. Consultations took place in the following countries:<sup>4</sup>

- Americas: Brazil, Colombia, Paraguay
- Asia/Australia: Australia, Bangladesh, China, India, Indonesia, Japan, Pakistan, Singapore, South Korea, Sri Lanka, Vietnam
- Europe: Belarus, Bulgaria, Greece, Germany, Macedonia, Netherlands, Nordic Network, Spain, Switzerland, Turkey, UK
- Middle East/North Africa: Egypt, Gulf States, Iraq, Syria
- Sub-Saharan Africa: Kenya, Uganda, Zambia
- c. Various activities on youth have been implanted by the UN Global Compact. Developed by UNICEF, the UN Global Compact and Save the Children the Children's Rights and Business Principles are the first comprehensive set of principles to guide companies on the full range of actions they can take in the workplace, marketplace and community to respect and support children's rights.

Furthermore, on May 28, 2014, the UN Global Compact and UN Habitat hosted a Google Hangout on Youth Employment, Skills and Entrepreneurship. Speakers from business, international youth organizations and the United Nations exchanged ideas on promoting entrepreneurship among young people. The role of the private sector in providing youth with training and mentoring to establish new enterprises was also explored.
