The National Khoisan Council presented their statement during 2013 at the Forum. It was an important milestone the Forum created for the National Khoisan Council to make a statement.

- We support Khoisan indigenous women and their families in different ways. We've held a womens day function celebrating the role of women in our communities. We counsel and support Khoisan women and their families in conflict. We conduct several women's traditional ceremonies acknowledging women and their role in our communities. We also support a women's farming community in an area called Napier. They received a small piece of land which they use for subsistence farming. Our organization is supporting them in the running of this cooperative through self sustainable methods.

We held a youth day in our rural area called Paarl. The purpose of the day was to raise awareness about our heritage sites and linking it with identity and our indigenous knowledge systems.

Further, the South African government quite involved in our land reform processes in post apartheid South Africa. They have started processes which includes the Khoisan. This policy development processes are looking at how available land could be identified for the Khoisan on par with other historically disadvantaged communities. (10) What are the major successes as well as the remaining obstacles for the

implementation of the UN Declaration on the Rights of Indigenous Peoples in your country? The South African government is making a lot of progress. There are concerted efforts to engage the Khoisan much more than previously. In terms of resource and land rights, they are developing key policy frameworks. However the legislation formally recognizing the Khoisan as a cultural community and their institutions are still not enacted. The is one of the key remaining obstacles we hope will be addressed soon.
